Educational Assistance Policy revised

The Educational Assistance Policy has been changed (as of January 1) so that more employees may have a chance to participate in educational programs.

•The Educational Assistance Program will pay tuition and registration fees for approved classes, seminars and workshops in advance.

·Within 30 days after the course, seminar or workshop has been completed, all employees must furnish evidence of satisfactory completion.

·Checks will be made out to the educational institution only.

•Checks will be mailed to the educational institution unless you ask to pick up the check from the Disbursements Office.

•You must register yourself and submit an Educational Assistance Application at least two weeks before your class begins.

•Use form #964 (Rev. 3/87) until updated forms are available. Ask your supervisor for a form.

Free Income Tax Forms preparation assistance

Do you need help completing your income tax forms? CW sponsors a free VITA (Volunteer Income Tax Assistance) site on Monday and Wednesday evenings, 5:30 p.m. to 7 p.m., beginning Wednesday, February 2, 1989. Volunteers have been trained by the Internal Revenue Service and State Department of Taxation to complete appropriate federal and state income tax forms.

Friday. If you elect to drop off your forms you will be called when your return is ready.

Keeping rabies under control

We've all heard about the escalating rabies epidemic in this area and we all need to do our part to keep rabies in check.

One of the first things that everyone can do is to keep their trash yards clean. Messy trash yards are treats for raccoons (leading carriers of rabies in this area) and squirrels.

If you own pets, make sure their vaccinations are up-to-date. Veterinarians in the Williamsburg area are offering rabies vaccinations at a discount on Saturdays during the month of January.

Keep your pets indoors, especially in areas with high squirrel or raccoon populations.

If you see an animal acting strangely in or around the Historic Area, call Security at ext. 2600 immediately.

If you are bitten by an animal, don't panic. Wash the wound thoroughly with soap and lots of water and call your doctor immediately. Explain how you got the bite and follow the doctor's advice. Report the bite to the local health department.

If possible, capture the animal under a large box or can, or at least identify it before it runs away. Do not try to pick the animal up. If you are in or around the Historic Area, call Security immediately. If not, call the animal control officer or police to come get it.

New FICA withholding guidelines

New IRS guidelines require employers to withhold FICA (social security) taxes from employees to whom group-term life insurance coverage in access of \$50,000 has been provided.

This means that if you have signed up for more than \$50,000 of group-term life insurance coverage, you must pay FICA tax on that portion of the premium your employer pays for any coverage greater than \$50,000.

If you are one of the few employees affected, you will see a light increase in the amount of FICA tax withheld from your paycheck.
