At the Annual Homecoming Banquet which was held at the Emerson Hotel on November 7, the two hundred of you who were present already know that Mr. R. Loran Langsdale, Chairman of the Board of Trustees, announced the purchase of the two-story building on the corner of Charles and Oliver Streets, adjoining Charles Hall. This building will be torn down and a new, modern building erected.

The first concrete plans for this new building include a new library, and the present library in Charles Hall will be restored as a students' lounge.

"Acquisition of this new property enables the University to do two things which the trustees long have desired to do," said R. Loran Langsdale. "First, it will give much larger and greatly improved facilities for our library, which steadily is adding to its books and to the various services it performs.

"But by making the move it will enable us once again to give to the students a comfortable, large lounge. This is something the trustees long have desired to do, but have been prevented from doing by lack of space."

As of the present it is not known when the new building will be completed, but the architects, Hopkins and Pfeiffer, already are working on the project. Other plans in connection with the addition are to be announced in the not distant future.

### SOCCER TEAM HAS SUCCESSFUL SEASON

The University of Baltimore soccer team, under the coaching of alumnus Bill Beck (Class of 1952), completed another winning season this past Fall. Although not repeating as champions of the Mason-Dixon Conference, the team did finish second and had a record of 8 won, 2 lost, and 1 tie. This includes non-conference contests. The team's excellent record was achieved even though the squad included several freshmen who were novices in intercollegiate competition. Next year, with a year of experience under their belts, this young team may be able to regain the Mason-Dixon Conference Crown.

### OTHER SPORTS NOTES

Both the "Bees" basketball and wrestling squads are pointing for their respective Mason-Dixon Conference Tournaments.

The wrestling tournament will be held at Gallaudet College, Washington, D.C., February 26 and 27. Coach Bill Owings' squad, after a slow start, has showed well in recent contests and is expected to do well in the tournament with an excellent chance of repeating as the conference "Kings."

Coach Don Newbery and his basketball squad have picked up momentum after a slow start and are pointing to the Mason-Dixon Conference tournament to be held February 25, 26, and 27. The tournament will be held at either Catholic U. in Washington, D.C. or Loyola College in Baltimore. As in the past the Conference will announce the exact site about 5 days prior to the tournament.

The method of choosing the 8 teams to participate in the tournament is changed this year. The Conference is divided into 2 divisions—a northern and a southern. The University of Baltimore is one of the 7 teams in the northern division. The winner of the northern division automatically qualifies for the tournament, while the other 6 teams are paired off in three games to be played at Western Maryland College the night of February 20. The winners of these games go to the tournament. In the Southern Division, all 8 teams are paired off in 4 games to be played on the night of Feb. 20—2 games at American U. in Washington, D.C., and 2 games at Roanoke College in Salem, Va. The 4 winners qualify for the tournament.

The University of Baltimore has been elevated to the National League in lacrosse competition. This league is composed of 9 teams recognized as being the top collegiate teams in the United States. This league replaces the old "A" league. The rest of the Nation's schools participating in lacrosse are divided among the Northeast League, the Northwest League, and the Middle Atlantic League—each with an "A" and "B" division. Heretofore, perennial champions of the old Class "B" division, the 1960 "Bee" lacrosse squad may find the competition rougher but is expected to do well in its initial encounter with the National League schedule.

### WATCH THE NEW DEBATING CLUB!

A group of Pre-law students have organized the Forensic Association of the University of Baltimore. Under the able coaching of Dan Craig, an instructor in both English and Philosophy, these debaters have entered tournaments at the University of Maryland, American University, the University of Delaware, and Temple University. At American University, the University of Baltimore tied the Naval Academy and Loyola for second place in the novice division, winning 4 out of 6 debated, by defeating Georgetown University "A" team, University of Maryland, American University, and Trinity College. At Temple University, the U. of B. won 6 out of 8.

### **ENROLLMENT**

This year's Day School enrollment has reached well over 700 students—an all-time high. 2,350 students are attending the Evening School—also a new enrollment high. Due to the heavy enrollment and lack of necessary classroom facilities, mid-winter term registration was closed to new students 10 days prior to the start of the new term. Those who were not enrolled were given the privilege of putting their names on the waiting list for future registrations.

### COMMENCEMENT EXERCISES HELD

The 33rd annual commencement exercises were held at the Lyric Theater, Thursday, June 9. The main address was given by Mr. Jerome Framptom, Jr., President, State Board of Education. 399 students were graduated this year as compared with 362 in 1959. This is broken down, with recent year comparisons, in the following: the Law School graduated 92 (83 in 1959, 67 in 1958), the School of Business, Industry, and Management graduated 247 (203 in 1959, 159 in 1958), and the Junior College graduated 45 (37 in 1959, 51 in 1958). Of the 399 graduates, 384 were awarded degrees and 15 awarded certificates.

Since the school's beginning, 5242 students have received degrees and 478 students have received certificates for a grand total of 5720.



### OTHER FACULTY NEWS

In June, 1959, after twelve years of distinguished service to the University of Baltimore, Dr. John E. Graefe, Professor of Philosophy and Religion since October, 1947, retired as Chairman of those two departments. To the great delight of all who know him, however, Dr. Graefe consented to continue to teach two Monday evening sections of Living Religions.

As his successor, Dr. Samuel W. J. Walsh, took up his duties in September, 1959, and has already won for himself the reputation of being, as was Dr. Graefe, not only thoroughly acquainted with the subject matter of his two fields but also eminently able to present both subjects in a clear and meaningful way.

Dr. Walsh holds four earned degrees:—B.A. from Mt. Allison University, Canada; M.A., S.T.B., and Ph.D. from Boston University, Massachusetts. In addition, he has studied at London University,

England. He came to the University of Baltimore after a very successful twelve years on the Faculty of Morningside College, Iowa.

Likewise from the Middle West, Dr. Bryce W. Shoemaker became co-chairman of the Departments of History and Political Science in September, 1959. Dr. Shoemaker, too, holds four earned degrees:—B.A. from Olaf College, Minnesota; G.Th., from Luther Theological Seminary, Minnesota; B.D., Northwestern Seminary, Minnesota; and Ph.D. from the University of Edinburgh, Scotland.

Dr. Shoemaker came to the University of Baltimore from Denver, Colorado, after having served for eight years on the faculties of Augsburg College and Northwestern Seminary in Minnesota. He, too, has proved his competence both as a scholar and as a classroom teacher.

The University is fortunate in obtaining two such capable men to teach and to serve as chairmen of these important departments.

### PUNCH CARD SYSTEM PUT IN USE

The Remington-Rand punch card system used at the University of Baltimore has proved its value in certain areas of use. Among other things, the system makes available the following: controls size of classes to a predetermined optimum number; reduces materially the time required for getting out student grade reports; makes readily available such information as number of students by degree objective, number of veterans, number of male and female students, etc.

### 1ST ANNUAL ATHLETIC AWARDS BANQUET HELD

On June 7, the 1st Annual Athletic Awards Banquet was held at the Park Plaza in Baltimore. Director of Athletics, Donald A. Newbery, served as Master of Ceremonies, and an address by Emil "Lefty" Reitz, Athletic Director of Loyola College, was the highlight of the evening.

The athletes from the various teams were awarded their letters, certificates and trophies. A special trophy, from an alumni group of former U. of B. basketball players, was presented to Charles "Stretch" Thomas for being the most improved basketball player of the season. "Pip" Moyer, former U. of B. star, presented the trophy. Ken Johnson, a letterman in soccer, wrestling and lacrosse, received an individual sweater as a token of his participating in 3 sports. Joe Cosgrove, freshman soccer performer, was recognized for his selection on the All-American soccer team. Jack Bychick received recognition for being selected to the Who's Who in Small College Basketball Team.

### SPORTS HIGHLIGHTS OF THE YEAR

Include the thrilling one-point loss of the basket-ball team to American U. in the Mason-Dixon Conference Annual Tournament. American U. went on to win the tourney, then proceeded to the finals of the N.C.A.A. Small College Tournament before losing. During the regular season, the Bee basket-ballers tied for second in the northern division of the Mason-Dixon Conference. Besides being chosen on the Who's Who Team, Jack Bychick was selected to the Mason-Dixon Conference 1st team, and to the college All-State team, each for the second year in a row.

The golf team failed to score in the Mason-Dixon Conference Tournament. However, Hank Majewski copped the individual crown and Winnie Miller went on to win the individual Little College N.C.A.A. Golf title.

The baseball team finished 4th in the northern division of the Mason-Dixon Conference and placed pitcher Ron Mather on the Conference All-Star Team.

The lacrosse team lost only to Army and Navy in college competition this year. Their record looks more impressive when it is realized that Navy won the national championship and Army's only loss was to Navy.

The wrestling team finished second in the Conference standings and heavyweight Dick Kohlhafer won the individual crown in his weight class. And, as reported in our last Newsletter, the soccer team finished second in the Mason-Dixon Conference.

Attackman Tim Albrecht and goalie Ed Nippard have been elected to the 1960 All-American Lacrosse Team. The two star performers had outstanding seasons. Albrecht won the state scoring title with 39 goals, and Nippard, game after game, proved he was All-American calibre. Each player was also placed on the All-Maryland Lacrosse team and Nippard received the Kelly Award, symbolic as the best college goalie in the State of Maryland. Others receiving lacrosse honors were: Randy Walker (midfielder), Second Team All-American; and Don Willoughby (attackman) and Ken Johnson (midfielder), Honorable Mention All-American.

### LIBRARY EXPANDS SERVICES

As part of its continuing program to increase service, the library staff, under the direction of Mrs. Shelton, now gives lectures and presents a handbook to freshman on how to use the library. Furthermore, a faculty library committee has been formed to work with the librarian in determining ways and means of increasing the library's collection of books.

During the month of June each year, the Law Library will remain open allowing Law School graduates who plan to take the bar exam an opportunity to use the library's facilities.



#### BALOO RECEIVES AWARD

For the first semester of the past school year, the student newspaper, the BALOO, received from the Associated Collegiate Press a Second Class Honor Rating. This rating is one of the highest awarded and is the first such honor the BALOO has received since 1950.

### LARGEST FRESHMAN CLASS ENTERS DAY SCHOOL

Although complete registration figures were not tabulated at this writing, it has been estimated that this year's Day School freshman class will number approximately 350—the largest freshman class in the school's history. The total Fall enrollment, both Day and Evening Divisions, should exceed last Fall's record of 3049.



### LIBRARY RECEIVES GIFT

The new magazine rack and the new bulletin board, gifts of the Class of 1959, have been installed in the library. Both gifts were greatly appreciated by the library staff and will help to provide more service and convenience for the students.

Mrs. Harriette W. Shelton, Librarian, has announced that the library has increased its magazine subscriptions by 25% over last year. This is a deliberate attempt to introduce to the student the widest possible scope of magazines of literary value for recreational reading.



### THREE NEW MEMBERS JOIN FACULTY

President Wilson has announced that the full-time faculty has been increased by the addition of three new members this Fall. Because of the increased number of applicants for the day freshman class, a new instructor has been necessary in each of three departments—English, history, and mathematics.

The new English instructor is Laurence Vincent Short. He received his School Certificate at St. Bonifaces College, Plymouth, Devon, and his Licentiate (M.A.) at Louvain, Belgium. He has pursued post graduate work at Issoire and at Lyons, France. His teaching experience has been at Tervuren, Belgium, and Dijon and Le Havre, France. From 1945 to 1950, he was in the British Civil Service. And from 1950 to 1960, he was Liaison Attache with the British Transport Commission. Early this year, he brought his wife and two children to Baltimore.

Valentine E. Sherring will teach Contemporary World Affairs. He received his B.A. degree at Lucknow University, India; his M.A. degree and Licentiate of Teaching degree at the Government Training College, India; and his B.D. degree at Garrett Biblical Institute, Evanston, Illinois. He has completed all residence requirements for the Ph.D. degree at The American University, Washington, D.C., and is working on his doctorate dissertation.

His teaching experience has been as Lecturer at Christ Church College, Kanpur, India; and at The American University, Washington, D. C. And, he has been employed at the District of Columbia Public Library. He and his wife and two children expect to move from Washington to Baltimore.

James Fenn Sullivan will teach mathematics. He attended the University of Santa Clara, California, for two years; received his A.B. degree at the University of Gonzaga, Spokane, Washington; and has pursued graduate studies toward the M.A. degree and Licentiate at the University of Gonzaga. He has taught mathematics at Saint Ignatius High School, San Francisco, for four and a half years. He is unmarried and is living in Baltimore.

### SOBELOFF AND WEEKS HEAD PROGRAM AT HOMECOMING

Judge Simon E. Sobeloff, former Solicitor General of the United States, and former Chief Judge of the Maryland Court of Appeals, is now Chief Judge of the United States Court of Appeals for the Fourth Circuit.

Before going on the bench he was City Solicitor of Baltimore and United States District Attorney for Maryland, and headed Maryland's "Little Hoover" Commission, which helped bring about many improvements in the administrative structure of the State.

The dinner-dance meeting was featured by an address by Dr. Russell S. Fisher, Chief Medical Examiner for the State of Maryland and Professor of Legal Medicine and Forensic Pathology of the University of Maryland.

The razing of the building which occupies the site of the new University of Baltimore building is now complete. Construction of the new building which will occupy the 60-by-150 foot site will begin soon. With space to be developed in the basement, a total of about 40,000 square feet of usable floor area will be provided. That is about equal to the space in the present building at 1420 North Charles Street.

The first floor will provide space for a lobby, for administrative offices, the book store and related facilities. The second floor will be devoted to the library. With the completion of the new building, scheduled for August 15, 1961, the library on the first floor of 1420 North Charles Street will be reconverted to a students' lounge. Classrooms will occupy the third and fourth floors.

The automatic elevator installed in the present Charles Hall will provide service to all floors of the new building. The north stairway in Charles Hall will be removed and replaced by the stairways in the new building and by corridors linking each floor of both buildings.

The new structure will have a modern facade, featuring relatively light curtain-type walls, aluminum and glass.

It is estimated that the new building will cost \$800,000. Projects included in the general renewal program may bring the total expenditures to \$1,000,000 or \$1,250,000. The entire project is being financed by the university without any governmental aid.

### SPORTS NEWS

Alumnus Bill Beck (Class of 1952) will be fielding his third consecutive University of Baltimore soccer team. His 1958 team was the Mason-Dixon Conference Champion and his 1959 team placed second. This year's team, however, may find the going a little rough due to the loss of many of last year's outstanding players. However, a
