Calhoun, All That plantation or Tract of Land situate in the State and District aforesaid on the East side of Seneca River, known as the Fort Hill farm, containing Eleven Hundred and two acres, adjoining lands of Andrew J. Lewis, James Crawford and others and having such form and mark as a copy plat made by M. S. McCay D. S. on the 2nd March 1853 and hereunto annexed represents, Together, with all and singular, The Rights, Members, Hereditaments and appurtenances, to the premises belonging, or any wise incident or appertaining, To have and to hold all and singular The premises before mentioned unto the said Andrew P. Calhoun his Heirs and assigns forever.

And we the said Floride Calhoun and Cornelia M. Calhoun for and in consideration of the above mentioned sum of Money have also bargained, sold and in plain and open market delivered, and by These presents do hereby bargain sell and in plain and

Also all the plantation tools and imple-
ments, Stock of Horses, & Mules, & Cattle, Corn
provision, & provender, House hold an
Kitchen furniture, being the entire prop-
erty of every description connected with
or belonging to the Fort Hill premises,
except such articles, as are especially
exempted from sale in a list annexed
to the original agreement between the
said parties, bearing date the Thirteenth
day of May 1854 and also filed hereunto.

To have and to hold all and sin-
gular the premises, before mentioned
unto the said Andrew P. Calhoun
his Heirs and Assigns forever
And we do hereby bind ourselves
our Heirs, Executors and Administrators
to warrant and forever defend
all and singular the said premises
unto the said Andrew P. Calhoun
his Heirs and Assigns against our-

selfe, our Heirs and against every person
whomsoever lawfully claiming, or to claim
the same or any part thereof,


