

## Chiropractic



IKE many other departments of human industry or phases of science, Chiropractic had its incipiency in an incident which was almost an accident.

Dr. D. Palmer, who was practicing as a magnetic doctor in Davenport, Iowa, in the year 1895, had for a patient one Harvey Lillard, the janitor of the building, who had been deaf in his left ear for some seventeen years. He had been lifting in a cramped position and felt something give way in his back, and instantly lost the use of the left ear. In his examination, Dr. Palmer found a peculiar bump on the man's back, and decided a vertebral segment was out of place. After considerable time spent in an attempt to replace the vertebra, he finally struck a sharp blow, which caused the displaced area to change position, accompanied by a snapping sound. Almost immediately Lillard could hear a watch ticking at a distance of a foot and a half from his left ear with the other ear closed.

Shortly after this incident, D. D. Palmer wrote to his old time friend, Willard Carver, who was then practicing law in Northwestern Iowa, telling him of the Lillard experiment and its success, and the success of the same character of experimentation with other patients. Dr. Carver, who had been an invalid all his life, was of course immensely interested in the discovery and began a correspondence and collaboration with Dr. D. Palmer which ended only with the death of Palmer in 1913.

During the years intervening, Willard Carver acted as Dr. D. D. Palmer's lawyer, had the application of Chiropractic and was restored to health, notwithstanding a congress of physicians had declared him to be in the advanced stages of pulmonary tuberculosis.

Dr. Charles Ray Parker graduated under Dr. D. D. Palmer in the early part of 1905 and that fall opened a school of Chiropractic in Ottumwa, Iowa. Willard Carver had encountered a severe injury and was threatened with general paralysis and went to Dr. Parker to be adjusted, and incidentally to teach Dr. Parker the science of Chiropractic, while Dr. Parker taught him what he knew of the art of Chiropractic. In June, 1906, Dr. Carver took his degree of D. C., from Dr. Charles Ray Parker, from which time he gave his entire attention to the development and practice of Chiropractic.

He with Dr. Denny located in Oklahoma City in 1906 and in October opened the doors of Carver Chiropractic College, the first chartered College of Chiropractic in the world. From that time until 1918 Carver College was used as a laboratory by its founder in which to work out and develop the fundamentals of the science of Chiropractic with no thought nor intention of building a large educational institution. Carver College was purposely kept small so that research work and development would not be interfered with.

In 1918, Dr. Carver became convinced that the general fundamentals of the science had been worked out and that he had a sufficient

grasp of them that those that were not already permanent record could be easily reduced and that therefore the necessity for a small institution had passed. At the same time he was aware of the fact that a school should be kept sufficiently small that the student may receive a sufficient amount of individual instruction and that the school enrollment should be in proportion to the size of the town in which the school is located so that there will always be an abundance of clinic material. With this idea in mind, he planned to establish schools in various cities throughout the country rather than one large school, and at the present time the following institutions are in existence:

Carver Chiropractic College, Oklahoma City, Okla. Carver Chiropractic Institute, New York City, N. Y. Carver Chiropractic University, Denver, Colo. Carver Chiropractic College South, Montgomery, Ala.

Dr. Willard Carver has published in all fourteen books, on many phases of Chiropractic and other scientific subjects. The textbooks now ready for the profession are: Psycho-Bio-Physiology, which is a complete treatise, as its name implies, on Psychology, Biology and Physiology, deduced from the fundamental principles of Chiropractic; Carver's Chiropractic Analysis, third edition, consisting of volumes one and two. Volume one contains a complete Chiropractic pathology, followed by a complete analysis of the structures and principles entering into the art of Chiropractic, which is also followed by a complete treatise on the art or technique of Chiropractic. Volume two contains a complete treatise on Symptomology and a treatise on Diagnosis.

Dr. Carver began going abroad and lecturing upon Chiropractic in 1917. Immediately the remarkable advancement made by his discoveries placed him in the limelight as the greatest writer of Chiropractic philosophy and science by the profession and the public as well. Leading men of the great schools of medicine read his works and announced that they could find no flaw with his reasoning. The great alienist of Belleview Hospital said after perusing Dr. Carver's works, that he was not able to pass upon the science of Chiropractic, but that the medical world lost the greatest mind in this country when it lost Willard Carver.

The textbooks named are used in Carver College, thus securing to the student a knowledge of the very latest and best that has been developed as a part of the scientific literature of Chiropractic.

#### WHAT IS CHIROFRACTIC?

"Chiropractic is hereby defined to be the Science that teaches HEALTH in anatomic relation, and DISEASE or ABNORMALITY in anatomic disrelation, and teaches the ART of restoring anatomic relation by a process of adjusting by hand." (Copied from the Constitution of the International Association of Chiropractic Schools and Colleges.)

Carver Chiropractic College is not a money making corporation, but is strictly an educational institution dedicated to the spread of true Chiropractic science and practice. It is not an endowed school, and the entire amount paid by the student for his course is used for the maintenance of the college and the improvement of the plant. For this reason a type of work is given here, and a corps of eminent teachers employed, which would be utterly impossible if this college were a commercial institution.

In commercialized schools all students go into the same hopper, and within a given number of months and hours are ground out with a diploma. In Carver Chiropractic College though classes are maintained, yet the class is not the unit. Each individual is dealt with to a very large extent as though he were in a class by himself, and this personal element becomes more prominent as he becomes more advanced. Our examinations are known as Positive Examinations, in distinction to the Negative Examinations, given in public school systems. In other words the student is tested, to find out what he knows, and how thorough he is, rather than to find out what he does not know. At no time through out of his course is the negative element emphasized. In this way our faculty will help you out of the rut, train you to think positively, help you to break away from the negative thoughts that keep people in the ranks of the under paid and dissatisfied, and lift you into a largeness of mind and in a way toward material wealth.

#### ENTRANCE REQUIREMENTS

The course of instruction as taught by cCc includes academic subjects bearing directly on Chiropractic and also such subjects as Public Speaking, Business English, How to Conduct an Office, Letter Writing, jurisprudence and personal efficiency so that the student leaving cCc is ready to take his place in any community with credit to himself, his profession and the community.

State boards of examiners require a high school education or it's equivalent and the student receiving a diploma from this institution will be able to pass the examination for license in any state. Because of the general education given in our regular course, we do not have a rigid educational requirement for entrance, we believe in the general opportunity to learn, and do not think it right to prevent any person from acquiring knowledge for a right purpose.

#### LENGTH OF TERM

It requires a minimum of eighteen months to complete the Doctor's course. The requirements of many of the State Examining boards of Chiropractic are that applicant for license shall have had at least 2100 sixty minute hours of professional training in a recognized school of Chiropractic. Carver graduates are eligible to appear before all state boards, and as our system is based on a sixty minute schedule instead of thirty or forty-five minute periods, an hour in Carver College means an hour in every sense of the word. The student who is faithful in attendance usually has at the end of eighteen months attendence of from 2400 to 2500 hours to his credit.

# DEGREES CONFERRED COURSES OF INSTRUCTION.

#### DOCTOR'S COURSE

This course is based on three school years of not less than six months each, of resident study, or eighteen months continuous resident study.

The Doctor's Scholarship, however, admits the student, without further cost, to pursue his studies until graduation, no matter how long it may take him to finish. This course includes all subjects of the curriculum and the class schedule with subjects and hours listed will be found on pages 20 and 21. It also includes special drill and preparation for state board examination.

#### SCIENTIFIC COURSE

#### A Twelve Month's Course With Privileges

This course is for persons wishing to familiarize themselves with the Science of Chiropractic and Psycho-Bio-Physiology for general development purpose.

The course entitles the student to all departments of the School except Practice Clinic, and Clinic Demonstrations.

Graduation from this department carries a diploma conferring the degree of S. S. (Science Scholar.)

At any time after matriculation in this department, the student may convert this to any Scholarship by paying balance of tuition for the course selected, governed by the current issue of the College Catalogue.

#### MASTER'S COURSE

The shortest time in which the Master's degree may be had is four school years, and is only issued then, on motion of the faculty, to those possessing a peculiar fitness.

The Master's course is a LIFE SCHOLARSHIP. It leads to all of the degrees issued by Carver College which are at present S. S., D. C., M C., I. C., Ph. D. and LL. D.

Under this matriculation, the student may attend Carver College as LONG AND OFTEN as he wishes, enter any of the regular Departments, without additional fee, except the teacher's and is entitled upon a show of fitness, to a degree stated. He may POST GRADUATE as FREQUENTLY AND AS LONG AS HE DESIRES.

#### TEACHER'S COURSE

It is the policy of Carver Chiropractic College to use as its instructors only its own graduates. The growth of the college here together with those of New York City, Denver and Montgomery, is so rapid that it necessitates the constant production of a thoroughly qualified, responsible and constantly increasing teaching force.

This College offers the highest inducements to persons wishing to enter the Chiropractic profession for the purpose of becoming teachers. It not only instructs them in a very superior way to that end, but furnishes them the opportunity for a tutoring experience as a part of their instruction.

"Nothing succeeds like success." It is invaluable to the student to not only hold a diploma as a teacher, but to have the diploma also certify that its holder has taught, successfully, for one calendar year, which carries with it the stamp of success.

The Teachers' Course leads to the degree of I. C. (Instructor of Chiropractic) with a diploma conveying the same and containing a certificate of actual successful experience of the recipient.

\$300.00 of tuition may be earned teaching provided the student passes the teachers' examination in all other respects except that of actual experience.

The teachers' diploma issued in no case except following a period of actual teaching exper ence in this institution, the length of which service to establish passing proficiency is to be fixed by the Dean or in his absence by a two-thirds vote of the faculty.

The teachers' course is only open to those having taken the D. C. degree from this institution.

#### POST-GRADUATE REVIEW COURSE

#### Six months—study outline

Complete review of the anatomy of the bones, muscles and joints with the use, maintenance and co-ordination of each analyzed.

Complete detailed physiology of the organism deduced from the basic principle of Chiropractic.

Rapid review of Chiropractic physiology with analysis and comparison with medical, or therapeutic physiology.

Complete detailed pathology as the same is deduced from the basic principle of Chiropractic.

Characteristic distortions and the pathology of each.

Anomaly distinguished from pathology and the relation of each to Chiropractic correction.

The symptoms of pathological phases of disease, as contradistinguished from medical symptomatology, with full detailed compar son of chiropractic symptomology with medical symtomatology, giving effects of medicines ordinarily used for such cases, and the dangers incident from the same followed by chiropractic and of chiropractic followed by medication.

Practical psychology as related to handling patients. Methods of overcoming fear; securing co-operation. How to remove effects of wrong habits of mind and attitude that operate against recovery.

The Anatomy by Palpation, learning to see anatomic structures through the hands; that is, converting memory anatomy into physical sense anatomy.

Anatomic Palpation Clinic, learning to locate anatomic parts and sense the immediate resistance, condition, and the opponent resistance.

Relating and Relatology—Poseology. The positions and movements incident and necessary to relating, use of table and rolls, etc.

Clinic Practice, going into the details of handling patients under the direction of the faculty.

Chiropractic Obstetrics, and old methods analyzed and compared, with details of handling cases and explaining results.

Therapeutic Critique, analysis of blood "count," blood "tests," blood "pressure." Full discussion of the relation of vaccines and serums, details of immediate and remote affects of uses of same, and their effect on Chiropractic follow-up, and especially their dangerous effects when followed by Chiropractic.

Minor Surgery and First Aid in Detail, with demonstration; with analysis of major surgery, explaining the Chiropractic elimination of more than eighty per cent of major surgery now in vogue.

Analysis and Details of poison and poisoning, with antidotes, when to use, how to use—Chiropractic antidotes.

Graduates of all authorized schools of chiropractic are eligible for this course.

NOTE—All Chiropractic subjects with the exception of Anatomy are taught from text books written and published by Dr. Willard Carver, who is the longest time student of Chiropractic now living and the recognized scientific head of the profession. His text books entitled Chiropractic Analysis—Volume I, and II., include chiropractic principles, science of conduct, relatology, pathology, symptomology and diagnosis. His Psycho-Bio-Physiology as the name implies includes psychology, biology and physiology.

If you have a standard work on psysics, chemistry, or business english, it will not be necessary to purchase others.

The above named books are all that are required for the course and if other books are needed for reference study, they can be obtained at the library. Students are required to purchase the Carver texts at time of entering classes.

#### CLINIC

THE cCc public clinic is in charge of Dr. Fred C. Riffe assisted by Doctors Dunn and Tinsley. Dr. Riffe is a Chiropractor of wide experience and a recognized authority on diagnosis and adjusting. Each student during his entire senior year, spends two or more hours each day in public clinic under the personal supervision of Dr. Riffe and his assistants, adjusting several patients daily. Many interesting cases are brought to the students' attention and analyzed.

Last year, because of the growth of this department a new building and many other conveniences were added to the equipment for handling the necessary work. The College is centrally located in a growing City of 130,000, and because of this fact and the number of people of the community who are today enjoying health as a result of the administration of our clinic doctors, there is always an abundance of patients.

The graduate of cCc leaves the institution with a practical experience so large and varied that he is ready to take his place as a doctor in any community. This is an important point for the prospective student to consider.

## BUILDINGS AND EQUIPMENT

THE buildings of cCc are located at 515 to 521 West Ninth Street and consist of four substantial structures.

CARVER HALL, which is the original cCe building is occupied on the ground floor by the Superintendent's Office, bookkeeper and auditor's office, Secretary and General Counselor's office, library, supply room, two doctor's suites, doctor's reception hall and the Gamma Alpha Rho's (A Greek Letter Fraternity) office. The second floor is the freshman class room and seats about three hundred people. It is equipped with charts, mannikan, skeleton and such other equipment as is necessary in freshman lecture halls.

FRA ELBERTUS HALL is a large brick building completed in May, 1921. It is well arranged, well lighted, well ventilated and in every respect a modern, up-to-date school building. The first floor is occupied by a reception hall, a number of office suites, including those of the president, registrar, master clinic an and faculty doctors, and the laboratory and orificial correction room. The second floor is a large auditorium with a seating capacity of six hundred. This hall is equipped as a lecture room for advanced classes and is also used as a general assembly room.


PUBLIC CLINIC. A new one-story building has just been completed for this purpose. It contains dressing rooms, rest room and such equipment as is necessary to the comfort of student and patient. Our equipment and large practice clinic gives the student of cCc an amount of practical experience that will be invaluable to him in establishing a practice of his own.

OLD CLINIC BUILDING. This is a two story structure situated north of Fra Elbertus Hall and has been converted into two large class rooms, one of them a lecture hall and the other equipped with tables, etc., for instruction in poseology and palpation.

#### OPPORTUNITIES IN CHIROPRACTIC

No other profession offers the same opportunity for self-realization to such an extent as does Chiropractic. The financial end of it, which is the great determining factor in most professions, is not lacking. We do not attempt to hold it prominently before you, for we consider there are other things of greater importance in the choosing of a life's work. However it is one factor that should not be under estimated by any means. We know of no other profession where one, after 18 months of intensive training can go out into a field and make five to ten thousand dollars a year, and yet that very thing is being done repeatedly by our graduates. #### OPFORTUNITIES FOR WOMEN

THE Woman chiropractor enjoys a wonderful number of advantages. It is part of her make up to be more sympathetic and responsive to the feeings of others than is man. Her intuitive faculties are more highly developed.

Women are more careful observers and note many times finer symptoms that would pass unnoticed by man. However it is not a question

of sex that spells success but ability.

Any woman who can learn the philosophy of chiropractic and to deliver the thrust as taught by cCc will make a success, and women are going from our college every year succeeding in their profession. So often the statement is made by the ill-advised that women are not strong enough to become chiropractors. That statement is not true for it does not take an unusual amount of strength. Through the course as developed in our clinic, the physical well being of our students is taken care of, until when they are ready to do actual adjusting they have bodies vibrating with health, and a musculature that is flexible and responsive.

Because of the peculiar ills of womanhood, women are particularly fitted to counsel and adjust their sex. Proof of this is to be seen in the

countless successes that our women graduates have made. We have on file an affidavit made by a woman doctor that she has not made less than \$30,000 a year in her practice. On the other hand we had a little lady go out from here a short time ago, barely over her majority, into one of our small towns of the state, and she reports that she averaged the first year \$300 a month. This is not an unusual amount, and the majority of our women graduates are doing even better. In the home, Chiropractic for the mother is a boon to her in the raising of her family and is worth many times over its cost, in handling the ills that arise.



# QUESTIONS AND ANSWERS OF INTEREST TO THE PROSPECTIVE STUDENT

- Q. Can Chiropractic be learned by mail?
- A. No. The science and art of Chiropractic can be learned only under the personal supervision of competent instructors. All efforts to teach Chiropractic by correspondence have been failures. Chiropractic examining boards recognize this fact and require full time residence study.
  - Q. Can Chiropractic be learned in less than three years?
- A. No. And many of our students are now voluntarily taking four years. They find it well worth the time and effort.
  - Q. Is dissection necessary to the Chiropractic Student?
- A. No. The results of findings from dissection have been written into the texts of anatomy. The Chiropractic Student must learn the animate body, not the cadaver.
- Q. Is X-ray or Spinography necessary to the successful practice of Chiropractic?
- A. No. Thousands of Chiropractors have demonstrated in their practices that careful palpation is infinitely more accurate than spinography, in so far as the skeletal body is concerned. X-rays may locate a built in the deeper tissues of the body, but trained fingers are much better for examination of the bones.
  - Q. Why are Carver Graduates so successful?
- A. When other Chiropractic schools were teaching what they termed Chiropractic by correspondence, cCc required two years of residence study. When other schools were conferring the D. C. degree at the end of twelve months, cCc required a residence attendance of eighteen months. cCc was the first school to set an educational and attendance requirement for graduation. cCc does not teach a system, it teaches the SCIENCE OF CHIROPRACTIC. It is the most comprehensive and effective course of instruction possible to obtain.
  - Q. Why is it the most comprehensive?
- A. Because it includes the entire body and therefore every phase of disease possible to the human organism. It teaches the correction of whatever part of the body may be disrelated, thereby removing the phase of abnormality or disease that may be presented at that part.
- Q. Does Chiropractic recognize the so-called germ theory of disease?
- A. No. We know there are germs, but so-called disease germs occur as a result of disease rather than as a causitive factor. Our demonstrations prove this statement.
  - Q. What is the legal status of chiropractic?
- A. Twenty-six states now have separate state examining boards. They are as follows: Arkansas, Arizona, Connecticut, California (now restrained by court order), Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Maine, Maryland, Minnesota, Montana, New Hampshire, New Mexico, North Carolina, Nevada, Nebraska, North Dakota, Oklahoma, Oregon, South Dakota, Tennessee, Vermont, and Washington. Nine states,

two foreign nations, one province and two territories give chiropractic legal recognition in part. They are as follows: Colorado, Illinois, Kentucky, Michigan, New Jersey, Ohio, Pennsylvania, Virginia, Wisconsin, China, Japan, Saskatchewan, Alaska and Hawaii. Twelve of our supreme courts have held that the practice of chiropractic is not the practice of medicine. They are as follows: Arkansas, Georgia, Idaho, Illinois, Mississippi, North Carolina, New Jersey, New York, Ohio, Pennsylvania, Rhode Island and Tennessee.

One state exempts Chiropractic from control by law. That state is Wisconsin.

NO STATE HAS BANNED OR CAN OR WILL BAN THE PRACTICE OF CHIROPRACTIC. In all states other than those listed above chiropractors practice by the will of the sovereign people, under the immemorial rules of common law.

#### BASIC COMFENSATION VS. SPINOGRAPHY

In the past decade certain schools of Chiropractic have been exploiting the X-ray and from the literature that they are broadcasting one would be led to believe that a Chiropractor without an X-ray is indeed far out of date. They go further, and state that a spinograph is absolutely necessary before one can tell how much the vertebral column has lost its relationship.

LET us analyze the situation and see if a spinograph really helps the Chiropractor.

One who is familiar with an X-ray knows that all a spinograph reveals is the osseous situation—the bones; and then shows only a shadow, and does not reveal anything about the relationship of the viscera, muscles, ligaments, tendons, or in fact any other soft tissue of the body.

THE question arises: Do disrelated soft tissues produce interference with the transmission of nerve stimulus, just as do disrelated bones? Absolutely, Yes. In fact, it is the change in the distance between the origin and insertion of muscles, tendons, etc., that causes the bones to become disrelated.

In basic Compensation, as taught at cCc, the entire relationship of all tissues of the human organism is carefully analyzed and in exact ratio with the extent to which they have lost their normal relation the nerves are either tractioned or impinged.

This therefore discloses the amount of abnormality, for the pathologic or abnormal change is always in exact ratio with the extent of the distortion.

We believe the X-ray to be efficacious in locating foreign substances in the body, such as bullets, safety pins, etc., and also to be of some value in locating fractures; but we do not believe a spinograph helps the Chiropractor one bit in making his skeletal analysis.

The above statements should be perfectly clear to a student of anatomy, and should also show how little value there really is in the X-Ray.

When we hear of one's having an X-Ray made to locate a subluxation, we are reminded of the story of the patient, who having had one made, asked the doctor how much it was going to cost him. Upon being told ten dollars, he replied, "Now, I know where the X comes in."

#### GENERAL INFORMATION

It is the desire of cCc that prospective students shall be fully informed before enrollment and it is with this in mind that we list the following information which we trust will answer any questons that may arise.

ROOM AND BOARD or light housekeeping apartments may be secured by applying at the Superintendent's office. Living expenses are as low in Oklahoma City as in any city of the United States. Room and board near the College can be obtained at from six to eight dollars per week. Light housekeeping suites with everything furnished can be secured at from \$5.00 week up. Members of the Y. M. C. A., Y. W. C. A. or K. C., can secure rooms at these institutions at a reasonable rate.

EMPLOYMENT: We are often asked if it is possible for students to work all or part of their way through College. A large percent of our students are doing this. Oklahoma City has a population of 130,000 and there are many opportunities for ambitious students to work during their spare time. We are always glad to aid the student in any way possible to secure work.

PUBLIC SCHOOLS, as good as any in the United States are within two blocks of the College.

The Post Office, Public Library, High School, Y. M. C. A., Y. W. C. A., K. C., Masonic Temple, many fine Churches, and the main business section of the city are all within walking distance. Street Cars run within one-half block of the school.

VISITORS are always welcome at the College. Inquire at the Matron's desk and a guide will be furnished.

TUITION as stated on page 14 covers the entire course There are no extras except books which will amount to about \$50.00.

GRADUATION FEE. A fee of \$10.00 is payable at beginning of Senior year to cover expenses of graduation, diploma, pictures, etc.

THE CHIROPRACTIC PROFESSION is the only profession today that is not overcrowded. It has 20,000,000 loyal supporters in the United States alone and the number is increased daily. Many good communities all over the country are asking for chiropractors. We have more openings for our graduates than we can fill.

WHEN SHALL I BEGIN? The course is in cycles. You may start any day in the year, and eighteen months later, if you have passed all class examinations with a standing of 80% or better, if your deportment has been up to standard, if you have put in full 2,100 hours re-

quired in the eighteen months, have passed the final examinations and have been certified by the master Clinician, your diploma will be issued forthwith. Therefore, BEGIN ANY DAY IN THE YEAR.

WHEN YOU ARRIVE IN OKLAHOMA CITY, take any street car from any depot going to the Terminal Station,—on arriving at the Terminal Station leave the street car from the front platform where the motorman will give you a transfer good on any street car. Take a Shartel or 28th Street car and get off at ninth street and you will be at the College. Inquire for the Superintendent and your troubles will be at an end. If you prefer write or wire us and we will meet you at the station.
