

- New x-ray and dark room equipment was installed to more efficiently handle the increased numbers of x-rays being taken.
- 2072 x-rays were taken on 1558 persons at the Association office. These persons were referred by their family physicians or health departments.
- 1670 school children in grades 1, 8, and 12 were tuberculin tested. 52 gave a positive reaction. Reactors and immediate household members were x-rayed.
- 85 certificates were provided to food serving establishments in Bangor and Holden whose employees had conformed to local ordinances requiring them to have an annual chest x-ray.
- In cooperation with the State Division of TB Control more than 3,000 chest x-rays were taken during county teachers' convention and Farm and Home week at the Univ. of Maine.

to teach values of good health and importance of guarding against tuberculosis -

- Speakers were provided for organizations telling the facts about tuberculosis and what is needed for its control.
- Newspapers, radio, television and exhibits carried tuberculosis information to the public the year round.
- The Association endorsed and urged passage of legislation to provide all tuberculosis patients hospital care without compulsory charge to them or town of residence. This became affective August 29, 1957.
- Promotion of legislation for stronger control of the uncooperative tuberculosis patient to prevent his leaving hospitals while still an infectious case, proved a failure. Increased community action seems to herald adoption of a bill another year.
- Grants were offered to physicians to attend a pulmonary function course in Boston.
- Tuberculosis Abstracts, a professional publication, were sent monthly to physicians.

to bring into play against all diseases and for better community health, all the forces of the people —

- Conducted an in-service training program on school health for parochial teachers.
- Offered grants to teachers to attend teacher health training courses.
- Provided monthly "Children's Health Bulletin" to elementary teachers for class-room use in teaching health.
- Co-sponsored with Penobscot County Medical Society six television programs produced in cooperation with other health groups.
- Offered a grant to a public health nurse to attend Simmons College for certification in public health nursing.
- Sponsored the Clergyman's Heatlh Institute in cooperation with the various local clerical associations and the State Department of Health.
- Financially supports the Adult Medical Clinic held weekly at the Eastern Maine General Hospital. 109 patients received treatment 312 times.
- Financial assistance was given to help start the Eastern Maine Guidance Center.

to help those already sick with tuberculosis -

- A staff position was created, but not yet filled, for a social worker to help solve patient's problems on finance, child care, housing, marital relations, legal aid, social security, discharge plans, and to assist them to adjust to hospital routine.
- Limited direct service is given to patients and their families seeking aid with employment, vocational training and personal problems. Patients and their families are also referred to other agencies for assistance when indicated.
- A tuberculosis clinic is held monthly for patients discharged from sanatoria but needing continued observation and drug treatment. 30 patients made a total of 59 visits. Furniture was purchased to equip a recreation room for patients at the Central Maine San.
- A health class for women patients was held at the Central Maine San. on how they conserve their strength and energy by simplifying their housework when able to return home.
- During the year individuals and clubs remembered to send clothing, toys, magazines, books and newspaper subscriptions to patients.
