Re-enlisted in Troop A, Second Cavalry, July 7, 1903. Discharged July 6, 1906. Served in Philippine Islands, February 18, 1904, to January 5, 1906. 

Coat of Arms

106TH QUARTERMASTER REGIMENT



BLAZONRY

The following coat-of-arms for the 106th Quartermaster Regiment, Louisiana, Mississippi, Alabama and Florida National Guard, was approved under the provisions of Par. 5, AR 260-10:

SHIELD: Per bend sanguine and buff, to chief a prickly pear cactus, to base a fleur-de-lis, all argent.

CRESTS: Those for the regiments of the Louisiana, Mississippi, Alabama and Florida National Guard, in the following order:

LOUISIANA: On a wreath of the colors (argent and san-

guine) a pelican in her piety affronte with three young in nest, argent armed and vulned proper.

Mississippi: On a wreath of the colors (argent and sanguine) a slip of magnolia full flower with leaves proper behind a trident sable.

Alabama: On a wreath of the colors (argent and sanguine) a slip of cotton plant with full bearing boll proper:

FLORIDA: On a wreath of the colors (argent and sanguine) an alligator statant proper.

Мотто: Pret d'accomplir (Ready to accomplish).

HISTORY OF THE 106TH QUARTERMASTER REGIMENT

The 106th Quartermaster Regiment was organized in January, 1924, as the 31st Division Quartermaster Train in the National Guard of Louisiana, Mississippi, Alabama and Florida, and was redesignated as the 106th Quartermaster Regiment on May 1, 1936. The regiment is entitled to a streamer in the colors of the Victory Ribbon, without inscription, to commemorate the services of Companies A and D (one-third of the lettered companies of the regiment) during the World War. The regiment, as a unit, has served the Dixie Division in the Third Army Maneuvers held in the DeSoto National Forest in Mississippi in August, 1938, and again in the Third Army Maneuvers in the Sabine Concentration Area in Central Louisiana in August, 1940.

The regiment, as a unit, was inducted into Federal service at the various home stations of the units on November 25, 1940, pursuant to Presidential call, and was bivouacked in its regimental area at Camp Blanding, Florida, on December 13, 1940. The regiment is commanded by Colonel J. H. Spengler, St. Augustine, Florida, who is also Division Quartermaster of the 31st Division.

REGIMENTAL HEADQUARTERS

Headquarters, 106th Quartermaster Regiment, was organized on June 13, 1924, as the Quartermaster Section, Headquarters, 31st Division, and redesignated as Headquarters, 106th Quartermaster Regiment, on May 13, 1936.

The Regimental Staff consists of the following officers: Lieutenant Colonel Albert T. Callicott, Executive Officer, Senatobia, Mississippi; Captain Stokes V. Robertson, Jr., Regimental Adjutant, Jackson, Mississippi; Captain James R. Long, Intelligence, Plans and Training Officer, Montgomery, Alabama; Captain John L. Goodwyn, Regimental Supply Officer, Montgomery, Alabama; Lieutenant Colonel Hugh L. McCalip, Regimental Surgeon, Yazoo City, Mississippi; Captain Charles O. Pate, Regimental Chaplain, Senatobia, Mississippi.

Other officers, who serve on the Division Staff and are also officers of the 106th Quartermaster Regiment, are:

Major Mark W. Lance, Division Motor Officer, Tallahassee, Florida; Major Frank V. Barchard, Division Motor Maintenance Officer, Foley, Alabama; Captain Julian F. Pfaff, Division Quartermaster Supply Officer, Jacksonville, Florida; Captain William D. Smith, Jr., Division Transportation Officer, Ramer, Alabama.

HEADQUARTERS COMPANY

Headquarters Company, 106th Quartermaster Regiment, was organized and Federally recognized on June 1, 1936.

Headquarters Company (less the Division Quartermaster Platoon) was located in Ocean Springs, Mississippi, and the Division Quartermaster Platoon was located in Senatobia, Mississippi. In July, 1938, the Division Quartermaster Platoon was transferred to Ocean Springs, Mississippi.

During the Third Army Maneuvers in DeSoto National Forest, Mississippi, in 1938, Headquarters Company for the first time operated with the complete 106th Quartermaster Regiment. The company again operated with the complete regiment in the Sabine Concentration Area near Forest Hill, Louisiana, in August, 1940.

On November 25, 1940, the company was inducted with the rest of the 31st Division into the Army of the United States at its home station, Ocean Springs, Mississippi, with a strength of three officers and 63 enlisted men. On December 13, 1940, the company arrived at Camp Blanding, Florida, where intensive training along with the rest of the 106th Quartermaster Regiment was begun.

The present strength of the company is three officers and 99 enlisted men. The company is commanded by Captain Walter Holloway, with First Lieutenants Daniel B. Van Court and Ernest F. Henley as company officers. Second Lieutenants Frank C. Buehler, Mose Wander and Edward P. Bradley are attached N. G. U. S. officers.

FIRST BATTALION

Headquarters

Headquarters, First Battalion, 106th Quartermaster Regiment, was organized and Federally recognized on May 12, 1936, with Major Henry E. Walden as Battalion Commander and Lieutenant B. A. Pittman as Adjutant.

This battalion, as a unit, served with the regiment in the Third Army Maneuvers in DeSoto National Forest in Mississippi in 1938 and in the Louisiana Maneuvers in 1940. Battalion Headquarters was inducted into Federal service, with Captain (now Major) D. H. Clark as Battalion Commander and First Lieutenant Seymour W. Bullock as Adjutant, on November 25, 1940, at Camp Beauregard, Alexandria, Louisiana. Transferred to Camp Blanding, Florida, on December 13, 1940, the battalion now consists of nine officers and 206 enlisted men.

COMPANY A

Company A, 106th Quartermaster Regiment, was first organized in July, 1917, as Troop E, Second Separate

Squadron Cavalry, Mississippi National Guard. Mustered into Federal service on August 9, 1917, and redesignated Company F, 114th Supply Train, it served in France with the 39th Division. After the Armistice, the personnel was transferred to other units, the records returned to the United States by cadre, and the unit demobilized on January 23, 1919.

The unit was reorganized April 21, 1922, as the 154th Motor Transport Company; redesignated 122nd Motor Transport Company, January 29, 1924, and Company A, 106th Quartermaster Regiment, Mississippi National Cuard, May 13, 1936.

First Lieutenant Albert T. Callicott, organizer and first commander, served as such from 1922 to 1925, when he was made Major and Commander, 31st Division Quartermaster Train. He was promoted to Lieutenant Colonel and Executive Officer, 106th Quartermaster Regiment, in 1936.

Besides being called to duty on several occasions during floods, following tornadoes and for guard duty during trials, the unit participated in the Third Army Maneuvers, DeSoto National Forest, Mississippi, 1938, and in Central Louisiana, 1940.

Inducted into Federal service on November 25, 1940, at Senatobia, Mississippi, it was ordered to Camp Blanding, Florida, where it arrived December 13, 1940, and has been stationed ever since. The company is commanded by Captain Thomas V. Dixon, with First Lieutenant John S. B. Johnson and Second Lieutenant Frank E. Puryear as company officers. Second Lieutenant John T. Kizer is an attached N. G. U. S. officer.

COMPANY B

Company B, 106th Quartermaster Regiment, was originally organized as the 123rd Motor Transport Company on December 3, 1924, with home station in New Orleans, Louisiana. In 1930, the company was transferred to Alexandria, Louisiana. The unit was redesignated Company B, 106th Quartermaster Regiment, on May 12, 1936. On January 3, 1939, Captain Beuford A. Pittman was placed in command.

The unit participated in both maneuvers of the Third Army: in 1938, DeSoto National Forest, Mississippi, and in Central Louisiana in 1940. Inducted into Federal service on November 25, 1940, at Camp Beauregard, Alexandria, Louisiana, it was transferred to Camp Blanding, Florida, on December 13, 1940. Captain B. A. Pittman now commands the company, with First Lieutenant Jack C. Miller and Second Lieutenant Frank D. Gordon as company officers, and Second Lieutenant Theophile J. Combel, Jr., as an attached N. G. U. S. officer.

SECOND BATTALION

HEADQUARTERS

Headquarters, Second Battalion, 106th Quartermaster Regiment, was organized and Federally recognized as a component part of the Florida National Guard on May 21, 1936, with Major Mark W. Lance as Battalion Commander and Lieutenant Julian F. Pfaff as Adjutant.

The battalion first operated as a separate organic unit at Fort McClellan, Alabama, in 1937. It also served with the regiment in the Third Army Maneuvers in the DeSoto National Forest, Mississippi, 1938; with the 62nd Brigade at Camp Foster in 1939, and the Third Army Maneuvers in Central Louisiana in 1940.

Inducted into Federal service on November 25, 1940, at Tallahassee, Florida, it was commanded by Major Lance, with First Lieutenant Joseph M. Ingram as Adjutant. Since that time, Lieutenant Ingram has been succeeded by First Lieutenant Vernon T. Cairns as Adjutant. The headquarters was transferred from Tallahassee, Florida, to Camp Blanding, Florida, on December 12, 1940. The battalion consists of nine officers and 204 enlisted men.

COMPANY C

Company C, 106th Quartermaster Regiment, was first organized as the 220th Motor Transport Company on April 27, 1921, and then redesignated as the 124th Motor Transport Company on January 1, 1928, with Captain Maxwell C. Snyder as Commander and Jacksonville, Florida, as its home station. On May 19, 1936, it was redesignated Company C, 106th Quartermaster Regiment, Florida National Guard, with Captain John W. Snyder as Commander.

It participated in the Third Army Maneuvers of 1938 and 1940, in DeSoto National Forest, Mississippi, and Central Louisiana, respectively. On November 25, 1940, it was inducted into Federal service at Jacksonville, Florida, then transferred to Camp Blanding, Florida, on December 13, 1940. Captain John W. Snyder still commands the company, with Second Lieutenants Robert H. Mizelle, Roy P. McRae and Charles F. Riggle, Jr., as officers.

COMPANY D

Company D, 106th Quartermaster Regiment, was first organized in June, 1916, as the First Ambulance Company, Alabama National Guard, at Ramer, Alabama.

Mustered into Federal service on July 2, 1916, it was ordered to duty on the Mexican Border. Upon its return from the border, it was again mustered into Federal service on April 2, 1917, for service in the World War. Expanded into the 121st, 122nd, 123rd and 124th Ambulance Companies, 106th Sanitary Train, it served in France with the

31st Division. Upon its return to the United States, it was demobilized on June 2, 1919.

Reorganized as the 140th Ambulance Company, April 1, 1922, it was redesignated the 116th Ambulance Company, January 16, 1924; the 111th Wagon Company, March 24, 1934, and then converted into the 121st Motor Transport Company, September 1, 1934. It was finally redesignated Company D, 106th Quartermaster Regiment, Alabama National Guard, May 1, 1936, with Captain William D. Smith, Jr., as Commander and Lieutenant Charles E. Sellers as his assistant.

It participated in the Third Army Maneuvers in DeSoto National Forest, Mississippi, 1938, and in Central Louisiana, 1940.

Inducted into Federal service on November 25, 1940, at Ramer, Alabama, the unit reported to Camp Blanding, Florida, on December 13, 1940. It is now commanded by Captain Charles E. Sellers, with First Lieutenant Hugh D. Cargill and Second Lieutenant William D. Smilie as company officers.

THIRD BATTALION

HEADQUARTERS

Headquarters, Third Battalion, 106th Quartermaster Regiment, was organized and Federally recognized in the Alabama National Guard on June 4, 1936.

Headquarters Detachment, Third Battalion, was organized at Montgomery, Alabama. July 3, 1936, with First Lieutenant John L. Goodwyn commanding.

The Third Battalion operated for the first time as a unit at Fort McClellan, Alabama, in 1937. It served with the regiment during the Third Army Maneuvers in DeSoto National Forest, Mississippi, 1938; with the 62nd Brigade at Camp Foster, Florida, 1939; during the Third Army Maneuvers in Central Louisiana, 1940.

With Major Frank V. Barchard, commanding, and First Lieutenant Roscoe Baxter as Adjutant, the battalion was inducted into Federal service on November 25, 1940, at Montgomery, Alabama, and arrived at Camp Blanding, Florida, its present station, on December 13, 1940.

COMPANY E

Federally recognized as the 111th Motor Repair Section, 31st Division, on June 19, 1924, this unit was redesignated Company E (Light Maintenance), 106th Quartermaster Regiment, on May 1, 1936, with its home station at Montgomery, Alabama.

In addition to flood and emergency work, the unit participated in Third Army Maneuvers: in 1938 in DeSoto National Forest, Mississippi, and in 1940 in Central Louisiana. Inducted into Federal service on November 25, 1940, at Montgomery, Alabama, Company E left there on

December 12, 1940, and arrived at Camp Blanding, Florida, its present station, on December 13, 1940.

Captain John P. Kohn, Jr., present commander, is assisted by First Lieutenant W. J. Boroughs, Jr., and Second Lieutenant Hilton L. Battle. Second Lieutenant Joseph C. Brown is an attached N. G. U. S. officer.

COMPANY F

Company F, 106th Quartermaster Regiment, was Federally recognized as the 106th Motorcycle Company, 31st Division Special Troops, on June 17, 1926, and was redesignated Company F (Car), 106th Quartermaster Regiment, on May 1, 1936.

It participated as a unit of the regiment in the Third Army Maneuvers held in the DeSoto National Forest, Mississippi, in 1938, and in 1940 it served with the regiment in the Third Army Maneuvers held in Central Louisiana.

Inducted into Federal service on November 25, 1940, at Foley, Alabama, Company F trained at its home station until transferred to Camp Blanding, Florida, on December 13, 1940. Company F is commanded by Captain Jesse L. Willingham, with Second Lieutenant Oscar B. Rich as a company officer. Its peacetime strength is 63 enlisted men and two officers.

SERVICE COMPANY

Service Company, 106th Quartermaster Regiment, now composed of two officers and 101 enlisted men, was organized September 8, 1940, at Demopolis, Alabama, with Captain Nicholas T. Braswell as Company Commander, and First Lieutenant Elijah D. Morris, Jr., as company officer. Both officers are still with the unit.

The Service Company was inducted into Federal service on November 25, 1940, at Demopolis, Alabama, and served at its home station until December 13, 1940, when it was transferred to Camp Blanding, Florida, as a part of the 106th Quartermaster Regiment.

MEDICAL DETACHMENT


The Medical Detachment, 106th Quartermaster Regiment, was organized and Federally recognized on June 1, 1936, as a part of the Mississippi National Guard, with home station at McComb, Mississippi.

It participated with the 106th Quartermaster Regiment in the Third Army Maneuvers in the DeSoto National Forest, Mississippi, in 1938, and the Third Army Maneuvers in Central Louisiana in 1940.


Inducted into Federal service on November 25, 1940, at McComb, Mississippi, it was transferred to Camp Blanding, Florida, on December 13, 1940. The detachment is commanded by Captain Thomas Purser, Jr., with Captain James H. Armstrong as a Medical officer. The detachment is composed of three officers and 21 enlisted men.



















