To be entitled An Act regulating the
Right to Keep and bear Arms.

Sec 1st

Be it enacted by the Legislature
of the State of Texas, that if any person shall
go into any church or religious assembly,
any school room, or other place where
persons are assembled for educational,
literary or scientific purposes, or into
a ball room, social party or other social
gathering composed of ladies and gentle-
men, or to any election precinct on the
day or days of any election, where any
portion of the people of this State are
collected to vote at any election, or to any
other place where people may be assembled
to muster or to perform any other public
duty, or any other public assembly, and
shall have about his person, a bowie knife
dirt or butcher knife - or fire arms, whether
known as a six shooter, gun, or pistol of
any kind, such person so offending shall
be deemed guilty of a misdemeanor, and
on conviction thereof shall be fined in a
sum not less than fifty or more than five
hundred dollars, at the discretion of the
Court or Jury trying the case, Provided

That nothing contained in this section shall apply to locations subject to Indian depredations.

Section 1st

Be it enacted by the Legislature
of the State of Texas that if any person
shall go into any church or religious
assembly, or into a Ball room, social party,
or other social gathering composed of ladies
and gentlemen or to any election precinct
on the day or days of any election, where
any portion of the people of this State are
collected to vote at any election, or to
any other place where people may be
assembled to muster or to perform any
other public duty, and shall have about

A BILL

TO BE ENTITLED "AN ACT REGULATING THE RIGHT TO KEEP AND BEAR ARMS."

SECTION 1. *Be it enacted by the Legislature of the State of Texas,* That if any person
2 shall go into any church or religious assembly, any school room or other place where
3 persons are assembled for educational, literary or scientific purposes, or into a ball
4 room, social party or other social gathering composed of ladies and gentlemen, or to
5 any election precinct on the day or days of any election, where any portion of the peo-
6 ple of this State are collected to vote at any election, or to any other place where peo-
7 ple may be assembled to muster or to perform any other public duty, or any other
8 public assembly, and shall have about his person a bowie knife, dirk or butcher knife,
9 or fire-arms, whether known as a six-shooter, gun, or pistol of any kind, such person so
10 offending shall be deemed guilty of a misdemeanor, and on conviction thereof shall be
11 fined in a sum not less than fifty or more than five hundred dollars, at the discretion of
12 the court or jury trying the same; provided that nothing contained in this section shall
13 apply to locations subject to Indian depredations.

SEC. 2. That this act to take effect and be in force in sixty days from the passage

Section I Be it enacted by the Legislature of the State of Texas, That if any person shall go into any church or religious assembly, any school room, or other place where persons are assembled for educational, literary or scientific purposes, or into a ball room, social party or other social gathering composed of ladies and gentlemen, or to any election precinct on the day or days of any election, where any portion of the people of this State are collected to vote at any election, or to any other place, where people may be assembled to minister or to perform any other public duty, or any other public assembly and shall have about his person a bowie knife, dirk or butcher knife or fire arms whether known as a six shooter, gun, or pistol of any kind, such person so offending shall be deemed guilty of a misdemeanor, and on conviction thereof shall be fined in a sum not less than fifty or more than five hundred dollars, at the discretion of the court or Jury trying the same, Provided That nothing contained in this Section shall apply to locations, subject to Indian depredations, and Provided further That this act shall not apply to any person or persons whose duty it is to bear arms on such occasions in discharge of duties imposed by law.

Section II That this act take effect and be in force in sixty days from the passage thereof.
