1. The Old Buckner Place "Oakland" 215 acres. Involved in several Chancery Court suits: Edmonds, Guardian vs. Buckner; Henry Rudolph, Administrator of E.C. Randolph, deceased vs. Arrabella Virginia Randolph; John P. Wright vs. J.H. Rives and others.

2. Adjoining tract of 29 acres, 2 poles known as "Martin Field," minus residue after selling several lots

Randolph contracted to purchase the property for \$4,650.00, but defaulted on the contract and subsequently died. Sold to W.W. Spain (bidder for Waugh) on 8/4/1882 for \$2,500.00.

215 acres "Oakland" formerly owned by Colin Buckner, deceased. Conveyed to James Paxton, Trustee for Rachel Buckner [wife of J.W.E. Buckner] and children by deeds: Elisha Paxton (7/13/1852), William Langhorne (8/1/1855), Martha Buckner (9/20/1855), Alexis Alexander (5/20/1856) in Lynchburg Deed Book T, page 41-42, Campbell Deed Book 30/240-241,358. Plat by Hutter delivered to purchaser [plat not found].
