Note. *1826. Smith. I have a Smith problem of considerable historic interest, involving the relationship of two distinguished families of the name in Massachusetts and South Carolina. The following facts are known and constitute, with some tradition, the present inquiry for further information:

Thomas Smith of Charlestown, Mass., called by Wyman a butcher, was evidently a mariner who abandoned the sea and engaged in business, somewhat unsuccessfully. I judge that he was born about 1620, and he is first heard of about 1660, and shortly after married Sarah Boylston, perhaps a second wife. The issue of this marriage is of record in Charlestown: Sarah, born 1664, died young; Thomas, born July 4, 1665; William, born March 24, 1667 (the grandfather of Mrs. Abigail Adams, wife of President Adams), and Wyman adds another son, John, born Dec. 11, 1671, died 1688, in Jamaica, and "a son," born Feb. 4, 1681-2.

The town records of Charlestown dispose of these people as follows:

"Thomas Smith Sen'r dyed February 14, 1690.

"Thomas Smith son of the above Tho. Smith dyed at sea September 8th, 1690."

There is no settlement of the estates of either of these Thomases in the Middlesex or Suffolk Probate offices. The senior Thomas was in debt and probably left nothing to settle up, and the junior Thomas, evidently a mariner, "died at sea," and as he is the problem in the case it becomes of interest to know where he died and whether he had acquired a residence elsewhere. He was twenty-five years old at death and may not have left any property. Wyman in his "Estates and Genealogies," II, 574-5, says of these particular Smiths, "Thomas Smith, governor of South Carolina, was of this family." This statement is apropos of nothing and was inserted by Wyman with some reason, but so far nothing has developed in the records to explain this interpolation. It cannot be assumed he did it without evidence.

In 1715, Thomas Smith, mariner, of St. James Parish, Berkeley County, S. C., quitclaims to his uncle William (2) Smith of Charlestown, Mass., all his right, title and interest in the estates of his grandfather, Thomas, and grandmother, Sarah (Boylston) Smith. This uncle was the William born 1667, and as there was but one known brother Thomas (born 1665, died 1690 at sea) who could have had children, the inference is plain that Thomas of St. James Parish was son of Thomas, born 1665, and is selling to his only surviving uncle. No other deed is recorded of any other Smith elsewhere

selling his rights in Charlestown, and it is of importance as tending to establish a theory of descent through this line.

Among the large landed proprietors of South Carolina was Bernard Schenkingh, whose daughter Barbara married Landgrave Thomas Smith, governor of South Carolina, who died 1694, leaving a son Thomas Smith, also landgrave of Carolina. This Bernard Schenkingh had a daughter Elizabeth, and the tradition in this branch of the Landgrave Smiths, as indicated in Bible records and family papers, is that Elizabeth Schenkingh married a Thomas Smith of the Charlestown, Mass., family and had one son, Thomas, born April 28, 1691. The conditions require close but not improbable dates to apply them to the Charlestown, Mass. Thomas, born 1665, died Sept. 8, 1690, "at sea." It makes the birth of the son seven months after the supposed father's death and is therefore consistent with the theory. This Thomas, of South Carolina, born 1691, is, therefore, the nephew who in 1715 sold to his uncle William, upon this theory of identity. Furthermore, this Thomas, born 1691, married Sabina Smith, daughter of the second landgrave, and the statement is that he was her "cousin," a relationship which came through the Schenkinghs. It will thus be seen that there is excellent reason for maintaining the theory of the marriage of Thomas Smith of Charlestown, Mass., to Elizabeth Schenkingh of Charleston, S. C., his early death immediately after the birth of a posthumous son, who in 1715, quitclaims his rights to his uncle William. Further, this relationship between the two families of Massachusetts and Carolina has been a tradition in the Adams family for generations. President Adams, in a letter dated 1815, says his son John Quincy was "a relative of the Smiths of Charleston, South Carolina," but that is not explicit enough to mean anything in particular, though the landgrave's family were the Smiths of Charleston.

The writer desires any light on this interesting problem and would say that he has searched the records both here and in South Carolina without obtaining the actual proof required to establish the theory. Possibly some private records or documents overlooked by me will afford the necessary corroboration.

Book 10 page 249: Andrew Bettz has a State Grant, #936, for 100 acres on Dutch Second Creek next said Bettz, Michael Peeler, Windle Miller & Conrod Lingle, on Nov. 4 1784.

Extracts from Bethabara Diary of 1763, Vol. I page 271 (by Miss Adelaide Fries): "April 26. Hans Schor, of Bethania, who had been to Salisbury to seek Peter Schmid's daughter for his wife, returned today with her and her parents, and April 27, they were married by Br. Loesch."

The will of one Johannes Schorr, made in Dutch or German (book A page 153) while "sick in body" on Jan. 5 1770. Wife Magdalen (who is to have everything but is to educate the sons Johannes, Peter & Henry. Exr: brother Henry Schorr.

Book 6 page 562: On Jan. 15 1768, Esq. Francis Lock, the high Sheriff of Rowan Co.N.C. (whereas the superior Court of Salisbury District, held at Salisbury on March 22 of the 7th year of his Majesties reign, & the Honorable Edmund Fanning Esq. as Assistant Justice of the District of Salisbury decreed that the lands of Oliver Wallis, a "Carpender" late of Salisbury, should be sold for debt, & a fieri facias was issued under the seal of Esq. John Frohock "Clark of the Superior Court of Justice" of Rowan) puts up the 188 1/2 acres on Grants Creek next the original survey--which had been confirmed by deed from Peter Smith to Oliver Wallis on Oct. 15 1766-- & sold to John Mitchell, a merchant of the county, for 47 pounds & 17 shillings on Sept. 22 of the 7th year of his Majesties reign, as highest bidder, witnessed by John Braly, Max Chambers & James Thompson & acknowledged by the Sheriff in April 1768. (The debt of 47 pounds & 17 shillings with 3 pounds, 18 shillings & 7 pence for detention, which latter may not have been obtained).

Book 8 page 29: On April 4 1761, Earl Granville lets James Carson of Rowan Co.N.C., have 320 acres on the north side of Grants Creek, for 10 shillings, witnessed by John Frohock & W.Lucas & proved in Aug. 1772.

John Wilson. (Done by Jno. Miller, Jas. Smith, Jas. Ellis, R.L. Hargrave & Matthias Long, the commissioners.)

The land of another David Smith divided in 1903, for which write Mrs. Chrissie Smith in care of Mrs. Mollie Myers, Linwood, route #2. This land is about Cotton Grove section. Mr. Holmes of Linwood, N.C., says the father of this one was also named David Smith.

Henderson Crawford, of Salisbury, says his grandfather was Charles Smith who lived about five miles from Jersey meeting house in a brick home which was later burned. Refer to Lindsay Smith family.

Land Proceession, book 1 page 23: On Oct. 10 1840 the land of deceased Peter Smith is divided:
