



tion into the battle field--a field the terrible harvest of which it was his destiny to reap. This was a memorable battle. The Indians were led by Little Turtle, who evinced the sagacity of a disciplined soldier. The savages made the attack so suddenly that they instantly perceived that they had gained an advantage, and this was everything to the red man. If he began well, he went through the fight with desperation, but a vigorous defense caused him to quail. Major Adair directed his plan of battle skilfully, directing Madison, afterward governor of Virginia, to attack the right, and Lieut. Hull the left; but the enemy had already killed Hull, and it became necessary for Adair to lead the assault. He did so boldly, and the Indians fell back; but learning tactics in their flush of success, Little Turtle sent sixty of his warriors to turn the right of the troops. There was but one thing left for the regulars. It was unusual in the annals of Kentucky to sound a retreat, but it had to come, and in the best order available; the retreat was made, and they fell back on their camp. The Indians in all their fury rushed after them, knowing as their leader did, their power in one fierce charge, but Adair rallied, and drove them back. Here an officer figured, to whose counsels and experiences, and many of them, it may be, founded on this battle, the world owes one of its greatest of modern military commanders. It was the father of "Old Zach"--Col. Richard Taylor, who was the prominent in this struggle. At that time the future hero of Buena Vista was eight years of age, and it is easy to imagine with what intense interest the fireside stories of his gallant father were heard by the boy."

Tennessee Guide (page 347); Adair's Station, Sullivan Co. Tenn. was a log cabin built in 1788 by John Adair, Entry-Taker of Sullivan County, who financed the expedition led by Isaac Shelby & John Sevier which defeated the British in the Battle of King's Mountain, when the two latter promised that the State would repay it. John Adair was a member of the Tennessee Constitutional Convention of 1796.

D.A.R. Lineage, vol. 78 page 275: Mrs. Adair Taylor Aiken (wife of Wyatt Aiken), born joined as #77731 from Major John Adair (1759-1840) born in Chester District, S.C. died in Mercer Co. Ky., served as aid-de-camp to General Thomas Sumter in S.C. partisan warfare, was placed on the Kentucky pension-roll in 1831 for service as major in S.C. line. (See also #71224). She is the daughter of Thomas Hart Taylor (1825-1900) & wife Eliza Adair Monroe (1852-1901) whom he married in 1878; granddaughter of John Adair Monroe & wife Maria E. Bacon; great-granddaughter of Thomas Monroe & Eliza Adair; great-great-granddaughter of John Adair & wife Caroline Palmer.

King's Mountain and It's Heroes (Draper) page 463: "Edward Lacey was born in Shippensburg township, Pennsylvania, in September, 1742; and when only thirteen, fascinated with the appearance of soldiery, he ran away, joined the Pennsylvania troops, serving in the pack-horse department, and was in Braddock's defeat. After two year's absence, his father found and took him home. When sixteen, he again ran away, emigrating to Chester District, South Carolina, with William Adair, to whom he bound himself to learn the trade of brick-laying, and from whom he received a good English education. In 1766, he married Jane Harper, and settled on the head waters of Sandy river, six miles west of Chester Court House. He became a Captain on the breaking out of the Revolution, and served on Williamson's Cherokee Campaign; and when news reached them of the Declaration of Independence, he read that patriotic paper to the army. He lead the detachment that defeated the British Captain Hugk, and served with Sumpter at Rocky Mount, Hanging Rock, Carey's Fort, and Fishing Creek. At King's Mountain, he lef the Chester troops, losing his horse in the action, which was replaced with one of Ferguson's charges."*****



Daniel Boone and The Hunters of Kentucky (by W.H. Bogart, published in 1858) page 410: "Gen. John Adair was early trained to war. He had learned in the cruelties of an imprisonment during the revolution, what war really was. Migrating from South Carolina, he joined the bold and adventurous in Kentucky, and in the bloody border war took active part. On the 6th of November, 1792, he organized a company of volunteers to guard the transportation of supplies to the forts north of the Ohio river. Contiguous to Fort St. Clair his troops were attacked by the Indians with terrible force, and here young Davies, who had dashed away from the plow to volunteer for the stirring strife, took his initia-

Dear Mrs. Tufts,

Your letter has slipped in among my papers so that I cannot find it at present, but have been looking through the minutes as you desired and will make notations, although they seem so little to work on.

Aug. (8?) 1778: "Register of Persons who refused or neglected to appear before the Justice of their respective Districts and take the Oath of Affirmation of Allegiance to the State agreeable to Act of Assembly & who have omitted appearing at Court and rendering Excuse for such Neglect at Court and rendering Escuse for such Neglect or Refusal": a total of 577 persons. among whom are: John Adams in the District of Captain Johnston among the Bryans in the Boone family vicinity, (of which I told you) in a total of 128; Zachariah Adams Sr. & another Zachariah Adams in Capt. Lyons' District out of a total of 112 (probably in the lower section of Davie County or possibly I should have said the eastern portion); an order was given and this remained

Aug. 5 1777 the county was divided into districts so that the people might take the oath

An order of Court on the seventh of Aug. 1778, required that those who refused to take the oath should leave the State within sixty days for the West Indies or Europe and that the Clerk advertise this order.

Aug. 5 1778, there were quite a number of Tories permitted to take the oath after giving their excuses and paying for certificates, among whom: Moses Adams, Abraham Adams & John Adams.



A letter from Mrs. Eugene Howard May or "The Weissinger-Gaultert", Lexington, Ky. on Aug. 22 wanting Adams information--also Turner. Says her John Adams had a brother named Peter, who was born in York Co. Penn in [unclear] died in Washington Co. Ky. in 1846 didn't marry. Her ancestor, John Adams born 1760 in York Co. Pa. married in 1786 to Eleanor Worland, was a Revolutionary soldier, drew a pension, was a Catholic, moved from Frederick Co. Md. to Ky. where he died in 1842. There were other Peter Adams in Washington Co. Ky.--one who died in 1845 leaving a wife & sons Blisha S. & Eligh B.--he came with his uncle, Jacob Hunter, from Rowan Co. N.C. & drew a Revolutionary pension. On her Turner line her line runs: Roger T. Turner married Catherine [unclear] had a daughter, Elizabeth, who married Danile Boone Bryan (son of Col. William & Mary (Boone) Bryan. This niger T. Turner came to Ky. about 1786, and I think died here although I cannot find his will. Left property in Fayette County. His wife, Catherine left a will about 1804 mentioning all of her children but I do not know her maiden name. Would like to join D.A.R.

McCall-Tidwell And Allied Families (by Ettie Tidwell McCall) page 281: "WILLIAM ADAMS¹ of England, was probably a passenger on the ship "Elizabeth and Ann" from London in 1635. He was married in England and had three sons, William, Nathaniel and Samuel. He settled in Cambridge, Massachusetts, and died in 1666.

"WILLIAM ADAMS² (William¹) born in England, 1620, was also a passenger on the "Elizabeth and Ann", coming over with his father at fifteen years of age. He married ----- and had two sons, John and William.

"REVEREND WILLIAM ADAMS³ (William², William¹) was born in Massachusetts, May 27, 1650, and became the second minister at Dedham, Massachusetts, and was ordained December 3, 1673. Married October, 1674, to Mary Manning. He married second time on March 29, 1680, to Alice Bradford, daughter of William Bradford. Judge Sewall, a descendant of Henry Sewall of Massachusetts, informed us that William Adams preached the General Elect Sermon on May 24, 1684, and died August, 1684. Prayers were publicly offered at his funeral for the first time in New England on an occasion like this.

THOMAS RICHARDS OF MASSACHUSETTS

McCall-Tidwell And Allied Families, page 280: "MR" THOMAS RICHARDS was one of the original settlers of Dorchester, Massachusetts. He was born about 1590, came from Dorsetshire, England, to America. Landed at Boston, Massachusetts. Selectman at Weymouth, 1643. Freeman May 18, 1630. He married Welthean Loring in England. His will was probated November 28, 1650. She died in Boston, Massachusetts, her will probated November 4, 1679. Children: 1. JOHN mar. Elizabeth (Hawkins) Winthrop.

"+ ALICE RICHARDS² (Thomas¹) born in England, 1627, came with her parents to America. Married at Weymouth about 1651 to William Bradford² (William of Plymouth). Born in Plymouth, June 17, 1624; died at the same place February 20, 1704. (See Bradford Family.)"

ALEXANDER CARPENTER OF ENGLAND.

(Alice Carpenter of Plymouth).

ALICE CARPENTER² (daughter of Alexander Carpenter of England) had five sisters: Mary, Alice, Agnes, Julia Ann, and Priscilla, who were all identified with the history of the English exiles, who fled to Holland for conscience sake. She married (1) Edward Southwroth, one of the religious exiles who followed Rev. John Robinson to Leyden, Holland, in 1613. She was born about 1590 and died 1670. They had two sons.

"In the summer of 1623, the ship "Ann" came to America and brought many supplies for the little Colony; and in this ship came a little family, destined to be well known in the New World, the widow Alice (Carpenter) Southworth and her two sons. Soon after her arrival, she married William Bradford, Governor of Plymouth Colony, as his second wife.

DEACON EDWARD COLLINS, MASSACHUSETTS.

McCall-Tidwell And Allied Families (by Ettie Tidwell McCall), page 274: "DEACON EDWARD COLLINS¹ was the oldest son of John Collins of London, England, who was buried at Brampton, Suffolk County, England. He married (1) Abigail Rose of England (dau. of Thomas Rose of Braintree). He was born in England in 1603, emigrated to America, and came to Massachusetts Bay with his wife Martha..... Was at Cambridge in 1638. In 1636, he was owner of large tracts of land around Cambridge. A freeman May 13, 1640; appointed Clerk of the Writs October, 1641; Deacon of the Church before 1658. Was a man of prominence in the Church and political life of the Colony and always spoken of as a very pious man. He represented Cambridge in the General Court, 1654-1670; a member of the Military Co. of Cambridge commanded by Captain George Cooke. In 1641, a member of the Military Company of Massachusetts, which subsequently assumed the title of "the Ancient and Honorable Artillery." He died at Charlestown, Massachusetts, April 9, 1689. 
His mother was an Adams, descendant of the earliest settlement of Massachusetts Bay family--his maternal grandfather was an officer in the Connecticut Continentals who went to Massachusetts but arrived too late to be in the battle of Bunker Hill.

His paternal grandfather was also an officer in the Revolution--his paternal grandfather Smith was married in 1642 at Hartford, Conn. Both of his paternal grandmothers were descended of Richard Seymour who settled in Hartford in 1635, but by different lines. (The Connecticut & New York lines trace to him.)

Ashbel studied at the Hartford Grammar School & elsewhere, was graduated from Yale College in 1824, took about one year's course of law in North Carolina but as his health failed completely, switched to medicine & attended lectures in New York City & New Haven. Getting his medical degree at Yale he continued study in Paris, France, where he became officially attached to Neckar Hospital, &c.


He began the practice of medicine in America at Salisbury, N.C., went to Texas early in 1837, where he was appointed Surgeon-General of the Texas Army during of that year but resigned in December 1838.
