Book 11 page 29: April 28 1786, Esq. John Brevard (as high-sheriff of Rowan Co. N.C., on the complaint of Samuel Young to Esq. Jacob Nichols, that William Morrison had left the county owing him 101 pounds, and by order of court to obtain restitution, executed by James Andrew, a constable, on Aug. 23 1785, the said high-sheriff Brevard, sold the tract for 101 pounds, 8 shillings & 7 pence, & for debt of 2 pounds 17 shillings & 11 pence for--do not quite understand this) lets Samuel Young have for 50 pounds, 209 1/3 acres, on the waters of Sills Creek next James Ervin & the old plantation of Jacob Nichols, where Thomas Swan & Hugh Allen live, beginning on the corner of Ervin & Nichols at a hickory, going south 19 degrees west 38 chains to a black oak on the corner of Nichols, south with the same line 20 chains to a small black oak on the corner of Allen, east 52 chains with the line to a stake in the old line, north 58 chains to a black oak, then to the beginning (being one third part of the tract of 628 acres conveyed by John Patterson to the now deceased Archibald Morrison, who willed it to the said William Morrison), witnessed by Alexander McWhorter & Benjamin Brevard & proved by the latter in May court of 1787.

(This is part of the 675 acres granted by The State to Gasper Neadrick on Oct. 6 1800).

Sons: Samuel (the upper part & remainder of my plantation next the meeting-house, John Carson & John Irvin, on the creek, & the negroes: Ned, Dunkin, Anes, Raih, Rose & George, also the plantation I bought of Adam Jeefle). Exrs: brother John & James Kerr. Witnesses: John Irvin & Mary Cowan (test).


Samuel Young. (North Bank of Middle Fork of Rockey Creek). Book 11 page 330: Oct. 25 1786, The State grants (#1097 at 50 shillings the 100 acres) to Robert Wason 366 acres on the Middle Fork of Rockey Creek, beginning on its north bank on the line of Thomas Bones at a hickory, going with his line north 38 poles to a post oak on the corner of Bones, east 62 poles to a pine on the corner of John Bones, north with his line 64 poles to a post oak on the corner of Hugh Andrews, west with the line of Andrews & — Stewart 362 poles to a black oak by a glade on the corner of the line of Andrews & — Smith, south with the lines of Smith & --- Little 240 poles to a beach of Stewart & --- Smith, south with the lines of Smith & --- Little 240 poles to a beach on the creek bank, then down its meanders to the beginning.

Book 11 page 344: Oct. 25 1786, The State grants (#1316 at 50 shillings the 100 acres) to Robert Wason 100 acres on the north side of the Middle Fork of Rockey Creek on the north side of Hugh Andrews, beginning on the corner of said Andrews at two pines, going west with his line 140 poles to a pine, north 120 poles to a pine, east 140 poles to a pine, then to the beginning.

Book 11 page 395 or 397 (numbered twice): Oct. 25 1786, The State grants (#1263 at 50 shillings the 100 acres) to Hugh Andrews 400 acres on the Middle Fork of Rockey Creek, beginning on the line of Robert Wason & corner of ---Stewart at a black oak, going north with the line of Stewart 300 poles to a black oak saplin, east 230 poles to two pines by a branch, south 170 poles to a black oak, west 40 poles to a post oak at the head of a hollow, south 130 poles to a post oak on the line of John Bone, then with the line of Wason to the beginning.

The will of Townsend Burroughs (book H page 171) made while "in a now State of health" on March 15 1822 & probated in Aug. 1822. The land on the hill next Jonathan Young & My house go to William Young & Jonathan Young. Duffy & Jonathan (sons of Thomas Burrough's) must be paid \$50.00 each for their schooling, and the remainder goes to Nancy (widow of William Young), Margaret & Jonathan Young. Exrs: John Young & Henry C. Burke. Witnesses: Richard W. Barber & John E. Barber.

Book 11 page 427 or 428 (numbered twice): May 1 1788, Abel Armstrong, a blacksmith--no wife signs--lets the planter, Samuel Young (both of Rowan Co.N.C.), have 11 acres on the south side of Third Creek next the old Titled land of the said Samuel Young, which he bought of Mary Armstrong, late of the said County of Rowan, beginning on the east side of the Meadow Branch & going south 8 chains & 25 links to a maple in the said branch, west 28 chains to a birch at the south bank of said creek on the corner of said Samuel Young's old place & the land he bought of the said Mary Armstrong, then with the line of said Mary Armstrong to the first corner of Samuel Young, for 10 pounds N.C. money, witnessed by William Foy & Cathrine Armstrong & acknowledged in May court of 1788. (This is part of the 144 acres Granted the said Abel Armstrong on Oct. 25 1786).

Book 11 page 428 or 429 (numbered twice): Sept. 19 1787, Mary Armstrong of Rowan Co.N.C., lets Abel Armstrong of ----, have 36 acres on the south side of Third Creek, beginning on the old original corner of said Mary Armstrong's land at a white oak on the land where the said Abel Armstrong now lives, north 27½ chains to a hickory on the south bank of Third Creek, up its various courses to a beech at the mouth of the Meadow Branch on the corner of the land which the said Mary Armstrong sold Samuel Young, up the meanders of said branch to a white oak on the corner of said Young & the line of said Abel Armstrong's new Grant, then to the beginning, for 25 pounds, witnessed by Ninian Steel & Samuel Young & proved by the latter in May court of 1788. nel of said creek, for \$590.00, witnessed by Moses D. Kilpatrick & Robert N. Fleming &  
proved by the latter in Nov. 1836.

Sarah Valentine, Lucinda Munn, Rebecca H. Higgins, Nancy Rice, Phebe Gill and Pamela  
Crane, wife of Joseph Crane.

Oct. 21, 1836, John J. Valentine, of Boston, Mass., aged 61 years, declares that Dr.  
John Young and his widow, Rebecca Young, were the parents of his present wife, etc.

Feb. 27, 1845, Abner D. Young was residing in Phippsburg, Me. (one of the children).  
March 15, 1855, Nathaniel and Rebecca H. Higgins, his wife of Duxbury, declare they  
are interested heirs-at-law of Rebecca Young.

George W. Higgins appears as a witness (no relation stated).

In 1848 Mrs. Willson and Mrs. Rice, of New York, are referred to as daughters.  
Mrs. Rebecca Young died July 26, 1837.

April 9, 1855, the surviving children were Abner D. Young, Rebecca Higgins, Sophia

Book 11 page 245; Aug. 9 1781. The State grants (\$1594 at 50 shillings the 100 acres) to Thomas Young 720 acres on the waters of Hunting Creek, beginning on the line of said Young at a pine, going west 104 chains to a small white oak, south 62 chains to a black Jack, east 80 chains to a pine on the corner of Jacob Nichols, south 15 chains to an ash on the Long Branch near the five pines, east 64 chains to a hickory, north 11 chains to a post oak, west 42 chains to a white oak on the Long Branch, then north to the beginning.

Park of Abbott's Creek

Colonial Families of the United States (by Mackenzie) 1907, page 66; Charles Carroll of Litterlum, Kings Co., Ireland, born 1660 died July 1 1720, (2nd son of Daniel Carroll, 13th descendant from Florence O'Gorman, King of Ely, who died in 1025), came as the Attorney General of Lord Baltimore, to Maryland Oct. 1 1668 & married 2nd, Feb. 14 1693, Mary Darnall (who died in Feb. 1742, daughter of Henry Darnall by Eleanor (Hutton)) & had 10 children, the 8th being Daniel of Duddington who was born Oct. 3 1707 & died April 15, 1734, who married Ann Roxier (daughter of Notley Roxier of Notley Hall, Prince George's Co., Maryland), who later married Benjamin Young.

Application for pension May 12, 1818. Age. Residence at date of application, Quincy, Mass.

He entered the service June 1775, served as a surgeon for 1 year, part of the time in Col. Benjamin Church's Regt. and part of the time in Col. Varnum's Regt. R.I. Troops under the command of General Greene.

May, 1780, he enlisted and served aboard the Continental Ship "Gen. Mifflin" of twenty guns, commanded by Capt. Daniel McNeill of Boston, for one year.

John Young died June 19, 1820, in Quincy, Mass."

She was married to John Young at Wellfleet, Mass., Sept. 3, 1776, by Rev. Isaiah Lewis.

Dr. John Young, late of Lewis in Sussex, England, now of Wellfleet, and Rebecca Young, of said Wellfleet, were married by the Rev. Isaiah Lewis, Sept. 3, 1776. Recorded by Hezekiah Doane, Town Clerk, copied from the 1st Book of records kept in the town of Wellfleet, Oct. 10, 1836. Signed: Josiah Whitman, Town Clerk.

Sons of American Revolution, page 256: John Edward Fenwick of Laurel, Maryland, joined the District of Columbia Society as #13559, son of Frances Yates Fenwick by Alice Gertrude (Evans); grandson of Edward Fenwick by Mary Carolina (Sheiburn); great-grandson of Thomas Fenwick by Ellenor (Young); great-great-grandson of Ignatius Fenwick, Colonel of the Maryland Militia, also of Notley Young, Member of Annapolis Convention of 1775 & Justice of the Peace.

Page 437: Joseph Lancaster Brent of Baltimore, Md., joined the Maryland society as #1128, son of William Leigh Brent by Maria (Fenwick); grandson of James Fenwick by Henrietta (Lancaster); great-grandson of Ignatius Fenwick, Jr., Major of Barnes' Battalion of the Maryland Militia.



Jacob Young (Pounders Fork of Abbotts Creek Book 11 page 11, March 27 1787, Michael Young (perhaps a German & it is signed by another German), makes a quit claim to Jacob Young--all of Rowan Co.N.C.--for 400 acres on Pounders Fork of Abbotts Creek, beginning on the line of Davauld Peck--20 chains from his north east corner--at a stake, going with his line east 20 chains to his corner, contained 45 chains in all to a post oak, north 15 chains to a stake, east 15 chains to a small pine, north 55 chains & 30 links to a red oak, west 60 chains to a small black oak, then 70 chains & 30 links to the beginning, for 30 pounds N.C. money, witnessed by some Germans(?) & proved by Fredrick Goss in May court of 1787.
