William Russell of Kentucky

Page 448 of Daniel Boone & the Funters of Kentucky (by W.H.Bogart, published in 1858) William Russell was born in Virginia about 1758 while that state was fighting England. At an early age, the father of said William, left his home in Culpeper County, for the western wilds near the border.

While Culpeper County was of that portion of Virginia where Indian Alarms were more or less unheeded, where he headed was totally unprotected, so young William learned self-preservation very early. When but 15 years of age, he fermed a company under Daniel Boone against the Indians, & the remainder of his life was spent in such undertakings. In 1780, he visited Kentucky--this was the year of the very hard winter. When Nashville Tenn. was defending itself, he visited & helped them. He was in the battle of King's mountain where he was conspicuous for his daring, as second in command of the Virginia mounted regiment, circumstances soon placing him as in full command--it is thought that he was the first to reach the summit of the mountain & to him was the sword first surrendered. This gallant service was followed by a series of bold passages as a soldier in successive engagements.

Arter the Revolution ended, he removed to Kentucky, in Fayette County, where the Indians assailed him continuously. Later he served under Anthony Wayne & William Henry Har rison—the latter assigned to him the defense of the frontiers of Indiana, Illinois & Missouri. His entire life of almost three-score years & ten was spent in service for his country.

King's Mountain and It's Heroes (Draper) page 406; "William Russell, Jr., who, though only a Lieutenant, commanded Captain Neal's company at King's Mountain, was born in Culpeper County, Virginia, in 1758.
