Samuel Young, a planter, on May 27 1756, gets for 66 pounds, 520 acres on the north side of Third Creek from Michael Dickson, a weaver. The witnesses are John Kerr, James Hemphill & James Storey. Proved by John Kerr. Book 3 page 295.

Deed from Earl Granville to Samuel Young for 150 acres Aug. 6 1759 proved by William Churton.

Will of Alexander Young (Book A page 166) made Dec. 4 1769 probated Feb 1770. Wife = Ann. Daughters = Jane -- (Sarah, Mary & Rachel have received their portions). Sons: Alex., James, Samuel & Robert. Granddaughter = Martha Young. Exrs = wife (with his trusty friends; John Dickey, John & Robert Brevard, to help her).

John McWhorter to Alexr Young deed for 319 acres Sept. 13 1783 proved by John Dickey.

Deed from Mary Armstrong to Samuel Young for 364 acres Sept. 12 1787 proved by Abel Armstrong.

Abel Armstrong to Samuel Young 11 acres May 1 1788. Ackn.

Benjamin Shield to Samuel Young a negro named Sarah or Sall, on July -- 1787 proved by Samuel Young Jr. (wonder where he comes from?).

Abel Armstrong from Samuel Young 26 acres May 1 1788. Ackn.

Lease & Release from Robert Luckey to William McKnight for 559 acres Feb. 5-6 1760 proved by John Kerr. (Coddle Creek)

Deed from "Mary Reed, Alias Luckie, and John Luckie ex; of Robert Luckie, to Hugh Jenkins 624 Acres, Sept. 3d-- 1785. proved by James McCreeters".

Hugh Jenkins is appointed Admr. of the estate of James Jenkins deceased, on Aug. 6 1782, & quallifies under bond of £ 500 Specie with William Cowen & Mathew Stewart as securities.

Hugh Jenkins settles the estate on Nov. 10 1787. Amount of Sales = £ 85-6-6. Disbursements = £ 109-17-4 Ballance due the Admr = £ 24-10-10 = £ 85-6-6.

James Young is dead & Hugh Park is made Admr. on Jan. 22 1761 with Hugh McCowen & Francis Baitey securities in 50 pounds proc.

Book 21 page 450: On Sept. 14 1808, David Killpatrick & wife Mary, let Peter Brown have 171 acres on S. side of "the Great road, Leading from Salisbury to Catheys Meeting House" about 7 miles from Salisbury, (left them by will of Hugh Jenkins Sr.) for \$722.75. Wit: A.L. Osborne & Jos. Chambers in Feb. '09. Oct. 20 1758: "A Power of Attorney, in Generall, from Samuel Gillkie to Samuel Young, Bearing Date Ninteenth Day of October 1758. Proved by Mathew Wilson one of the Subscribing Evidnce".

Book 7 page 405 shows that John Thompson of York Co. Pa. gets 640 acres from David Horner & wife Mary of same Co. on Sept. 25 1771 for 300 pounds Pa. money land on Marlin's Creek next Jas. Stewart & Wm. Thompson

"Samuel Young and Margrett Thompson Exrs & Exuctrxz? of the Last Will and Testament of John Thompson dead. Returned an Inventory of said Estate, upon Oath which is Duly filled". Jan. 20 1761. (The will of John Thompson was proved Oct. 24 1760 by James Orton. The wife Margerett Thompson & Samuel Young quallified then.)

Deed from Alexr Robinson & wife Jane, to John Thompson for 350 acres July 17 1759 proved by David Byars. Lease & Release from John McCulloch to Alexr. Robinson for 388 acres April 17-18 1758 proved by David moffett.

Jane M. Young to Rufus H. Kilpatrick in 1836 (book 33 page 199) & the same from Jonathan " " " " " " (" 34 " 118)

in Book 25 page 475: Polly Jenkins is the heir of Hugh Jenkins. She is of Lincoln Co. Ky. as are Jenkins Kirkpatrick, Mary Kirkpatrick & Sussannah Kirkpatrick (heirs of David Kirkpatrick) & they appoint their father, David Kirkpatrick, their attorney to sell some property in Salisbury, Rowan Co. N.C. which was left them by the will of their grandfather Hugh Jenkins, namely the lots # 51-52-&43. Barnabas Hughes (Notary Public of Danville, in Mercer Co. Ky. sends his affidavit on April 21 1817,) but the attorneyship is dated on April 21 1817 also. In the same book, page 575: David Kirkpatrick, of Lincoln Co. Ky. the "Attorney in fact for Jenkins Kirkpatrick, Molly Kirkpatrick alias Mary Kirkpatrick and Susanna Kirkpatrick the Son & Daughters of the said David Kirkpatrick" lets John Howard of Rowan Co. N.C. have # 51 in W. square left Jenkins by his grandfather Hugh Jenkins Sr. & # 52 left by same to Mary or Molly Kirkpatrick & Susanna in his will. The amount paid by Wm. Howard = \$100.00 & deed proved Nov. 1819 by Lewis Beard & William Howard.

Deed from Samuel Jenkins to Benjamin Cowan for 200 acres May ---1792 proved by John Lorance.

Will of Hugh Jenkins made (Book ? page 308) probated in 1800 mentions Ann, Jane & Vally Cowan, Marg Stuart, Mary Kilpatrick, Joseph, Samuel, Moses, Hugh, Polly & David Jenkins.

Marriage Bonds:
Hugh Jenkins to Elizabeth Hudgins July 12 1797 signed James McLaughlin.

Page 496 of Our Kin by Laban Miles Hoffman of Dallas, N.C., mentions that his wife is descended of Hugh Jenkins who came from Va. to N.C. about 1750 and settled in Rowan Co. wife named Mary. Died in 1800 leaving property to wife & making her & son Joseph Exrs. Deeds made to the children, Moses & Joseph Dec. 17 1803. Joseph married Col. Frederick Hambricht's daughter; Samuel (md. wife unknown); Moses (md. wife unknown); Aaron (moved to Tenn.); Hugh (md. wife unknown); James (md. " ") died young; Ann (md. Wm. Cowan); Mary (md. Matthew Stuart); Margaret (md David Kilpatrick or Kirkpatrick); Susanna (md Robert Johnston); & daughter? (md Hugh Robinson)--these were sent by Eugene Bean to the author & may be copied wrong. Would make 2 Anns & 2 Marys.

Joseph Jenkins probably lived in Lincoln Co. about Catawba Springs for Long Creek near mill of White & Jenkins where his father, Hugh, conveyed 200 acres to him for "satisfactory considerations". Tradition says he was a fifer in a company of American Revolution. Died in 1821, & his sons, David & Hugh, were Exrs. of his will which mentions 2 sons, 6 married daughters & daughter Mary (who married her 1st cousin Aaron Jenkins in 1821). These were: Agnes who (md Samuel Wells & moved to Pope Co. Ark); Margaret (md. Wm Froneberger & lived on Upper Long Creek); Elizabeth (md. David Lineberger & lived east of South Fork River); Mary (md. Aaron Jenkins in 1821 & lived 2 miles west of Dallas); David (md Nancy Carpenter & lived on Long Creek); Hugh (md. Mary Rhyne & Susan Best & lived on Long Creek); Anne (md. Jacob Carpenter a blacksmith &

The will of Samuel Young proved Nov. 9 1793 by Abel Armstrong. James & John Young qualified as Exrs.

Feb. 6 1794: "Joseph Young, Orphan of Samuel Young, being of lawful Age, came into court & elected John Kerr his Guardian, who gave bond with Abel Armstrong and George Erwin in the Sum of 3,000".

Dr. Ruple in his History of Rowan Co. says the will of Samuel Young mentions seven children: William, Janet, Samuel, James, Margaret, John & Joseph Young. That the eldest, William was married & had a son, Samuel, who was left a small legacy. The 2d, Samuel, received a plantation near Thyatira; James got land on Coddle Creek; John got his on Third Creek & the youngest, Joseph, received the home place according to Scotch-Irish custom. The elder daughter, Janet, married Webb & had a son, Samuel, who received a legacy. Margaret married John Irvin & had sons: Christopher, Joseph & John.

Samuel Jenkins (son of 1st Hugh) lived in Rowan Co. when father died but moved to Lincoln --now Gaston Co.-- & had: Aaron (md. Mary Jenkins daughter of Joseph his uncle & Elizabeth Carpenter); Joseph (didn't marry); Mollie (md. John Murphy).

Moses Jenkins lived on Dutchman's Creek in Lincoln (later Gaston Co.) on land purchased by his father Hugh from Andrew Hampton on Jan. 6 1772--called the Hampton Tract. Had 3 or more? children: Hugh (md.); Stuart (md.);

Aaron Jenkins was living with his niece, Sarah Trott in Rutherford Co. Tenn. when his father Hugh died, but being willed 417 acres in Rowan & later conveyed it to his niece Sarah in Tenn. He was a Revolutionary soldier (a private in cavalry & infantry) & drew a pension.

Hugh lived in Rowan Co. probably & had a daughter named Polly, according to his father's will.

James died before his father Hugh who willed to Sarah (wife of Benjamin Trott) all the land he had received for her as Admr. of his son & her father's estate--namely James Jenkins's estate. She was the only child & was living in Rutherford Co. Tenn.

Ann Cowan (daughter of Hugh Sr.) lived in Locke Township, Rowan Co. N.C. & had: Jane, Polly & other children.

Mary Stuart had children.

Margaret Kilpatrick (thinks the name should be Kirkpatrick) had: Jenkins, Mary, Susanna & others?

Susanna Johnston had son Hugh who got 212 acres on Dutchman's Creek from his grandfather for that reason.

Capt. John M. Young, born in Mecklenburg Co. Va. on Aug. 3 1776, moved with his parents to Hunting Creek in Iredell Co. N.C. in 1778 & lived here until his death on Dec. 12 1758.

Mary Lloyd Young died Feb. 28 1819 in 5th year.

Jenny Young died Jan. 5 1804 in 28th year.

Col. Francis Young died Nov. 1 1854 age 75 yrs. 9 mos. & 22 days. His wife, Mary, died March 19 1851 age 66 yrs. 6 mos. & 1 day.

Capt. Edwin B. Young (son of Col. Francis Young) died Nov. 8 1836 in 24th year.

Thomas Young Sr. died July 9 1829 in his 98th year. His wife, Lucy, died Nov. 1 (or 7) 1807 in her 64th year.

Samuel Young born June 22 1781 died Aug. 14 1847. His wife Sarah, born July 28 1784 died Dec. 28 1853 in his 70th year.

William Gill died Sept. 4 1797 in his 47th year. His wife, Susannah, died Sept. 29 1829 in 74th year.

Ingram A. Gill died July 14 1853 age 73 yrs. 5 mos. & 9 days. His wife, Mary, died Nov. 23 1844 in 61st year.

Thomas T. Blackburn born Aug. 26 1832 died in 1832.

James M. Blackburn born Oct. 30 1837 died Sept. 10 1876.

Sarah S. Blackburn born July 12 1808 died June 22 1873.

Iredell Co.N.C. book M page 876; April 14 1826, Christopher Houston of Maury Co.Tenn, lets his son Placibo Houston of Iredell Co.N.C., have out of love, 350 acres on Hunting Creek next Andrew Mitchell & George Smiley (being State Grant #1452 made to me on Aug.9 1787) also 100 acres on Dutchmans Creek on the Surry County line (which is part of the 1920 acres in Grant #241 made on Oct.27 1798), witnessed by Thomas T.Hall & Samuel King & proven by the latter in Feb. 1827.

Thomas Young born Jan. 5 1732 in Brunswick Co. Va. was the son of Michael Cadet and Martha (Sadler) Young. He married 1st Judith Johnson, 2d Lucy Ragsdale. He moved about the year 1771 to North Carolina & settled on Hunting Creek in Rowan County--now Iredell. He was a wealthy farmer, & had negroes, several blooded horses, and during the Revolution was an ardent patriot. He contributed liberally to the American cause. He converted his log house into a fort or blockhouse as a rendezvous for the Whigs. On their expeditions he acted as Commissary and between times, in company with several others, manufactured powder for the American Army. His four daughters had married Revolutionary soldiers. He died on Hunting Creek, July 9 1829, and is buried there in the family burying ground.

His children were all born in Brunswick County Va. except the last four who were born on Hunting Creek, N.C. Viz:

I. Susan born Sept. 7 1750 died Sept. 29 1829, married William Gill a Revolutionary soldier and farmer, and resided on Rocky Creek, Iredell Co. N.C. He died Sept. 4 1797, at Hunting Creek, Iredell Co. N.C.

II. Mary born Feb. 21 1751, married Thomas Moody a Revolutionary soldier.

III. Henry born May 14 1760? died in Tennessee.

IV. Nancy born July 7 1762, died in Sumner Co. Tenn. Married Daniel Wright a Revolutionary soldier, who was born in Surry Co. N.C. and died in Huntsville Alabama.

V. William born Sept. 3? 1764, died in Sumner Co. Tenn. Married Polly McCord.

VI. Temperance born Jan. 31 1767, died Oct. 29 1831. Married Captain Andrew Carson born March 1 17 , died Jan. 20 1841. He was a Revolutionary soldier and a prosperous farmer, owned negroes, lands and fine horses. For his services in the Revolution, he received a pension for several years before his death. His claim for a pension on file in the U.S. Pension Office, Washington D.C. contains an interesting account of the campaigns and battles in which he participated. He was born, lived and died in Rowan--now Iredell County, N.C. and is buried at Houstonville, N.C. His brother, Lindsay Carson, was the father of Christopher (Kit) Carson the famous guide and scout.

VII. Archibald, born Aug. 6 1769, died in Laurens Co. S.C. He was a farmer and married Nancy Nisbet, born in Iredell Co. N.C. Their children were:

1. John Nisbet born Jan. 16 1793, in Iredell Co. N.C. Was a merchant and died in Laurens Co. S.C. on March 5 186-. (Single.) 2. Henry Clinton, born Feb. 24 1794, in Iredell Co. N.C. lawyer of Laurensville S.C., married his first cousin, in 1827, Lucy (the daughter of John May Young) born in 1800. Their daughter, Jane, born 1828, married William Simpson, Governor & Chief Justice of S.C. 3. Mary Calista, born Feb. 2 1796 died single on Sept. 17 1870 in Laurens, S.C. 4. Thomas Melmoth, born June 20 1798, Laurens S.C., died June 19 1836 at Young's Store, S.C. He was a farmer and married Ellen Hackett of Anderson Co., S.C. 5. Sarah Eugenia, born March 19 1800 died March 22 1803. 6. Nancy Amelia born April 17 1802, died May 1882 Laurensville S.C., married Colonel Coleman. 7. Archibald, born Sept. 9 1804 died Aug. 27 1828 in Georgia. 8. Edward, born July 30 1806, died Sept. 26 1850 in Alabama, single. 9. Harriet Elizabeth, born Sept. 19 1808, died Nov. 13 1850 in Ala. 10. James Alfred, born May 11 1811 died July 30 1873 in Ala. a lawyer.

VIII. Thomas born Aug. 1 1771 died in Hopkinsville, Ky. where he resided. He married Mary Martin, born in Iredell Co. N.C.

IX. John May born Aug. 3 1776, died Nov. 10 1868, on Hunting Creek, N.C. He was a farmer. Married 1st. Jane Nisbet, 2d Mary Osborne--both of Iredell Co. By first marriage, had Lucy, who married her first cousin, Henry C. Young. By 2d marriage, had General John Augustus Young of Charlotte, N.C. who prepared the original from which this copy of the Young family tree was obtained. He was assisted in the work by Mrs. Cecilia Dalton of Houstonville, N.C., who has since furnished much valuable data.

X. Francis, born Jan. 8 1779, died in Iredell Co. N.C. A merchant on Hunting Creek & married, Aug. 29 1805?, to Mary Nisbet, born in Iredell Co. Their children were: 1. Thomas Melnoth, born Aug. 26 1806, Iredell Co. N.C., died June - 1860 in Statesville, N.C. Merchant of Mocksville, N.C. married 1st Mary McNeely born in Mocksville, 2d Margaret Stuart born in S.C. died in Mocksville. 2. John Nisbet born Jan. 19 1810, in Iredell Co. N.C., a physician who resided in 1895 at Water Valley, Miss. Married Kesiah Cowan. 3. Edwin born May 13 1811, in Iredell Co. N.C., died 1836 in Statesville, N.C. a merchant died single. 4. Francis L. born April 7 1815 in Iredell Co. N.C. died in Texas Aug. 1 1891, a farmer. 5. William, born ---died Jan. 20 1892 in Rome, Ga. Married Martha Martin born at Hamptonville, N.C. 6. Calista, born Feb. 19 1823 in Iredell Co. N.C.

Page 1.

The name Young has its origin in the youth of the first bearer of the name when it was adopted, its equivalent, Le Jeune, is a very common name in France. The word Cadet signifies a youngerer or youngest son.

The fact that thirty Coats of Arms have been granted to the different branches of the Young family in England, is evidence of the good social position of the family in the mother country.

The names of the following members of the Young family appear in the list of the early emigrants who sailed from England to Virginia, Viz. Richard, Samuel, Marmaduke, Francis and Nathaniel Young in 163- In the ninth year of the reign of Charles I., Thomas Young was sent as agent to Virginia to search for new territory. Richard Young, his wife and Jene Young resided in Virginia in 1623, and on the muster rolls of that year appears the name of Richard, aged 31, who came in the "George" in 1616.

The relationship of the foregoing persons to each other and to Francis Young the father of Michael Cadet Young, has not been traced but the similarity of their given names to those of the family on this tree, is suggestive of a common origin at least.

I.

Francis Young was born in England in the 17th Century and is believed to have resided in Bristol. He married Martha LeGros, a French Huguenot refugee, and had Michael Cadet and probably other children. By another marriage he had William and perhaps other children. He is said to have had seven sons, most of whom were killed in battle or died in the Army. He and several of his sons were killed in the battle of Blenheim, Bavaria, August 13 1704.

2.

Michael Cadet Young, born in the latter part of the 17th Century, and his half brother William, sons of Francis Young, were also in the battle of Blenheim. They were captured, taken as prisoners to France, and then to England. They were from Bristol and came to America together. Michael came to Virginia and William stopped in Maryland. They were surveyors. Michael Cadet Young married Martha Saddler, resided in Brunswick County, Va. and died there in 1769.

3.

Francis Young, born September 1731 (old style) in Brunswick County Va., was the son of Michael Cadet & Martha (Saddler) Young. He married in February 1754, Elizabeth, daughter of James and Elizabeth (Peyton) Bennett, believed to be a descendant of Richard Bennett, Colonial Governor of Virginia. He removed to Isle of Wight County Va. in 1768 and lived between Isle of Wight C.H. and Smithfield during the Revolutionary War. The house is gone but the site is yet known. He afterwards resided for many years, at Isle of Wight C.H., where he died December 31 1794. Elizabeth, his widow, died Oct. 1798.

Mr. Francis Young was Clerk of the Circuit and County Courts of Isle of Wight County, a position which has been filled by his descendants almost continuously for the present time. During the American Revolution, he served as Commissary in General Will's regiment from Isle of Wight County, having previously served under Braddock at the time of his defeat.

Their children were all born and the sons lived and died in Isle of Wight County Va., except Thomas who was lost at sea, Viz: I. James, Clerk of Circuit and County Courts Isle of Wight County Va., married Lucy Fearn. No descendants now living. His two sons were farmers. II. Francis, Clerk of the Circuit and County Courts, Isle of Wight County Va., married Sally Nelson, after an engagement of seven years and died in seven months. III. Bennett married Mary Godwin but died without issue. She afterwards married a man by the name of Peden, who became deranged, destroyed the journals or records of the Young family kept by Michael Cadet Young, (which was the authority for most of the traditions recorded in this Memorial), and killed himself the same night. Peden was the son of an Episcopal minister.

IV. Peyton, died young.

V. Thomas, the youngest son, died at sea, single.

VI. Michael, was a great musician and blind from the measles. He died young and single.

VII. Nancy married John Jones.

VIII. Elizabeth, married Benjamin English of Isle of Wight County, Va.

XI. Nathaniel, born July 27 1778, died July 23 1841. Married 1st to Sarah West on March 27 1804, married 2d on July 14 1814, to Mary Robinson, daughter of Dr. John H. Purdie of Smithfield Va. The children by the first marriage

X. Francis Ann, married Edmunds Mason and had 11 children. Their son, Hon. John Young Mason, L.L.D., born in Greensville County Va. April 13: 1799, graduated at the University of North Carolina in 1816, became a lawyer and served long in the State Legislature of Virginia, was in Congress in 1831-1845; became a Judge of one of the Federal Courts in 1837; was in the Virginia Constitutional Conventions in 1828 and 1849; became Secretary of the U.S. Navy 1846-1849. Was U.S. Minister to France 1854-1859. Died in Paris, Oct. 3 1859. To his daughter, Miss S.H.B. Mason, the family is indebted for the record of the descendants of Edmunds and Frances Ann (Young) Mason.

Le Gros Young, son of Michael Cadet Young and Martha (Sadler) Young, settled in or near the present city of Columbia, S.C. which he is said to have owned. During the Revolutionary War, he visited his relations in Virginia while en route to attend the Continental Congress or some convention of which he was a member, but no official record of his services in such body has yet been found.

The foregoing records and traditions of the earlier generations of the Young family furnished by Mr. Nathaniel P. Young of Isle of Wight C.H. Va., Mrs. Cecilia Dalton of Houstonville, N.C. and Miss S.H.B. Mason of Washington D.C. were arranged by Capt. Calvin Duvall Cowles, U.S. Army, for whom this family tree has been redrawn and photolithographed. Washington, D.C. Aug. 1895.

The D.A.R. Magazine of May 1916, page 364, # 4433 DRAPER & YOUNG: Miss Margaret L. Duvall of 518 North 2nd St. Mo. writes that John Young is said to have had brothers, Robert, Thomas & Francis--all of whom went to Kentucky from Va. soon after the Revolution. Robert's daughter, Margaret, married Littleton Cook. Robert, himself, married Judith Heath Tibbs, daughter of Capt. William Tibbs. The Gen. Editor of this magazine added that there is a genealogical chart of Michael Cadet Young of Brunswick Co. Va. (compiled by Calvin Duvall Cowles) in the Congressional Library. Also that 2 men named John Young--one living in Pocahontas Co. Va. and the other in Kanawah Co. Va.--received pensions for Revolutionary Service in 1835. She adds that she has been criticised for not specifying West Va., but that there was no West Va. in 1835, all being plain Va.
