

Feb. 5 1778: "Ordered That Crozier Craige reputed Father of Isaac Craige a base born Child begot on the Body of Sarah Brandon, take the said Isaac Craige into his possession whersoever in the County of Rowan to be found"

Aug. 4 1775: "Ordered by the Court, That Isaac Craig, Bastard Child of Crozier Craige be delivered by the said Crozier to Will: Tem: Coles Esqr. to be properly disposed of, and be had at next County Court to be provided for according to Law: To perform which Order the said Crozier binds himself to our sovereign Lord the King in the Sum of £ 20". Securities are Samuel Willson & Moses Linster.

May 4 1779: The will of crozier Craige proved by Alexander Endsley--a witness-- & William Cowen qualifies as Exr.

Nov. 4 1777: Crosier Craige takes oath of fidelity to The State.

+ Will of Thomas Brandon (book B Page 107) made March 8 1783 probated leaves the home plantation of 150 acres to Thomas Smith & wants a horse sold so that Isaac Craige may have 10 pounds. Exrs: Francis & John Lock. Witnesses: Wm Lock sr., Wm. Looke?Locke & Robert Cambell.

George Brandon qualified as Coroner May 9 1781 (as did Peter Faust.)

May 7 1778. In Captain Brandons district, William Cathey Esq. is Justice, Joe. Hays is Constable, & Arthur Erwin, Matthew Brandon & James Cathey are Sessors. In Captain Armstrong's district, James Brandon Sr. (Esq. is Justice?), Richard Graham Sr. little John Lorance & Ab. Knox are Sessors. In Captain Cowin's district, James Brandon Jr. Thomas Gillespie, Robert Harvey & James Knox are Sessors.

Deed or sale from James Innes & Francis Corbin Esqrs. to Richard Brandon 480 acres proved by James Carter Esq. in April 1756. One to Matthew Lock for 600 acres at the same time.

On Oct. 20 ? 1756 "Ordered Per Cur. that Mr. Richd. Brandon serve on the Grand Jury in the Room of Henry Huey by the reason the sd. Huey's Wife Lying very sick & obliged to go home &c"

The will of Margaret Skendrick (Book C page 6) made while 'sick and weak' on Aug. 22 1790. Friend Elizabeth Brandon. Others: Isaac Craige, Martha Cowdan, Jetsy (daughter of John Smith) & the negro woman, Phillis, of Elizabeth Mandon. Exr: Elizabeth Brandon. Witnesses: Mary & Will Cathey.

Marriage bond: Hugh Craige to Mary Billingsley Dec. 8 1799 signed by John Cragg

Marriage bond: Crozier Craige to Sarah Billingsly May 26 1803 signed by John Craige.

The will of Crozier Craige (Book C page 172) made while 'weak in body' on July 9 1776. The 'my beloved Son Isaac Gotten and torn off the body of Sarah Brandon, the hole of my Estate', but he is under age--the other things are to be sold to the highest bidder. Exr: William Cowan of Second Creek. Witnesses: Mary & Alexander Endsley & John Nevins.

May 4 1779: The will of Crozier Craige is proved by Alex. Endsley. William Cowan is the executor.

John Brandon (of Grant's Creek) & wife Elizabeth, had 3 sons: Richard, William & John. Richard married Margaret Locke, & had John, Mathew & Elizabeth.

Mathew Brandon married Jean Armstrong (daughter of Mathew & wife Lily). Armstrongs were pure Scotch & brave etc. Capt Thomas Armstrong killed in Ramsour's Mill where 6 other captains fell & a monument erected.

Mathew & Jean Armstrong had 5 daughters: Elvira md Rev James Hall, Alice md Samuel McCombs, Elizabeth gen Paul Barringer, Mary Md William P. Smith & Margaret md George Miller.

Mary Barringer md Dr. Charles Wilson Harris & had Lydia Brevard Harris who md Rev John Newton Craig D.D. & had daug Maud Craig who md Wm Mathews & had Lydia Brevard & Craig & Craig.

Matthew Brandon

Buried in Thyatira: Matthew Brandon died Sept. 9 1819 age 68 yrs. His wife, Jane died Feb. 3 1810? age 63 $\frac{1}{2}$  yrs.

Matthew Brandon qualifies as Justice for Rowan on Feb. 9 1788. (On May 10 1788, he was appointed Justice in the companies of Captains Graham & Johnston.).

Deed from John Todd to Matthew Brandon for 245 acres Jan. 20 1789. Ackn.(over)

Buried in First Presbyterian Church, Charlotte, N.C.: Alice Brandon, wife of Samuel McCombs, died July 2 1813. (Marriage bond in Salisbury: Samuel McCombs of Mecklenburg County to Alice Brandon Feb. 15 1809 signed by Alex. McGibbons & Geo. Miller before Matt. Brandon.) There are other McCombs (2 Samuels) in Charlotte.

Nov. 5 1794: "Matthew Brandon's Mark, Crop & Slit in the off ear and Near Ear slit"

Nov. 6 1794: Matthew Brandon is Admir. of Josephus Bromhead as the widow relinquished.

Aug. 5 1794: Esqr. Matthew Brandon is made Admir. of Allen Rice, (whose widow relinquished) gives bond of 100 with Alexr. Lock as bail.

Nov. 4 1790: "The Last Will and Testament of Richd Brandon proved Court by the Oath of William Cathey. Ordered that Letters Testamentary thereon issue to John Brandon & Matthew Brandon Executors who qualified". N.C. Records Vol. 9 pages 623 & 624. The only mention of Richard Brandon is about 1773 when he with many others of this section signs petition for better marriage arrangements.

Lease & release from John Knox to Robert Caldwell for 307 acres dated Jan. 13 1768 proved by Samuel Young.

The will of Richard Brandon (Book C page 14) made while 'in sick and low condition of body' on April 16 1790. Sons: Mathew (240 acres where I now live, the personal things, crop &c & a negro named Andy), and John. Daughters Mary, Elizabeth & Altis. Grandson Richard Alexander. Exrs: sons John & Mathew. Witnesses: Will Cathey, John Johnston & Marton(?) Marlin.

Hu. Blakemore Myers of Shelbyville Tenn. # 13391 & Paul Barringer Myers # 13392 join (page 952) as sons of Thomas Rawlings & Anne Eliza Wadsworth (Blakemore) Myers, (finished below).

In Tenn. BENJAMIN BRANDON.

"Benjamin Brandon, who married Mary (or Polly)Knox, as recorded in the beginning of this chapter, was born in Rowan county, N.C., in 1759. His father was James Brandon, whose will is found on record in Salisbury, N.C. We give a copy of this old will, as obtained from the clerk of court, thinking it may be of special interest to the Brandon descendants. From this old will we have tried to locate the homestead of this family of Brandons, and conclude that the lands lay just north from Third Creek Church, and the mill property mentioned was that now known as Baker's Mill.

Dr. Rumble, in his valuable history of Rowan, makes mention of several Brandon families, but seems to have had very little knowledge of this family. Thought he does mention Brandons on Fourth Creek, which may have been this family.

Benjamin Brandon's house was burned in the early days, and the Bible record lost, which makes it impossible to get all the dates.

Benjamin Brandon was a soldier in the Revolutionary War; enlisted when a youth of eighteen years. We give below a copy of the record obtained from the Bureau of Pensions at Washington.

This Mr. Judah is a grandson of Armstrong Brandon (brother to Benjamin.)

Mr. John Nicholson, of Polo, Ohio, says he had heard his grandmother, who was Polly Brandon, relate the circumstance of John Knox using his bridle in place of clevis pin, when pursued by the British, and of his grandfather, Benjamin Brandon, being wounded in the knee hiding in the bushes and letting the Tories and British pass him by unnoticed.

This John Knox was Polly Brandon's father, son of John Knox, emigrant.

The clerk of court in Rowan county, N.C., finds in Will Book "B," page 49, the will of James Brandon, which is given below.

COPY OF WILL.

June 17, 1790.

In the name of God Amen. I, James Brandon, of Rowan county, in the State of North Carolina, being very sick and weak of Body, but of perfect mind and memory, thanks be given unto God and calling to mind the mortality of my Body, and that it is appointed for men to die, Do make this my last will and testament and principally and first of all I give

and Recommend my soul into the hands of God that gave it, hoping through the Death, merits and Entercesion of my Lord and Saviour Jeses Christ to have a full and free pardon and forgiveness of all my sins and to Inherit everlasting life, and my Body I commit to the earth to be buried in a decent Christian burial at the discretion of my Executors hereafter named, nothing doubting but to Receive the same again at the General Resurrection by the mighty power of God. And as touching such worldly Estate wherewith it has pleased God to bless me with in this life, I give Demise, Bequeath and Dispose of in the following manner and form (Viz.) It is my will and pleasure that all those just debts and Duties as I do owe to any manner of person or persons whomsoever either in Law or Equity be first paid in some Convenient time after my decease by my Executors hereafter named.

Itim. I give, demise and Bequeath unto my Beloved son William Brandon that tract of land whereon he now lives, Beginning at the mouth of the spring branch on the North Side of Fourth Creek, and running up said branch to the head thereof thence a west course to the boundary line of said Tract, thence the course is of the original Deed to the Mill Dam, thence down the course is of the dam and Creek to the Beginning. Including the grist mill with one third part of the saw mill only, and my Negroe Wench Florah and her child called Yank, and to his heirs and assigns forever.

Itim. I give, demise and bequeath unto my Loving son Benjamin Brandon Two Hundred & fifty Acres of my Land on the north side of fourth Creek, Including the Improvements where he now lives, Beginning at the Original Beginning corner on the North Bank of fourth Creek, and so round according to the course is for compliment and my Negroe fellow called Paul and one-third part of the Saw Mill to his heirs and assigns forever.

Itim. I give, demise and Bequeath unto my Loving son John Brandon all the Remainder of my Land on the north side of fourth Creek Lying betwixt William's & Benjamin's parts aforesaid, and my Negroe fellow Harry, and to his heirs and assigns forever, and one third part of the Saw Mill.

Itim. I give and bequeath unto my Daughter Jane Wilson my Negroe wench Hannah and all and singular her sisters apparel and bed and bed clothes and the Sheep called Mary's, and to her assigns and heirs forever.

Itim. I give and bequeath and Demise unto my Loving son Abel Brandon one half of the plantation I live on on the south side of fourth Creek, both in Quality and Quantity, and my Negroe Wench called Kate and my Dun Colt, and to his heirs and assigns forever.

Itim. I give, Bequeath and demise unto my loving son Armstrong Brandon the Remainder of my plantation whereon I now live on the south side of fourth Creek, and my Negroe wench Dinah the half of my Sheep and my Dun filly, and to his heirs and assigns forever.

Itim. I give and bequeath to my well beloved Wife Rebeccha her dower of and in all my Land on the south side of fourth Creek demised as aforesaid to my two sons Abel & Armstrong, together with all and singular my household furniture and use of my mention house, my sorrel mare, five milk cows, the one-half of the sheep and my roand Coult, and to her heirs and assigns forever.

Lastly, the remainder and Residue of my Estate, both real and personal, I Give and Bequeath to my two youngest sons (viz.) Abel and Armstrong, share and share alike to them and their heirs and assigns forever.

Lastly, I name, ordain, Constitute and appoint Abel Armstrong and my son Benjamin Brandon Executors of this my last Will and testament, hereby revoking and disannulling all former and other wills, Testaments, Bequests, demise and Executors by me in any manner of ways before this time Named, Willed, Bequeathed, Demised or appointed, Ratifying and confirming this and no other to be my last will and Testament.

Mr. Watson also finds that James Brandon was a member of the Committee of Public safety during the Colonial days. The following is his certificate.

ROWAN COUNTY, N.C.

I, W.G.Watson, Clerk Superior Court, certify that it appears from copies of Colonial Records of North Carolina, filed in that office, that James Brandon, in the year 1775, was a member of and at one time clerk of the Safety Committee of Rowan county. It also appears from said Colonial Records that James Brandon was, in August, 1775, appointed second major of Rowan Minute Men by the Provincial Congress at Hillsborough, N.C.

It is not known with certainty the maiden name of James Brandon's wife. In the will she is called Rebecca. It is thought by the Brandon descendants that she was an Armstrong. Abel Brandon, we learn, married a Miss Jeanette Knox at Knoxville, Tenn., about 1794. We cannot say what relation she was to Polly (or Mary) Knox, Benjamin Brandon's wife, and cannot place her on our Knox Tree. Some think she may have belonged to our Joseph branch, though not sure that she was.

Armstrong Brandon, born about 1778; married in Piqua, Ohio, Eliza McCorkle, daughter of Joseph McCorkle, who had emigrated to Ohio from Rowan county, N.C., and who was closely related to Rev. Samuel E. McCorkle, one of the early pastors of Thyatira Church. Famous as a teacher and preacher. Armstrong Brandon was named for Capt. Armstrong, who was killed at the battle of Ramsour's Mills. He removed to Corydon, Ind., in 1816; there he was State printer, editor of the Indiana Gazette, and U.S.P.M.

The three Brandon brothers, Benjamin, Abel and Armstrong, settled in Miami county, Ohio, about 1808. It seems that John Brandon died in North Carolina in 1806. (See on Absalom Knox branch.) Of William Brandon we can learn nothing except that he was a witness to John Brandon's will, so must have lived after John's death. Some of the Abel Brandon family have it by tradition that one of the sons of James Brandon was killed in battle in the Revolutionary War, and that his horse came home a distance of seventeen miles without his rider, and that his friends went to the field of battle and found his corpse. If such was the case, we do not know his name. It would not, of course, be mentioned in the will, as that was made years after the war. Judging from the location of the James Brandon farm on Fourth Creek, it must have been one of the engagements when Cornwallis invaded Rowan county. Cowan's Ford, or Torrence's Cross Roads.

We know nothing of the daughter, Jane Wilson, mentioned in the James Brandon will."



"Benjamin Brandon is appointed Guardian of of Armstrong Brandon Minor Orphan of James Brandon deceased, who gave bond with Henry Hughey his Security in the sum of 500".



In Sanders N.C. Records (Vol 22 page 822) Thomas Bashford supplies food for the Cherokees in 1757-8

Deeds: James Brandon to William Armstrong for 458 acres March 13 1764, also another for 301 acres on March 31 1762-- both proved by James Armstrong. Deed from James Brandon & wife to William Armstrong for 320 acres April 6 1768 proved by Abel Armstrong.

On Aug. 6 1777 when the county was divided into districts, Major James Brandon, Hugh Jenkins & Alexr. Dobbins were in Capt. George Cowan's district of which Esquire Griffith Rutherford was the Justice & Joseph Cowan the Constable. Esquire James Brandon was the Justice was the Justice for Capt. William Armstrong's district, in which John Luckey was the Constable, Thomas Gillespie Sr. Henry Hughey & Samuel Young were the Sessors. Esquire James Brandon is made Entry Taker on Feb. 3 1778, & James Brandon Jr. is made a Justice of the Peace, (also James Brandon Sr.).

The districts in Feb. 6 1778: Esquire James Brandon is in the districts of Captains Armstrong & Wilson, while James Brandon Jr. Esquire is in Capt. Cowan's district as Justices of the Peace.

I judge by this that Esquire James Brandon Sr. (Entry Taker) is in Capt. Wm. Armstrong's District, while Major James Brandon--the Jr. Esqr.-- is in Capt. Capt. George Cowan's District, in 1778.

Aug. 9 1781: James Brandon Sr. remains in Capt. Armstrong's district and it is now Col. James Brandon in Capt. Bell's companies who are the Justices (still in Loyal District). Also there seems to be a Col. James Brandon in Captain Cowan's Co. in Newington District who is a Justice-- possibly these companies dovetail? (I think Newington District is over toward Mooresville).

May 10 1782: the Justices= Col. Brandon in Bell's Co. & James Brandon Sr. in Cowin's Co. (think Moses Winsley has the company that Col. James Brandon had in Newington District).

May 9 1783: the Justices are James Brandon Sr. in Capt Cowen's Co. & James Brandon Jr. in Capt. Todd's Co.

May 5 1784: No James Brandon as Justice is given. Col. James Brandon is made guardian of Thomas Miller's orphan Martha Miller on Aug. 3 1784, so he is still in Rowan. & on Nov. 5 1784 he is made guardian of James & Agness Miller, also orphans of Thomas Miller, and on Nov. 6 1784 he is to take Taxable List in Capt. Cowin's Co.

May 4 1785: Col. James Brandon & James Brandon Sr. are present at Court as Justices.

May 6 1785: James Brandon (miller) is appointed Justice in Capt. Armstrong's Co. & Col. James Brandon in Capt. W. Bell's Co.

May 5 1786: Esqr. James Brandon is appointed guardian of Saml. Kerr.

" 6 " 1786: Col. James Brandon is appointed Justice in companies of Bell & Armstrong, so possibly James Brandon the miller is worrying over his books?

Nov. 10 1787: Col. James Brandon is appointed Justice in companies of Captains Bell & Graham.

May 10 1788: Col James Brandon is appointed Justice in Capt. Bell's Co. & James Brandon in Capt. Cowin's Co.

Col. James Brandon goes on 2000 pound bond for James Craige and the widow Milly Cotton when they qualify as Admrs. of Cyrus Cotton May 9 1787.

Book 16 page 513: On April 17 1798, John Brandon lets William Brandon have 246 acres on the north side of Fourth Creek, beginning at south side next Benjamin Brandon's, next bank on Rutherford's Creek, --Benton & said Brandon & his spring branch, for 250 pounds witnessed by Benjamin Brandon & John Ervin & proved by John Brandon in Feb. term of 1799. (No wife signs). This is part of 514 acres granted to James Brandon on April 28 1760 & he gave this 246 acres to his son the said John Brandon on June 22 1790--see Book #12 page 182.

Gertrude L. Irwin, Librarian of Schmidlapp Free School, Piqua, Ohio., wants everything about the Rev. soldier, James Brandon, who married Rebecca Armstrong & had sons Abel & Benjamin. Private, enlisted April 15 1776 in 6th Regiment, & served 3 yrs. Wants dates. Brandon.

Tuesday Aug. 3 1790. "The last Will & Testament of James Brandon decd. proved in open Court by the Oaths of Samuel Young and Henry Hughey, Letters Testamentary granted to Abel Armstrong and Benjamin Brandon Executors who qualified" "Abel Brandon, Orphan of James Brandon deceased being of lawful age, came into court and did choose his Guardian, viz John Brandon who with William Brandon his Security entered into bond in 500,,0," "Benjamin Brandon is appointed Guardian of of Armstrong Brandon Minor Orphan of James Brandon deceased, who gave bond with Henry Hughey his Security in the sum of 500".

I presume that this is the will of the above James Brandon; made June 17 1790 & in Book B page 49 of Rowan Co. N.C. Sick & weak, Wife Rebecca. Sons: William ( land at mouth of spring branch on N. side of Fourth Creek to mill Dam, down Creek, including grist & saw mill only &), Benjamin ( land on N. side of Fourth Creek at Original corner on N. bank of creek & 1/3 of saw mill &), John ( remainder of land on N. side of Fourth creek between William & Benjamins' parts & 1/3 of saw mill), Abel (1/2 plantation on S. side of Fourth Creek where I live &c), & Armstrong (the remainder of plantation where I now live on S. side of Fourth Creek &c). Daughters: Jane Wilson. Exrs: Abel Armstrong & son Benjamin Brandon. Witnesses: Isaac Hughey, Henry Hughey & Samuel Young.

Miss Hattie S. Goodman in the Knox Family, says James Brandon's son, Benjamin Brandon was born in Rowan in 1759 in Rowan Co. & married on Feb. 6 1790 to Mary Knox, the daughter of John & Hannah (Reid) Knox & the grand daughter of the immigrants: John & Jean (Gracy) Knox. She was probably born in the early 1760's and they moved to Tenn in 1804 then to Miami Co. Ohio in 1808 where she died about 1850 very aged. She was a pensioner after the death of her husband, Benjamin Brandon (died May 5 1837 in Ohio) he having served as a private in Rev. & was in battles of Ramsour's mill, Cowpens, Cowen's Ford & Torrence's Cross Roads.

Miss Goodman thinks that Baker's mill north of Third Creek may have been owned by James Brandon. Also that he may have first married an Armstrong. — Some of Abel Brandon's family claim that one son of James was killed in the Rev. and that his horse came home-- 17 miles-- without him so that his friends went to the battleground & found his body.

Miss Goodman knows nothing of the daughter, Jane Wilson.

Mr. Samuel B. Judah, of Vincennes Ind. is a grandson of Armstrong Brandon, son of James Brandon, whose will is given above.

Mr. John Nicholson, of Pole, Ohio, is quoted as remembering his grandmother-- Polly (Knox) Brandon, tell of her father (John, son of John & Jean (Gracey) Knox) using his bridle instead of a clevis pin when pursued by the British, & that Benjamin Brandon ( Mr. Nicholson's grandfather) being wounded in the knee, hid in the bushes until the British & Tories passed by.

Presume that the above James Brandon is the one, who with James Armstrong, gets 640 acres of land from Patrick Campbell & wife on April 12-13 1762 which is proved by William Armstrong. Also the one whose mill owned with James Armstrong is made a publick wrist mill on 2d Tuesday of April 1763.

(Major Jno Brandon is on jury for next term. Aug. 9 1782. & is to collect taxes in his company--appointed Aug. 10 1782).

May 9 1782: "Ordered that the Sheriff notify Colo James Brandon to appear Tomorrow in Court with his Books of Office in order to Account with this Court relative to his Conduct as Entry Taker".

Feb. 8 1792: "James Brandon Esq came into court and resigned his Office of Entry Taker for said County." (So he couldn't have been the Major).

James Cathey & wife Ann of Anson Co., on Feb. 23 1753 let William Brandon of same county, have for 5 shillings 640 acres on forks of Sill's Creek Witnessed by John Brandon Sr., Alexander Cathey & John Brandon. (Book 1 page 42) The price on Feb. 24 1753, is 50 pounds.

In July 1767 "Orderd that Ann Bashford have Letters of admn. of all and Singular the Estate of Thomas Bashford deced Securities John Brandon & John Frohock.-- Quallified, according to Law &c" (see page 712 of Inferior Court minutes).

On the 2d Tuesday in Oct. 1767: "An inventory of the Estate of the Sale Thomas Bashford Returnd in Open Court by the Admx. amounting to the Sum of £20,,13,,"

Book 4 page 71 in Registrar's Office, (tells on Feb. 21 1759) that Thomas Bashford, an Innholder, married Anne Brandon who had two infants James & John Brandon. He became administrator but lost money in his business and to secure the property of these children is selling property.

Deeds of sale from Jas. Carter & Hugh Foster to Thomas Bashford & Robert Gillespie for 144 sq. poles in Salisbury ("?"), same amount in # 11 & in # 12 acknowledged on April 22 1758.

Book 12 page 521: On May 30 1791, James Brandon (no wife signs) lets Samuel Young have 320 acres on the south fork of Sills Creek next George Gillespie, "at the edge of the Swamp Just by the meeting house spring thence South along William Bowmans & part of Millers line", for 280 pounds, witnessed by Daniel Matheson & Henry Hughey & proved by Henry Hughey in Nov. term of 1791. From "Mary Tudor Queen of France by Mary Croom Brown. 1911.

Mary Tudor, second daughter of Henry VII. of England, was born March 18 1495 (from Queen Elizabeth of York's Psalter in Library of Exeter College, Oxford). Henry refused a marriage for his daughter to the Duke of Milan because she was only three years old in 1499. (The change of Calendar must be recalled).

The Flemish Council said Charles of Castille, who was five years younger than Mary in 1514, gibe<sup>d</sup> about her age (then given as 16 when really 19,) that he "wanted a wife not a mother"; betrothed Dec. 16 1503.

Elizabeth of York-- daughter of Edward IV. was rescued from her uncle Richard III to be thrust into the arms of Henry of Richmond whose mother Lady Margaret assumed authority and may have hectored her. She was beloved by the English and Henry was not. He thought his mother the queenliest of women and she was a despot.

Henry died April 21 1509 his wife had died Feb. 11 1503, while her grandmother died within a year of Henry.

Henry VIII held in check by his father-in-law for three years, but courtlife grew lax. Mary was given a teacher who would prepare her for the coming marriage, but little was required save French, as she had learned to sing, play the flute and dance. Her nursery days were spent at Eltham under Mistress Elizabeth Denton. At two years, she was dressed in velvets and silks as if a woman of twenty. On April 8 1497, she is described as playing in black velvet and tinsel stiffened with buckram.

Betrothed to Louis XII of France on Aug. 7 (having renounced the marriage with Charles of Castille on July 30) & wedded Two days later. Proxy Mary Tudor was in love with Charles Brandon and disliked the idea of becoming the wife of an "old, feeble, and pocky" man of fifty six, even if he were King of France. But her trousseau was so beautiful, and the fetes so wonderful, that she soon became reconciled by his gifts and the knowledge that he couldn't live very long. The marriage was solemnized at Church of Celestines, Paris on Sept. 14 with the Earl of Worcester as Mary's proctor. The King bound himself to the payment of a million gold ducats to Henry VIII. and was to be excommunicated in default. (His first wife, Jeanne, had been forcibly married to him by her father Louis XI. and is said to have been a crippled angel. She was divorced as soon as he attained the throne and married Anne of Brittany, who was the widow of his cousin and predecessor, Charles VIII. They had two daughters.)

Louis was obsessed with love for his new wife and beside himself to see her, but she was reluctant to cross the Channel. However, on Sept 19. 1514 they set out for Dover in great splendor-- 100 carriages for the women and 1000 palfreys-----

Charles, Duke of Suffolk, was far from being inexperienced in love affairs. As Charles Brandon, made a contract of marriage with a gentle woman--Mistress Anne Browne--but broke it off although they had a daughter who later married Lord Powes-- and married Lady Mortimer. The former brought forth her contract of marriage and Lady Mortimer was divorced. Married Solemnly to Anne in presence of all of the nobility and had another daughter-- she became the wife of Lord Mounteagle. Anne lived and died his wife. (The English were very loose about marriage.)

In November following the marriage, a joust was held in France and the Duke of Suffolk was among those who went over for it, and was in great haste to get out of England for fear of being recalled. Mary had great self control and everything went off well, but she was in an embarrassing position. Her husband was infatuated as was the Dauphin, and her lover present. Louis disliked the Dauphin and seemed to like Suffolk, who remained until the second week in Dec. His health had been shattered and the change from regular hours to fetes and excitement kept him in bed mostly. Mary was most circumspect in her attentions to her husband who was in a hopeless condition and kindly passed out with the end of 1514, but she had arranged with Suffolk for the contingencies. She soon learned that other marriages were being arranged, while the new King of France had become annoying in his daily attendance. Henry VIII. probably was willing that she marry Suffolk, but she was upset with the silence and intrigues and against the promises exacted from both, demanded the instantaneous settlement of the affair. On Feb. 9 1514 she signed away her plate of gold and the choice of jewels given her as Queen of France, and was secretly married to Suffolk, whose wife had departed. The date is uncertain, but was probably in Feb. Even the place and priest are not known. This not being sufficiently lawful, they were remarried in England May 13 at Greenwich.

F.L. on the Nigh Shoulder" April 16 1755.

Brandon Family Has High Place In History (by Laud C. Matthews): "if, like Edward Waverly, a younger generation should yawn over the dry deductions of their line of ancestry, it also may be that, like that imagination and fastidious youth, they may find miments when such knowledge may interest their fancy and regard their attentions. The Brandon family came from England where for centuries the name played a conspicuous part in public affairs, as every reader of English history known. It was Charles Brandon, Duke of Suffolk, who married Mary, sister of Henry VIII. after the death of her first husband, Louis XII. of France.

"Charles Brandon carried the silver wand of Anne Boleyn at the coronation procession and this same Duke of Suffolk rode into the banquet-hall on horseback escorting the Knights of the Bath, who brought 27 dishes for the newly crowned queen while from behind a screen, King Henry looked on delighted.

"By the will of Henry VIII., after his three children, Mary Tudor, Edward and Elizabeth, the heirs to his throne were to be the descendants of his sister Mary (whom he had compelled to marry Louis XII. of France) and her lover husband, Charles Brandon. Lady Jane Grey was granddaughter to this marriage.

"About the year 1750, John Brandon (widower), the father and sons, Richard and a younger brother named William, came from England.

Wedded Mrs.Locke.

"John Brandon married Mrs. Elizabeth Locke (who with her sons & daughters, and his sons & daughters, came over on the boat from England). The Lockes and Brandons were all buried in Old St. John's & Thyatira Church yards in Rowan County, "orth Carolina, not far distant from the old Brandon homesite, "Brandon Acres".

"In 1752, John Brandon obtained a grant of land of 630 acres from Earl Granville upon the waters of Grant's Creek. In the same year, the son, Richard Brandon, obtained a grant of 480 acres upon the same creek and William purchased 1,000 acres near "Sills Creek". John Brandon was one of the Justices who presided over Rowan Co. Court in the year 1753, along with Walter Carruth, Alexander Osborne, John Brevard and others. He was a man of prominence in his neighborhood and county, a member of the Presbyterian Church and a large land owner-owning thousands of acres of the poplar lands lying on both sides of the public road leading from the Yadkin River to the Irish Settlement. From a deed dated 1753 we learn that John Brandon's wife was named Mrs. Elizabeth Locke. John Brandon's son, Richard B., married her daughter, his step sister. (She was sister of Gen. Matthew Locke, who married his Step sister Elizabeth Brandon--

Cash to Davidson

Col. Alexander Brandon, a Kinsman, left in his will \$400.00 for the upkeep of the old Thyatira Church yard and \$3,000.00 to Davidson College for the education of students for the ministry--

The Brandons were conspicuous in the Revolutionary War in the fights of Ramseaur's Mill, Charlotte, King's Mountain and Cowpens--Matthew Brandon was one of the small party when the brave lieutenant George Locke, his kinsman, was cut down by the British in the retreat from Charlotte, September 26, 1780. He was also at King's Mountain when his cousin, Captain John Brandon led the mounted charge and broke the Tory ranks--

We should not take pride in our grand sires alone, but in our grand mothers also, whose blood flows equally in our veins, and to whom we owe many traits of inheritance. Doubtless the descendants of Matthew Brandon and Jean Armstrong owe their courage and endurance to "Little Jean" as her gallant husband was wont to call his bonnie wee Scotch wife. While Matthew Brandon was at King's Mountain and elsewhere, fighting the British and Tories, a band of the latter raided the farm, drove off the best of the stock and carried away provisions. The brave wife stood helpless until they applied the torch to the dwelling which contained her aged parents.

Risked Her Life.

Then she rushed in at the risk of her own life, extinguished the flames and shamed the ruffians until they shrank away. It was the niece of Matthew Brandon, "Betsy", who gave General (then President) Washington his breakfast when on his Southern tour in 1791. The family had gone to a great parade in Salisbury, but for some reason the little maid had been left at home. Early that morning General Washington rode up and asked for a light breakfast- The little girl, nothing daunted by the great soldier, began to prepare the meal, when the General told her he would reward her by showing her General Washington before the others would see him--and then revealed his identity much to the surprise and pleasure of the astonished child.

John Brandon of Grant's Creek, had three sons:-John, Richard and William. Richard married Margaret Lock (his step sister and sister of General Matthew Locke--a member of the Provincial Congress of North Carolina and who assisted in the construction of our first State Constitution 1776). The children of Richard Brandon and Margaret Locke were John, Matthew and Elizabeth.

Matthew Brandon married Jean Armstrong, daughter of Thomas Armstrong and his wife Lily(?). The Armstrongs were pure Scotch. They were a brave, patriotic family, and several of the connections held offices in the Revolutionary Army..

Captain Thomas Armstrong was killed in the Battle of Ramseur's Mill when six other captains fell, and their bodies sleep under a brick monument which stands near the

public road.

Had Five Daughters.

Matthew Brandon and Jean Armstrong had five daughters whom the historians called "Accomplished Women": Elvira married Rev. James Hall; Alise married Samuel McCombs, grandmother of Mrs. Richard Moore of Charlotte; Margaret married George Miller (Salisbury), great-great-grandmother of Mrs. Walter Toy, of Chapel Hill; Elizabeth married General Paul Barringer, grandmother of Mrs. Lydia Brevard Harris Craig, of Charlotte and Atlanta; Mary married William P. Smith, great-great-grandmother to Maud Carson Cumming of William Carson Cumming. Matthew Brandon was born 1752, died 1819. Jean was born 1755, died 1819."



John Brandon died in 1822 and left a widow, wife Anna, and a son, John Brandon, Jr., who inherited the land. In 1830, John Brandon, Jr., sold 180 acres of land to Benjamin Karpatrik, his son-in-law. The land was located on the creek bank in the neighborhood of the deceased John Brandon's home. The land was later sold to James Brandon, another son of John Brandon, who had moved to Tennessee.

The will of John Brandon (Book 2 page 3) made April 18, 1816, provided for his wife Anna, her brother John Knox & his brother, Benjamin Karpatrik, William Knox & his wife Anna (Book 2 page 298). The will of John Brandon, Sr., provided for his wife Anna, his son John Brandon, Jr., and his son Benjamin Brandon. John Brandon, Jr., died before his father, leaving behind a widow, Anna, and two sons, John and Benjamin.

(This is part of a State Grant to James Brandon, who willed this to his son, William Brandon, who let John Brandon have it).

Book 8 page 320: On April 6 1768, James Brandon & wife Elizabeth, let William Armstrong (all of Rowan Co.N.C.) have 320 acres on south side of Fourth Creek next the grist-mill which it may include, next Samuel Young, for 5 shillings-- being 1/2 of the tract of 640 acres which Earl Granville let William Grant Jr. have on April 26 1756, who sold it to Patrick Camble on July 15 1756, he & wife Ellinor let James Brandon & James Armstrong have it by release & release on April 12-13 1762--witnessed by Samuel Neisbett & Abel Armstrong & proved by the latter. The release price on next day is 100 pounds, proved in May 1775

In the minute Book of Rowan Co. N.C., A lease and Release from James Cathey to WM. Branden is given in the third court, probably.

In the third or fourth court he proves a lease and release from Jno. Lynn Esq. to the Congregation of "that Society called Desenters to the Lower Sett".

John Brandon examines Robert Reed's wife, Agness, concerning concerning her right of dower to a lease and release from Robert & Samuel Reed and she quits all claim to it. Probably in the fifth court of Rowan.

A lease and release from John Branden Sr. to James Lynn is acknowledged by Jno. Branden.

(Dr. Rumble says that John Branden lived six miles south of Salisbury on the Concord Road).

The commission meets at John Branden Esq. house on the last Tuesday in July. Richard Branden is on the grand jury. Wm. and Jno. Branden are fined 30 shillings for non-appearance as petit jurors. Wm. Branden wants to make a public mill.

Richard Branden is to give evidence in 1756 on The King vs John Enoch & Cornelius Andersen, in which the Defendant is guilty of killing the hog.

Richard Branden dead 1755, and his wife is Ann.

John Branden presents venire ticket in 1767

W William Branden is dead and Thomas Galispie and William Lucky are to lay off the plantation for son James Branden in 1761. It has a mill on it.

George Branden a planter and wife Mary get a separation, Aug 2 1788 and make Burgess Gaither their trustee. Burgess for 5 shillings seems to get much property from them at the same time, live cattle, household stuff and 300 acres of land on Main Hunting Creek where Capt. John Graham formerly lived. The deed is signed by all three of these persons and witnessed by John Branden and others in May session 1789. Book 11 page 646.

Will of John Branden (Book H page 386) Feb. 18 1827 probated May 1827. Wife: Sarah; Ex. Arthur Morrow; Test: Samuel Little and Abraham Branden. Esther Brandon (Book H page 142) June 4 1816 probated Feb. 1822. Daughters: Peggy, Clarissa, Sophia, Polly Hampton, Betsy Gibson and Precilla Gibson. Ex. friend William Gibson. Test J.L. The Gibson graveyard on the Lincolnton road behind the home where the beautiful hedges are on right side of road. Since they are members of the family and have investigated Dr. Rumple's sketch is wrong (page 286).

The will of one William Brandon is mentioned in the Minutes of Superior Court of 1797.

In the Minute Book 1753-1767 it says that Ann Brandon, the widow of William Brandon, is now the wife of Thomas Bashford (1758). Thomas Bashford of Rowan Co., supplies the Cherokees with food in 1757-8 see page 822 of N.C. Records by Sanders-Clark, Vol. 22

Martin Phifer supplies the Indians Vol 22 page 819.

William Brandon of Anson Co. N.C. died in Rowan Co. N.C. in 1755. He lived at Catheys Meeting House--now Thyatira--as a planter. His land was indentured by Earl Granville March 25 1752 in XXVth year of King George II.

John Kincaid Sr. was born in the North of Ireland in 1710, emigrated to America in 1750, lived first in Tryon Co. N.C. moved to Burke Co. N.C. in 1792, died at his home six miles northeast of Morganton at age of 101--he was twice hanged by the Tories but cut down. His three sons served in the Revolution. See History of the Kincaid Family by James Murphy Kincaid.

James Cathey lived in Anson Co. N.C. was a Justice of the Peace in that county in 1749--see Colonial Records Vol. 3 page 951.



Charles Brandon

"Male Mari Quam Fedrai"; I would rather die than be debased  
Sir William Brandon a vigorous man for his age with few equals in sword play was killed in a duel in March by Adam Judson a Scotchman called "Walking Death" who claimed to have killed 75 men in 87 duels, but as it appears through cheating. Sir William Brandon's sons John (the elder) & Charles who were just home from the continental wars having won considerable money, met up with Sir Adam Judson at an inn at Ipswich where the last named got their money by cheating while gambling, but they detected his method & on the second morning the duel resulted in Suffolk. The brothers had told their father that it was pending so he was present & when the sword of his son John bent double, and broke off at the hilt, the father stepped up & took his place followed by the same result although both were superiors of Judson. The younger son then stood up and when his sword should have killed it likewise bent showing that Judson was protected by a coat of mail & that the only way to win was by staying on defensive until Judson's strength should be spent, which he did finally did then sent his opponent's sword flying after which he cut him through the eyes & nose-bridge leaving him sightless & hideous for life in return for the horrible treatment of the other two. The matter ended & gave Charles much fame as a duelist.

As his uncle, Sir Thomas Brandon, was then Master of Horse for the King, he joined him in London & became quite a favorite. The King, Henry VIII. had a sister, Mary who was about 18 years of age (then visiting her elder sister, Margaret of Scotland, at Windsor) with whom this became particularly true. Both came to Greenwich for the jousts & there saw the newcomer Charles Brandon who had deep blue eyes, good skin, smooth face, long brown hair, good stature & pleasing manners. Mary was a beauty also with almost golden fluffy hair & large dark brown eyes, much magnetism & the Tudor temper. Their first meeting not altogether to his taste although she had already ready found her fate. Her grandmother, Elizabeth Woodville, was previously becoming wife of Edward

Maidens were married with their hair down so upon Aug. 13 1514 she became the wife of Louis de Valois (Louis XII, who was a debauched leper)

and four months later she again married with her hair down (token of virginity) her only love before her 1st husband was buried

Charles Brandon (When Knighthood Was in Flower, Edwin Casketed

King Henry VII, called the "Modern Solomon" by his daughter-in-law Queen Catherine  
was succeeded by Henry VIII in the spring of 1509

Hall's Chronicle says William Brandon (father of our hero) was killed by Richard III  
at Bosworth Field. "CHARLES BRANDON, ESQUIRE" is made knight, created Viscount Lisle,  
made duke of Suffolk, went to Paris for the jousts where he did valiantly, returned  
to England, sent to France for French queen, married her, died & is buried at Wyndesore.


