Book 14 page 108: Aug. 5 1795, John Carson--no wife signs--lets John Troy (both of Rowan Co.N.C.) have 212 acres on Crain Creek next said Carson & John Gardner, for 80 pounds, witnessed by Walt Graly & acknowledged in Aug. 1795. Book 9 page 55: July 1 1779, The State grants (#19 at 50 shillings the 100 acres) to John Carson 212 acres on Crane Creek next said Carson, Francis Gardner & John Gardner.

Aug. 6 1790: "Ordered that William Carson, pay thirteen pounds to Anne Vickers for her trouble in nursing and maintaining a base born child of which he is the reputed father for the first years of the child's age".

Aug. 7 1790: "25/. Paid by William Carson for Bastardy."

Aug. 4 1791: "On Motion, Ordered that William Carson take into his possession a base born child of which he is the reputed father, begot on Ann Vickers."

May 7 1792: "Ordered, that Mary Vickers a base born child, being two years & ten Months old be bound to Henry Carson as an Apprentice till she attain the age of eighteen years, the Master to comply with the Law in that case made."

Book 17 page 143: On Nov. 9 1799, William Vickers of Lincoln Co.N.C., Alexander Vickers, Ann Vickers & Henry Carson of Rowan Co.N.C. (as heirs of the deceased Thomas Vickers) let Anthony Newnan of Salisbury, N.C., have 210 acres on Crane Creek near Salisbury, next Joseph Hughes, Hugh Waddle, part of a tract bought by Anthony Newnan of Thomas Vickers on May 12 1792, John Gardner, John Dunn & Hugh Montgomery, for 160 pounds, witnessed by John Fullenwider (as to William Vickers) & George Dunn & proved in Feb. 1800. (This seems to be part of a patent to Thomas Vickers on July 11 1788).

Book 11 page 586: On Feb. 3 1789, Thomas Vickers & wife Alice, let Anthony Newnan of Salisbury, have 100 acres next the home & plantation of John Fogle, Joseph Hughes, Edgward Hill & Henry Horah, for 65 pounds, witnessed by Will Vickers & Hugh Carson & proved by the latter in Feb. 1789?. (This is on Crane Creek near Salisbury & was granted by The State to Thomas Vickers on July 11 1788).

Book 11 page 559: July 11 1788, The State grants (#1720 at 50 shillings the 100 acres) to Thomas Vickers 411 acres on Crane Creek next Joseph Hughes, Edward Hill, Henry Horah, John Gardner, John Dunn, Hugh Montgomery & Hugh Waddle.

Book 12 page 432: Aug. 6 1791, Michael Troy & wife Rachel of Rowan Co.N.C. (money paid to Michael Troy & wife Jane), let Isaac Teasdale of South Carolina have 72 sq. poles of the lower quarters of lots #2 & 10 in east square of Salisbury fronting on Corin St. 3 poles to corner of Freemason St. & along it 24 poles to Wake St. & along it 3 poles to beginning, for 200 pounds, witnessed by Benjamin Hodgens & John Troy & proved by the latter in Aug. 1792). (over)

Book 12 page 483: Oct. 8 1791, Hugh Carson--no wife signs--lets David Miller (both of Rowan Co.N.C.) have 1/2 lot #4 in west square of the town for 114 pounds, witnessed by John Patten & Whitmell Rylle & proved by latter in Nov. 1791. (Wm. Montgomery & wife Fortune sold it to Hugh Montgomery & his executors, sold it to Wm. Durphey in May 1784, being 6 poles fronting on Corin S t.next David Cowen & 12 poles back).

Feb. 4 1790: Deed from William Durphy to Hugh Carson for lot #2 in west square of Salisbury, Aug. 6 1789 is proved by Thomas Carson.

Feb. 4 1790: Deed from Hugh Carson to David Cowan for 1/2 lot. #2 in the west square of Salisbury Jan. 30 1790 proved by Henry Young.

Book 11 page 838: On Aug. 6 1789, William D'Urphey of Fairfield Co., South Carolina--no wife signs--lets Hugh Carson, a yeoman of Rowan Co.N.C., have lot #2 in the west square of Salisbury (144 sq. poles), for 200 pounds, witnessed by John & Thomas Carson & proved by the latter in Feb. 1790. (This had been bought from Will Montgomery & wife Fortune by Hugh Montgomery & he let Esq. David Nesbet of Salisbury & Esq. John Brown of Wilkes Co.N.C. have & they as executors of said Hugh Montgomery, let said D'Urphey have it on May 8 1784--refer to clause in deed from James Johnston to Casper Star on page 830).

Nov. 6 1784: Deed from David Nesbett & Jno.Brown to Wm.Durphy for lot #2 in west square of Salisbury May 8 1787 proved by Jno.Robley.

Book 2 page 385-6: On Aug. 12 1756, William Montgomery, an "Ordinary-keeper And Fortune his Wife" of Rowan Co.N.C., let Hugh Montgomery "late of Philadelphia in Pennsylvania" now of Rowan also, have lot #2 in west square of Salisbury, (144 sq. poles) fronting on Corbin St., for 10 pounds, witnessed by John Merrell, John Dunn, Jarad Irwine & Thomas Bashford & proved

Book 2 page 48: On May 31 1755, the Trustees of Salisbury town (Jas.Carter & Hugh Forster) let James Carson of Rowan Co.N.C., have lot #10 in the square (144 sq.poles?) for 20 shillings, witnessed by Abigail Foster & Thomas Carachan & acknowledged on May 31 1755 before James Hasell, Chief Justice.

Book 2 page 49: Another as above, being lot #9 in the west square.

Book 7 page 425: Dec. 30 1768, James Carson & wife Honnour of Rowan Co.N.C., let John Mitchell of Salisbury,N.C., have 36 sq. poles or 1/4 of lot #1 in the north square of Salisbury fronting 3 poles on Main St. & 12 poles back, next where said Mitchell now lives, for 30 pounds, witnessed by Andrew King & Marey McConnell & proved by the latter on Dec. 13 1772. (James Carter & Hugh Forster let said Carson have this on Nov. 23 1756).

Book 1 page 143: On Nov. 26 1753. (in the 17th year of the reign of King George II.) Earl Granville lets James Carson have 640 acres on the south side of the Yadkin River on the middle fork of Crain Creek next John Dunn & ---Brown's line, for witnessed by Wm. Churton & Jas. Carter & recorded on March 19 1754

March 19 or 22 1754: Deed of conveyance from "the Right Honble Earl of Granville Executed by Francis Corbin Esqr to James Carson Esqr by the Oath of James Carter Esqr Who Swore he Saw the deed Exon: Thereof"

Book 7 page 312: Nov. 20 1759, James Carson a Planter & wife Honour of Rowan Co.N.C., let their son, Thomas Carson, a yeoman, have out of Love & 10 shillings proclamation money, 320 acres on the north side of Grants Creek, witnessed by Andres King, & John Braly & proved in May 1771. (Earl Granville let said James Carson have this April 4 1761).

Book 8 page 29: On April 4 1761, Earl Granville (through his agent Thomas Child) lets James Carson of Rowan Co.N.C., have 320 acres on the north side of Grants Creek for 10 shillings, witnessed by John Frohock & W.Lucas & proved in Aug. 1772.

Aug. 6 1772: Deed from Earl Granville to James Carson for 320 acres April 4 1761 proved by a "Comparetur of hands. the Witnesses thereto Being Dead".

Book 4 page 317: On Oct. 22 1760, James Carson & wife Honour let John Biggs all of Rowan Co.N.C.--have 656 acres on both sides of Grants Creek below Alexander McCulloch & next John Whitsitt, for 5 shillings--the release price being 50 pounds on the next day--witnessed by Francis Beale & Will Reed & acknowledged in Oct. 1760. (Marked delivered to Jas. Carson).

N.C., have 656 acres on both sides Grants Creek below the line of Alexander McCulloch & beginning next John Whitsitt on the east side of the said Creek, for 10 shillings, witnessed by Thomas Jones & proved Jan., 30 1764.--Go to BBiggs from here

Book 4 page 479: July 22 1761, Esq Jas. Carter & Hugh Forster (as trustees of the township of Salisbury) let William Reed of have lots #4 & 5 (on Main Street) & 12 & 13 in the great south square of Salisbury, for 20 shillings & yearly rental of witnessed by Benjamin Milner & William Nassery & proved in July 1761.

Book 12 page 582: March 23 1792, James Bridges--no wife signs--lets Martin Phifer (both of Mecklenburg Co.N.C.) have the upper 72 sq. poles of lot #5 in the south square of the town, containing a dwelling house at west corner of it on Court & Temple streets, also 144 sq. poles of lot #13 in the south square of the town, for 113 pounds, witnessed by W.Alexander & Richard Trotter & proved by the latter in May 1792.

Book 11 page 315: On Sept. 19 1787, "John Carson (Eldest Son & heir of James Carson the Elder deceased) & Margrett his wife" of Rowan Co.N.C., let James Bridges, a "Millright" have lot #5 (144 sq. poles) in the south square of Salisbury, subject to payment of quit-rent however, for 120 pounds, witnessed by H.Horah & Wm. Hamton & acknowledged by John & wife in Feb. 1788.

Feb. 9 1788: Deed from Jno. Carson & wife to James Bridges for lot #5 in the south square of Salisbury on Sept. 19 1787, is acknowledged.

May 11 1792: Deed from James Bridges to Martin Fifer for 1/2 lot #5 in the south square of Salisbury, March 23 1792 proved by Richard Trotter.

Oct. 16 1763: Deed from James Carson to William Nassery for one lot in Salisbury, is acknowledged.

Book 3 page 537: On Nov. 23 1756, Esqs. Jas Carter & Hugh fforster (Trustees of the town) let James Carson, a "Tanner" of Rowan Co. N.C., have 1/2 of lot #1 in north square of Salisbury, for 20 shillings, witnessed by David Jones & acknowledged on April 21 1757. (The lots were 144 sq. poles each).

July 14 1763: Wm Nassery qualifies as Sheriff of Rowan--appointed April 23 '63. Hugh Horah, 3 poles fronting on Corbin St. & 12 poles back, for 10 pounds, witnessed by Jno. Lewis Beard & Jas. Craige & proved in Oct. 1763.

Book 6 page 187: On July 13 1765, James Carson, a planter, & wife Honour, let William Nassery have 1/4 of lot #1 in north square of Salisbury where Hugh Coyl formerly lived, fronting on Corbin St. 3 poles & back 12 poles, for 27 pounds & 10 shillings, witnessed by (J? F? or T?) Edwards & John Winn and acknowledged in July 1763.

Buried at Thyatira Presbyterian Church in Rowan Co. N.C.: John Biggs, born in Antrim Co. Ireland, died April 7 1763 in 64th year, leaving only one daughter, Honour, the wife of James Carson--beside him stands a very mutilated tombstone with "4 1774" remaining.

Oct. 24 1760: Lease & release from James Carson to John Biggs for 656 acres on Oct. 22-23 1760 is acknowledged. (over)

Oct. 22 1760: Deed of sale from Earl Granville to James Carson for 656 acres on Aug. 20 1759 is proved by William Churton.

May 6 1779: Deed from James Carson to Thomas Frohock for 328 acres Feb. 16 1776 is proved by John Braly.

Book 9 page 1: On Feb. 16 1776, James Carson, a "Tayler", lets Esq. Thomas Frohock have 328 acres on both sides of Grants Creek next John Whiteside & John Carson, for 250 pounds, witnessed by John Braly & Thomas Carson & proved by John Braly in May 1779. (This is 1/2 of a 656 acre tract which Earl Granville let James Carson Sr. have on Aug. 20 1759 & when he died he willed it to James Carson on April 12 1773).

Book 9 page 2: On Feb. 16 1776, John Carson lets Esq. Thomas Frohock have the other half of this property as above. (John is a planter).

May 6 1779: Deed from John Carson to Thomas Frohock for 328 acres Feb. 16 1776 proved by John Braly.

Book 13 page 988: On Jan. 1 1802, Alexander Frohock (no wife signs) lets John Kelly have 320 acres on Grants Creek & crossing it, for 800 pounds, part of 656 acres conveyed to the deceased Thomas Frohock by John & James Carson. No witnesses to this deed but it is acknowledged

Nov. 1 1774: The will of James Carson is proved by John Gardner. Letters testamentary are issued to "Honor Carson wife and Relict of James Carson" decd. and to John and Thomas Carson, The Executors nominated in said Will, and were Qualified according to Law".

May 6 1785: Deed from Thomas Carson to John Cochenour for 320 acres June 20? 1772 is acknowledged.

Deeds from James Carson & wife to their son Thomas for 320 acres to their son John 328 acres--both on Nov. 20 1769--proved by John Braley.

Book 7 page 311: On Nov. 20 1769, James Carson, a planter, & wife Honour, give to their son John Carson, a yeoman, acres on Grants Creek

Book 7 page 312: On Nov. 20 1769, James Carson, a planter, & wife Honour, give to their son Thomas, a yeoman, acres

JULY 22 1761: Deed of sale from James Carson to Henry McHenry for 688 acres on ---- is acknowledged.

Book 4 page 493: On July 22 1761, James Carson, a tanner, lets Henry McHenry, a tailor, have 688 acres on both sides of Third Creek next Samuel Reed, Henry Chambers & Richard King, for 100 pounds, witnessed by Robert Steele & Henry Chambers Jr. (James Carson got this on Feb. 27 1760).

Oct. 24 1760: Deed of sale from Earl Granville to James Carson for 560 acres on Aug. 6 1759 is proved by William Churton--also another for 688 acres on Feb. 27 1760 is proved by Wm. Churton.

Book 6 page 254: On July 11 1766, Luke Deane & wife "Hester" of ----through their attorney John Dunn, let James Carson, a "Tanner" have lot #5 in north west square Salisbury, for 20 pounds, witnessed by Geo. Magoune & John Braly & proved July 1766. (The trustees of town let Wm. Alexander have this by deed bargain sale & he let Luke Deane have it Sept. 11 1766. The preceding deed shows that Deane was a "Trader" & this lot of 144 sq. poles was on Corbin St. & that he paid Wm. Alexander 10 pounds for it.) (over)

Book 1. Thomas Carson.

The will of Thomas Carson of the town of Lexington, Davidson Co.N.C., made April 4 1804 while 'strong & healthy'. Book F page 47. Wife Deborah. Sons: John (111 acres in Guilford County which had been bequeathed said John by deceased Richard Sayers & had been sold with the consent of son John for \$333.00; also 1/2 of the profits from the store & some land bought from Adam Harmon & Peter Whitaker); Hugh (who must finish his education at the university of N.C.) & James (part of the store in Concord, Cabarrus Co.N.C.). Daughters: Hendicia Childress (whose husband still owes for a negro bought of him & William Bell as executors of Richard Sayers); Polly (land in Montgomery Co.N.C.), Sally & Jetzy. Exrs: son John & friend John Lewis Jeard. Witnesses: Samuel Dusenberry, James Orr & Samuel Davis.

Book 20 page 25; Feb. 5 1807, Lewis Beard, ^{1st} executor of deceased Col. Thomas Carson, who's John K. Carson (both of Rowan Co.N.C.) have 400 acres next Moses Lambert, David Capely, Jacob Lopp, for \$200.00, witnessed by F. Coupes & William Cox & acknowledged in Feb. 1807. (This is the subdivided tract granted to said Col-Carson & William Moore & afterwards sold as property of Robert Morris (See elsewhere)

Book 19 page 883: Feb. 19 1807, John Juis Sr.--no wife signs--lets Nicholas Michael (both of Rowan Co.N.C.) have 102 1/4 acres on Swearing Creek next --- McCulloch (now belonging to deceased Jacob Goss), Samuel Davis (now belonging to George Blaze), Samuel Dusenberry, Peter Whitaker, the town of Lexington, Richard Leach, Hugh McCrary & Joshua for \$450.00, witnessed by George Thomas & George Burgess & proved in May 1807. (This is part of the State Grant of Peter Whitaker Sr., who let Thomas Carson have it, he died & his executor, John K. Carson, let John Juis have it on April 25 1806.)

Book 19 page 847: Oct. 8 1803, Peter Whitaker Sr.--no wife signs--lets Esq. Thomas Carson (both of Rowan Co.N.C.) have 102 1/4 acres on Swearing Creek next --- McCulloch (now said Carson's). Samuel Davis, Samuel Dusenberry, Peter Whitaker Jr. in the town of Lexington next Richard Leach, Hugh McCrary & Joshua Whitaker, for \$409.00, witnessed by James Childress & James Orr & proved by the latter in Aug. 1806. (This is part of 159 acres granted by The State to said Peter Whitaker Sr. on Oct. 10 1783).

Book 9 page 508: Oct. 10 1783, The State grants (#472 at 50 shillings the 100 acres) to Peter Whitaker 159 acres on Swearing Creek next John Wilson, Patrick Coil, --- McCulloch, Joseph Whiteker & Hugh McCray.

Book 21 page 43: Feb. 19 1807, John K. Carson (as executor of deceased Thomas Carson) lets Alexander Caldeleugh--both of Rowan Co.N.C.--have lot #2 in the northwest square of Lexington upon which there is a stone house & a counting-room where said deceased kept his store, also a kitchen with a chimney in the middle & a smoke house, on Main street next lot #1; also lot #3 in same square (both being 144 sq. poles) for \$150.00, witnessed by ? & Andrew Caldeleugh & proved by the latter in Aug. 1807. (The former is part of 520 acres which belonged to Hugh McCrary who bequeathed to his daughter Ann, now the wife of Gabriel Davis, who with Jacob Huff & Susanna McCrary let Joseph Parke have July 7 1794, & part of 8672(?) acres granted by The State to David Evans by sale on Nov. 4 1784 who let Michael Jeard have Aug. 1 1789 who let said Jacob Huff, Gabriel Davis & Susanna McCrary have who let Joseph Parke & Myrick Davis let the deceased have on June 10 1801, while the latter is part of the land which Hugh Cunningham let Sarah & Boyd Wilson have Dec. 29 1800, who let Michael Jeard have Aug. 3 1801, who let said deceased have March 29 1804).

: Lease & release from Robt. Caven & wife to Robt. Carson for 363 acres Jan. 15 1762 proved by Wm. Neal. Book 5 page 439: On Jan. 15 1762, Robert Caven & wife Sarah, let Robert Carson (all of Rowan Co.N.C.) have 363 acres on the east side of the Catawba River on Norrids Creek & crossing it, for 15 shillings--the release price on same day being 7 pounds & 10 shillings--witnessed by Robert Thompson & William Neell & proved in Jan. 1764. (This is part of a tract granted to Samuel Caven on Feb. 21 1761, he died & Robert Caven & wife were heirs-at-law, according to the laws of the province). This begins at a white oak & goes south 210 poles to a hickory, south 80 degrees west 28 poles crossing Norrids Creek to a black oak, south 20 degrees west 70 poles to a pine, west 167 poles to a stake, north 277 poles to a red oak, due east 220 poles to the beginning.

July 24 1761: "Orderd P Cur that Robert Caven have Letters of all & Singular the Goods and Chattles of the Estate of his Brother Samuel Caven Deceas'd. having Given Bond and Securitie, according to Law, to wit, Francis Lock & John Hall, in the Pennal Sum of 60. Qualified, according to Law &c".

Book 4 page 421: Feb. 21 1761, Earl Granville lets the planter, Samuel Caven of Rowan Co.N.C. have 467 acres of vacant land on Northhead Creek on the east side of the Catawba River, going east 55 chains, south 85 chains, west 55 chains north 85 chains, for 10 shillings, with yearly rental of ^{witnessed by} W. Lucas & Wm. Matthews & proved by the latter on Feb. 21 1761. (Marked delivered to ? Caven.)

Book 5 page 17: Aug. 26 1762, Earl Granville lets Jacob Thomas of Rowan Co. N.C., have 529 acres vacant land on east side Catawba River next Richard Lewis on the lower end, for 10 shillings, witnessed by John Agar & John Frohock & proved in Oct. 1762.

Book 4 page 341: Jan. 22 1761 as William Carson & Jacob Thomas administered on the will of late deceased William Carson with bond of 50 pounds, they relinquish Robert Carson, James Dobbin & Thomas Bashford on conditions witnessed by John "cWhorter & Francis Beatey & proved in Jan. 1761.

The will of William Carson (book A page 49) made Oct. 10 1759 & probated in Oct. 1759. Wife . Daughter: Susana (under age to have the remainder). Brother Robert Carson. Cousin William Carson. Exrs: William Carson & Jacob Thomas. A codicil (if daughter Susana died the property to be divided among the children of my brother Robert. Witnesses: David Black & Samuel Cavan.

Oct. 19 1759: David Black proved the will of William Carson. "Orderd P.Cur that William Carson have Letters Testamentary of the Last Will of William Carson Deceas'd. Qualified"

Book 7 page 206: April 26 1769, David Black & wife Mary let John Henderson--all of Rowan Co.N.C.--have 212 1/2 acres on a branch of Norards Creek on the east side of the Catawba River, for 30 pounds, witnessed by Abraham Erwin & Robart Caven & proved in May 1770. (Part of an original tract deed on Aug. 7 1762).

Book 11 page 573: The State grants Andrew Niell for the heirs of deceased Robert Caven, 400 acres in Rowan Co.N.C. on Norards Creek next John Edmonds (about 1788?)

Book 21 page 102: Aug. 29 1805, James Childress of Rowan Co.N.C.--no wife--lets John Allen of Rowan Co.N.C., have lot #1 in the west square of Lexington, for \$300.00, witnessed by Jesse Hargrave & James Macay & acknowledged on Oct. 16 1807. (This is 8 acres or 800 sq. poles on Allots Creek opposite lot #1 in the southeast square, running on Main St. 2 poles from lot #1 in the southwest square &

Judeah Childress to Samuel Davis Jan. 9 1798 signed by Thomas Harper.



Committee of Inspection); grandson of Alvin Simpson and Nancy Caroline (Carson) Duvall; great-grandson of Andrew (and Temperance Young) Carson, (Captain of N.C. Militia); great-great-grandson of Thomas Young, (Commissary N.C. Partisan Troops); great-grandson of Alvin & Martha (Houston) Duvall; great-great-grandson of Christopher Houston, Captain of N.C. Rangers.

Page 189 of C.L. Hunter's Sketches of Western North Carolina, tells of Major William Gill, Capt. Andrew Carson & others of that portion of Iredell Co. which lies between Statesville & Yadkinville (county seat of Yadkin Co. N.C.): "In the year 1778, Thomas Young removed from Mecklenburg, Virginia, to North Carolina, and settled on Hunting Creek, within three miles of the place where the counties of Yadkin, Davie, and Iredell now form a common corner. He was then passed the age for military service, but had furnished three sons-in-law and two sons to the army of General Washington, and a third son, at sixteen years of age, to the army at Norfolk, Va."

"One of his sons-in-law, Major William Gill, entered the service at the beginning of the war, and became connected with the staff of General Washington. He served in the capacity of aid to the Commander-in-chief through the war, and was with him at the surrender of Cornwallis, at Yorktown. From this point he returned to his family, in Mecklenburg, Va., who had not heard from him in two years.

"Soon after the establishment of peace, Major Gill, with his family, and the other two sons-in-law of Mr. Young, viz: Major Daniel Wright and Dr. Thomas Moody, and his sons, William, Henry, and Thomas Young, removed to North Carolina and settled near him. Major Gill settled on Rocky Creek, near to the site of the present village of Olin, and, at his death, was interred in the family burying ground on the lands of his father-in-law. The record on his tombstone states that he died on the 4th of September, 1797, in the 47th year of his age. His commission is now in the possession of his descendants, in Iredell county. *****

"It has not been recorded in history that the mortal remains of a member of the staff of General Washington repose on the banks of Hunting Creek, in the county of Iredell, N.C. The tradition here given of the fact, can be yet fully attested by surviving members of the family of Major Gill, as well as by his commission.

"Captain Andrew Carson was a younger son-in-law of Mr. Young, having married after the family removed to North Carolina. He and his brother, Lindsay Carson, both joined the service in the southern army. And let it be recorded, in passing, that Lindsay Carson was the father of Christopher Houston Carson, now widely known as "Kit Carson," the great Indian scout, and that "Kit" was born on Hunting Creek, within half a mile of the residence of Mr. Thomas Young.

"Andrew Carson, like his nephew, "Kit", was of an adventurous disposition, and was the bearer of dispatches from the commanding officers in the up-country to those in South Carolina. This duty made him acquainted with the command of General Francis Marion, which suited his taste, and he connected himself with it. He was with the "Swamp Fox", so greatly dreaded by the British and the Tories, in many of his stealthy marches and daring surprises, the recital of which would send the blood careering through the veins of his juvenile listeners, half a century ago. ****

"Captain Carson was connected with the command of Baron DeKalb, at the battle of Camden, and was by the side of that noble officer when he was shot down while crossing a branch, and bore him out in his own arms. Captain Carson also sleeps in the same family cemetery with Major Gill.

"With a family thus engaged in the defence of their (fam)

"country, it will be readily understood that their parental home was no ordinary rendezvous for sympathisers in its vicinity. When Mr. Young settled in an almost unbroken forest on the banks of Hunting Creek, he located and constructed his improvements with the view of defence in cases of emergency. He built two substantial log houses, about forty feet apart, fronting each other, and closed the end openings with strong stockades. Port holes were provided to be used for observation, or otherwise, as occasion might demand. The buildings are yet standing, in a good state of preservation. This was head-quarters for the Whigs for many miles around. It was the point for receiving and distributing information, as well as for concerting measures for the aid of the cause of freedom, and for depositing supplies for friends in the field. The Brushy Mountains were but a few miles distant, and were infested with Tories, who made predatory incursions into this part of Iredell, carrying off stock, devastating farms, and ambuscading and shooting Whigs who were especially obnoxious to them.

"Mr. Young's fortifications presented a rallying point for defence against such invasions, as Fort Dobbs did four miles north of Statesville.

"He was himself a member of an association of eight neighbors, who were engaged in manufacturing powder in a rude way for the use of their home department. Against this association the Tories were extremely bitter, and conspired to kill them. They succeeded in murdering seven of them, and detailed one of their number to way-lay and shoot Mr. Young. The man assigned to this duty was named Aldrich, who concealed himself in the woods near the dwelling of his intended victim, and watched for an opportunity to perpetrate the murderous deed. The habitual circumspection of Mr. Young foiled him in his purpose until he was discovered by a member of the family, and became so frightened as to induce him to abandon the effort.

"After peace had been proclaimed, Captain Andrew Caldwell, who resided on Rocky Creek, and was the father of Judge David F. and Hon. Joseph P. Caldwell, and other sons well known in the public offices of Iredell, was appointed the Commissioner to administer the oath of allegiance in that part of the county. Aldrich presented himself among them, but the recollection of his seven murders, still fresh in the memory of all, so aroused the indignation of Captain Caldwell and Captain Andrew Carson, who was present, that instead of making him a loyal citizen of the United States, they went to work and forthwith hung him on one of the joists of the barn, in which they were transacting their lawful business" ****

N.C. Carolina Gardens (by E.T.H. Shaffer in 1839) page 240: The Carson family came from Ireland to America in 1770, moved to Burke Co. N.C., settling in the valley near Linville Falls, made a fortune & created an estate called Pleasant Garden, had a son, Joseph McDowell Carson, who was tall, with black hair & eyes, who decided to get out on his own &c.

Col. John Carson of the Catawba Valley. course, and stated that they would drive all the stock they could collect into the deep coves at the base of Black Mountain; that others might, if they would, take protection and save the remainder that could not be readily collected and concealed. Captain John Carson, a distinguished Indian fighter, afterwards known as Colonel Carson, Benjamin and William Davidson, and others, were designated to take protection, and thus save many valuable herds of cattle from the grasp of the enemy.* It was a very ungracious act on their part; but Carson and his associates deemed it justifiable under the circumstances--suggested and urged, as it was, by Colonel McDowell, in behalf of the Whig cause. While they accomplished the object they had in view, their motives, in the course of time, were unjustly misjudged and impugned.†

As had been anticipated by the patriots, Ferguson, either in full force, or with a strong detachment, penetrated into the very heart of Burke County--as far as Davidson's "Old Fort," in the extreme western part of then Burke, now McDowell county;* and a few miles farther north, up the Catawba Valley, as far as the old Edmondson place, since McEntyre's, on Buck creek at the foot of the Blue Ridge. On their way thither, the British force was supplied with beef, corn, and other necessaries, by one Wilson, an Irishman, who afterwards migrated to Tennessee, and for which he received a draft on the British Government from which, probably, he never received any avails.‡
