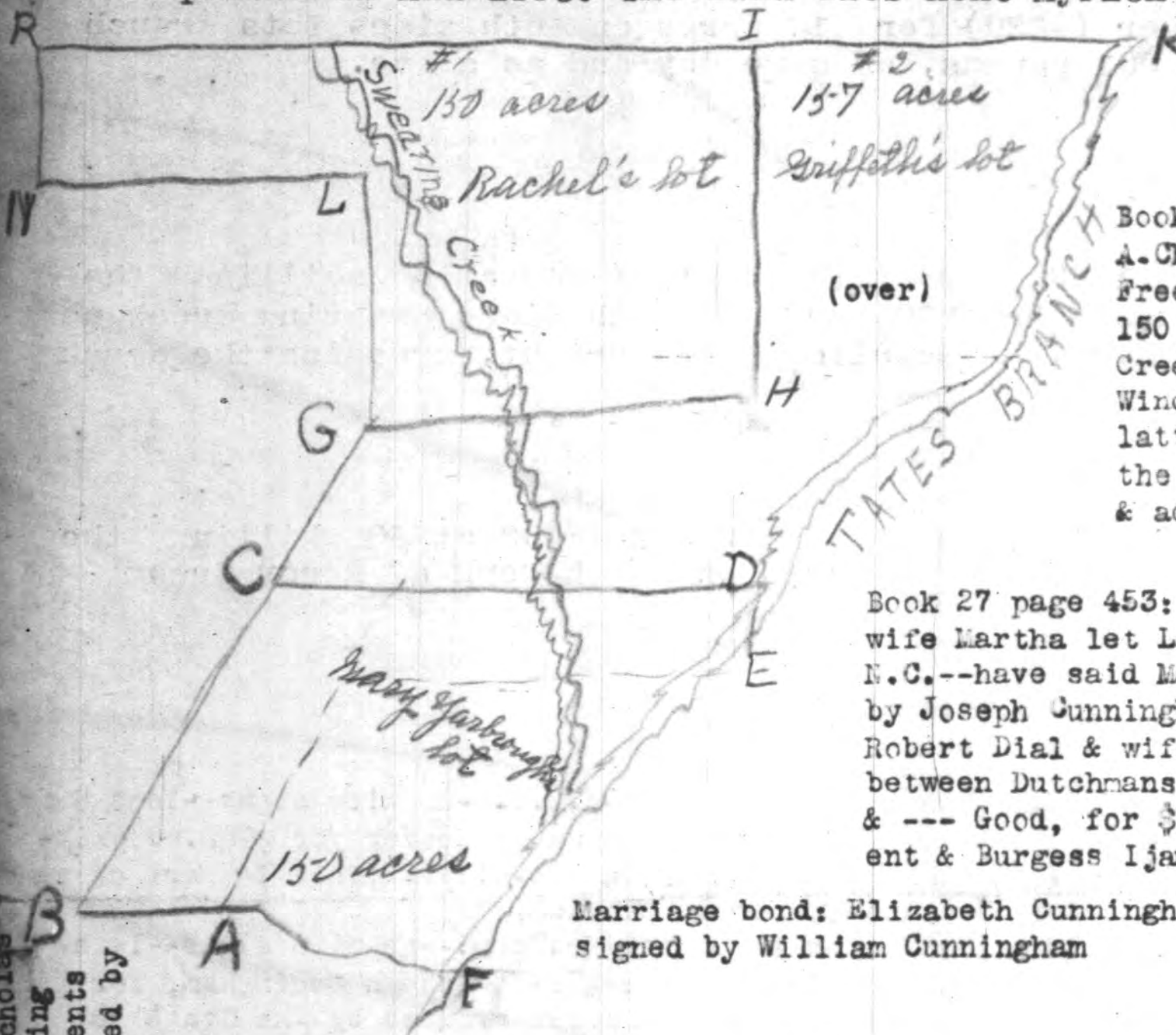

Book 23 page 236: Agreeable to order to divide the land of deceased Joseph Cunningham according to his will, it was done by Peter Smith, Joseph Haden, George Smith, Theodore McKee & Robert McKee. Surveyed on March 18 1805 & proved in Mau 1805. The land lies next Myrick Davis, John Wright



& this is a rough sketch of the land, the original being given in same.

Book 21 page 506: Dec. 31 1807, John A. Chapman--no wife signs--lets Casper Freedle (both of Rowan Co. N.C.) have 150 acres on both sides of Swearing Creek, for \$785.00, witnessed by Ep. Winders & John Thomas & proved by the latter in May 1809. (This belonged to the deceased Joseph Cunningham Sr. & & adjoined the 310 acre tract).

Book 27 page 453: Feb. 11 1823, Vachell Ijams & wife Martha let Lawrence Clement--all of Rowan Co N.C.--have said Martha's half of the land willed by Joseph Cunningham Sr. to said Ijams & wife & Robert Dial & wife Elizabeth, being 174 acres between Dutchmans & Bear Creek next Henry Clement & --- Good, for \$1100.00, witnessed by Henry Clement & Burgess Ijames & acknowledged in Feb. 1823.

Marriage bond: Elizabeth Cunningham to Robert Dial Aug. 24 1788 signed by William Cunningham

Marriage bonds: Mary Cunningham to Henry Yarbrough Sept. 13 1803 signed by, Rachel Cunningham to John A. Chapman March 29 1806 signed by William Andrews.

Book 26 page 444: April 17 1821, Vachel Ijams--no wife signs--mortgages to Nicholas W. Gaither for \$615.29 (as he owns the bank at Salisbury \$165.00, A. Nesbit a ballance on note of \$358.67, judgements &c) his wagons, germs, 3 head of horses, shepp, hogs, farming utensils &c.

Book 27 page 415: Jan. 20 1823, Nicholas W. Gaither relinquishes all his claims in the mortgage made by Vachell Ijams & wife Martha on April 17 1821--see book 26 page 425--which was proven in May term of 1821 & registered on July 24 1821, witnessed by Thomas McNeely & Laurence Clement & proved by the latter in Feb. 1823. (Refer to margin of this sheet).

Book 27 page 90: Vachell Ijams & wife Martha let Jesse Hargrave--all of Rowan Co. N.C.--have 63 acres on Swearing Creek next the line of Mr. Frohock, for \$1.00, witnessed by Thomas L. Cowan & A. A. Carrigan & acknowledged before Esq. John Monroe in May 1822. (William Millsaps let Joseph Cunningham have this & the said Martha was said Cunningham's daughter).

Book 8 page 135: Jan. 25 1774, Arthur Onail--no wife signs--lets William Millsaps, a planter of Rowan Co. N.C., have the plantation of 313 acres where said Onail did live next Mr. Frohock & --- Green near the bank of Swearing Creek, for 100 pounds, witnessed by Thomas Bell & John Blake & proved by the latter in May 1774.

Book 8 page 134: May 4 1774, William Millsaps & wife Nancy let Joseph Cunningham, a planter--all of Rowan Co. N.C.--have 59 acres on Swearing Creek next Mr. Frohock, for 25 pounds, witnessed by James Smith & James Bradley & acknowledged in May 1774.

Marriage bond: William Millsaps to Ann Onail April 23 1770 signed by William Frohock while her father, Arthur Onail writes consent.

Book 21 page 73: Oct. 25 1808, Hugh Cunningham (as executor of deceased Joseph Cunningham) lets Manoah Yarbrough (both of Rowan Co. N.C.) have 59 acres on Swearing Creek next Mr. Frohock, for 60 pounds, witnessed by James Carson & James Macay & acknowledged in May 1807.

Book 26 page 425: April 17 1821, Vachel Ijams & wife Martha mortgage to Nicholas W. Gaither--all of Rowan--the 205 acres where said Ijams & wife now live being 205 acres between Dutchmans & Bear Creeks next line of McIlhenny (now Clements dated March 13 1800, for \$615.19, witnessed by B. Gaither & A. Nesbit & proved by the latter in May 1821.

Book 12 page 693: Nov. 10 1784, The State grants Joseph Cunningham 443 acres (#521) for 351 pounds, on Indian Grave Branch next tracts #28 & 29, being part of the land which had been owned by Henry Eustace McCulloch & Act of Assembly demanded its sale.

Book 12 page 694: Another (#520) for 310 acres on both sides Tates Branch of Swearing Creek, for 201 pounds, on same day and as above.

Book 9 page 368: Oct. 10 1783, The State grants (#643 at 50 shillings the 100 acres) to Joseph Cunningham 270 acres on both sides Swearing Creek next his deeded land, --- Frohock, --- McCulloch & --- Wright, crossing the creek & a Branch.

Book 9 page 367: Oct. 10 1783, The State grants (#603 at 50 shillings the 100 acres) to Joseph Cunningham acres on north fork of Reedy Creek

Book 16 page 469: Dec. 26 1797, William Cunningham of Rowan Co. N.C. --- no wife signs --- lets Henry Michael of Wilks Co. N.C., have 200 acres on Reedy Creek next Jacob Weaver for \$100.00, witnessed by William Ambern & W. Moore & proved by the latter in Feb. 1799. (This is part of a State Grant made to Joseph Cunningham who conveyed it to William)

Book 16 page 462: Dec. 26 1797, William Cunningham of Carter Co. Tenn. --- no wife signs --- lets Henry Michael of Wilks Co. N.C., have 300 acres on Reedy Creek next Joseph Cunningham, for \$100.00, witnessed & proved as above. (This is part of 640 acres granted by The State to the said William Cunningham).

Book 8 page 102: May 31 1765, Esq. Henry Eustace McCulloch lets Myrick Davis a planter of Rowan Co. N.C., have 505 acres on Swearing Creek next --- Myers, south of Mr. McCulloch's south line, crossing Millers Branch, Tates Branch & Swearing Creek, next Joe Bowen & --- Green, for 150 pounds, witnessed by Alexander McCulloch & Esq. Benjamin McCulloch & proved by the latter on Oct. 14 1771.

Book 8 page 281: Feb. 8 1775, Myrick Davis & wife Margret let Joseph Cunningham (all of Rowan Co. N.C.) have 98 acres on Swearing Creek & crossing it for 30 pounds, witness (Part of the tract which Henry E. McCulloch let said Myrick Davis have --- see book 8 page 102).

Book page 332: Aug. --- 1783, Myrick Davis, a yeoman (Margaret makes her mark --- both of Rowan Co. N.C.) let Hugh Davis, a planter, have 65 acres on the east bank of Swearing Creek next Michael Myers, the manor of McCulloch, on the east side of Tates Branch next Joseph Cunningham & along his high-water mark on the creek, for 50 pounds, witnessed by John Wilson & Joseph Cunningham & proved by the latter in Nov. 1783.

Book 23 page 936: Oct. 21 1816, Griffith Cunningham --- no wife signs --- lets Jacob Sink (both of Rowan Co. N.C.) have 157 acres on both sides Swearing Creek & on Tates Branch next land devised to Mary Yarbrough, land devised to Joseph Cunningham & lot #1 (but excepts the 4 acres sold to Menore Yarbrough as it was drowned by his mill pond), for \$800.00, witnessed by George Thomason & Peter Whitaker & acknowledged in Feb. 1817. (This was formerly owned by Joseph Cunningham Sr. who willed it to the said Griffith Cunningham) (over)

Book 10 page 351: Aug. 3 1785, Joseph Cunningham --- no wife signs --- lets Myrick Davis (both of Rowan Co. N.C.) have 14 acres on Swearing Creek next said Cunningham, for 20 pounds, acknowledged in Nov. 1785. (This is part of the State grant of 270 acres made to said Cunningham on Oct. 10 1783).

Jersey Settlement Moores

Robert Moore of Ireland is said to have come to America in 1763 (highly recommended by his minister James Proudfoot of Pequea as sober & worthy of admission to any congregation on Oct. 21 1765), married Dec. 29 1763 to Martha Cunningham of Earl Township, Lancaster County Pa. by Alexander Murry (minister). Their children were:  
 William born Feb. 11 1765 about one in the day of Monday.  
 Mary " March 13 1769 at nine in the forenoon.  
 Jane " " 5 1767 at one in the day of Thursday.  
 Elizabeth " " 31 1771 about one on Monday.  
 Robert " Sept. 4 1773 about one A.M. Saturday.  
 Martha " March 7 1776 about midnight.  
 Ebenezer " Feb. 25 1779 about one in the evening of Thursday followed by Josiah 15 minutes later.

Descending from above Ebenezer Moore, is Mrs. Carolina Moore (Beall) Calvert who lives with her two daughters, (Mary Cornelia & Angeline Beall Calvert) and her brother James Beall on the old Cunningham & Moore lands near Linwood. The father of these two girls was James Clifton Calvert, son of Angie Drucilla Gaither & husband John Enos Colvert; grandson of Tabitha Caroline Gaither & husband Robert S. Colvert who was born in Maryland--the above mentioned Tabitha Caroline Gaither was the daughter of Asa Burgess Frierson Gaither & wife Caroline Tabitha daughter of Elizabeth Lovelace by her husband Alvin Howard.

Jan. 27 1772, Henry Doland & wife Elizabeth let Robert Moore, a weaver,--all of Rowan Co. N.C.--have 272 acres next John McGuire & Henry Sloan, for 170 pounds, witnessed by Robert Woodside & James Smith & proved in Feb. 1772. (Henry McCulloch let the deceased Henry Doland have this on Nov. 27 in the 2d year of King George III. & it was registered in the quit-rent office of Earl Granville on July 8 1762, also in the Registrar's office in Rowan County book 5 page 43). (Book 7 page 404: It is 222 acres with dimensions as in following grant).

Book 5 page 43; Nov. 27 in the 2nd year of King George III., Esq. Henry McCulloch let the planter, Henry Doland of Rowan Co. N.C., have 222 acres in tract #9, beginning on the line of John McGuire at a white oak sapling, going with the same west 148 poles to a stake on the line of Henry Sloan, north 240 poles to a hickory, east 148 poles to a stake, south 240 poles to the beginning, for 18 pounds sterling

Iredell Co. N.C. book M page 845; July 7 1824, Burgess L. Beall--no wife signs--lets Aza Beall --no homes given--have his part of the 225 acres (devised to them by their deceased father, Zachariah Beall, equally) on Rocky Creek next John Summers, bank of the river, on down it to Joseph Albea's, on the big road, next John Bailey & Horatio Beall, for \$562.50, witnessed by Neal H. Brooks & Joseph Albea & proven by the latter in Feb. 1827.

The will of Zachariah Beall (Iredell Co.N.C. book 1 page 400) made June 2 1817.  
Wife: Rebecca (all property while a widow, then it is to be divided between two sons Aza & Burgess) Sons: Aza, Burgess & Horatio. Daughters: Drucilla, Rebecca & Jemima Fitzgerald.  
Four grandchildren: Zachariah, Samuel, Rebecca & William--all are Albeas. Witnesses: Thomas C. Leach, James Smith Jr. & John Gaither (jurat)

Iredell Co.N.C., book page 955; March 17 1827, David B. Beggary (Hester M. Beggary also signs) lets Thomas Balt--all of Iredell Co.N.C.--have 148 acres on the north bank of the Yadkin River on the east bank of Rocky Creek next the heirs of Zachariah Beall, crossing the spring branch to the mouth of Rocky Creek, for \$1250.00, witnessed by Libetious Gaither & Jeremiah Gaither & proved in May 1827. (This is part of a grant to Zacharial Beall

Book 11 page 252; Aug. 9 1787, The State grants (#1561 at 50 shillings the 100 acres) to David Begerly 640 acres on the waters of the South Yadkin, beginning at a pine, going north 17 chains to a black oak on the corner of John Baley, west 20 chains to a forked post oak on the corner of said Baley, north 9 chains to a black oak on the corner of said Baley, north 31 chains to a pine on the corner of said Baley, west 9 chains to a post oak on the corner of said Baley, north 17 chains to a small black oak on the corner of said Baley, east 100 chains with the line of John Reed to a persimmon, south 74 chains to a black oak on the corner of Evin Beall, then west to the beginning.

Book 4 page 62: On Jan. 16 1759, Henry Dowland, a planter & wife Jane, let Edward Williams (also a planter & aml of Rowan Co. N.C.) have the 220 acre plantation on the Yadkin River, for 5 shillings--release price on same day being 20 pounds--witnessed by Wm. Giles & Francis Beatey & proved in Jan. 1759.

Book 22 page 113: On March 8 1811, William Moore (a surveyor), Dr. Robert Moore & Ebenezer Moore (a planter)--no wives sign--let "the Children & Lawful heirs of John Wilson (Deceased) All of the county" of Rowan, N.C., have 50 acres on Potts Creek next the tract purchased by Robert Moore the elder from Henery Donald; the line of the deceased John Wilson which was formerly land of ---Giles, and a glade on , for 100 pounds which had been paid by deceased John Wilson during his lifetime. (This is part of a tract of 100 acres granted by The State to Robert, William & Ebenezer Moore on Sept. 17 1800). The deed was witnessed by John Simeson & A. Yarbrough & proved by the former in May 1811.

Aug. 15 1770: Henry Doland is deceased & James Doland is to administer, his bond is 300 pounds with Edward McGuire & Henry Doland as security. Inventory.

Book 7 page 404: On Jan. 27 1772, Henry Dowland & wife Elizabeth let Robert Moor, a weaver, have 222 acres next John McGuire & Henry Sloan, for 170 pounds, witnessed by Robert Woodside & James Smith & proved in Feb. 1772. (This had been granted Henry Doland by Henry McCulloh on Nov. 27 in the 2d year of King George III. but Henry Doland is now deceased).

Nov. 2 1779: The will of Robert Moore proved by James Smith. The widow, Martha, & Joseph Cunningham qualify as Exrs. (over)

Exrs: wife & "Joseph Cunningham trusty and well beloved brother". Witnesses: Robert Simeson, Alexander Miller, Anderson Smith & James Smith Jr.

Book 18 page 317: On March 18 1802, William Moore, a surveyor,--no wife signs--lets Step Roberts (both of Rowan Co. N.C.) have 200 acres next Garshom Hunt, Henry Clemens, & the great road, for \$4.00 the acre, witnessed by Jacob Wiseman & John Wilson & acknowledged in Aug. 1802. (This is part of a tract of 250 acres granted by Henry Eustace McCulloh to Robert Moore and held by said William Moore, as devisee of the said Robert Moore who died).

Book 19 page 918: On May 1 1806, William Moore--no wife signs--lets Hugh Willson (both of Rowan Co. N.C.) have 320 acres on both sides of Bear Creek next ---Stewart & Ebenezer Frost, for \$1260.00, witnessed by Littlebury B. Rose & James E .? & proved by Littlebury B. Rose in Feb. 1807. (When deeded to him this was 319 acres in cluding a graveyard of 3/4 acres, but it now is found to be 360 acres with the burial ground--being part of 640 acres which Earl Granville let George Boone have by indenture on Dec. 21 1765?, who let Joseph Hughes & wife Molly, on Jan. 24 1772 & they let Valentine Huff who let William Moore have it).

Book 8 page : On Jan. 23 1772, George Boone & wife Ann let Joseph Hughes have 320 acres in the forks of the Yadkin River on both sides of Bear Creek next ---Stewart, William Brown & Isham Holland for release price on next day being witnessed by proved in . (This is part of a grant from Earl Granville to George Boone on Dec. 21 1761).

: Deed from George Boone & wife to Joseph Hughes for 320 acres on Jan. 24 1772 proved by William Brown.

: Deed from Joseph & Mary Hughes to Valentine Huff for 320 acres on June 12 1776 proved by James Hendricks

Book 23 page 149: On July 7 1809, George Moore of St. Clear, Helenoy Territory no wife signs--lets Stephen Mankins of Surry Co. N.C., have 200 acres next William Stettman? & William Steelman & William Cook on the Surry Co. line, for \$100.00, witnessed by Joel More & John Reavis & proved by the latter in May 1814. Book 23 page 147, Stephen Mankins of Surry Co. N.C.--no wife signs--lets Davis Reavis of Rowan have this Feb. 18 1813 for \$200.00.

Book 10 page 192: On Jan. 17 1784, William Raper of Guilford Co. N.C. (Rebekah also signs) lets Nathaniel Moor of Rowan Co. N.C., have 258 acres on both sides of Rich Fork of Abbits Creek, for 200 pounds, witnessed by Mack Osborn & Henry Davis & proved by latter in May 1788? (William Raper bought this of the high sheriff, John Brevard).

Book 29 page 443: On Feb. 6 1827, William Cunningham & wife Ann let Ebenezer Moore (all of Rowan Co. N.C.) have acres on Potts Creek for \$300.00, (this is wife Anne's portion of her father the deceased George Cunningham & 1/5 which she heirs from her deceased sister, Elizabeth, which is 1/5 of her father's estate, being 33 acres,

Book 22 page 157: On April 24 1810, John Cunningham (son of George Cunningham) & his sisters (Sarah, Rebecca, Elizabeth & Ann Cunningham) let Hugh Horah, a merchant, & Dr. Robert Moore (all of Rowan Co. N.C.) have 160 acres on the eastern side of Pottz Creek next Henry Dowland, at the edge of a meadow, or 100 acres (not to include the spring generally used for the dwelling house), for \$200.00 & a peppercorn to be paid on the 24th day of Dec. 1812, witnessed & proved by Ebenezer Moore in May 1811.

National Register of Sons American Revolution, page 280, Hugh Waddell of Washington, D.C. is #6937 of that society, as son of Hugh and Susan H. (Moore) Waddell; grandson of John and Sarah (Nash) Waddell; great-grandson of Francis Nash, Brigadier-General of North Carolina troops; grandson of Alfred and Rebecca (Williams) Moore; great-grandson of Alfred Moore Sr., Captain First North Carolina Line; great-grandson of John Pugh Williams, Colonel Ninth North Carolina Line.

N.C., a planter, have 220 acres where said Moore now lives including his plantation & improvement on east bank of Yadkin River above the mouth of Swearing Creek crossing two branches, for 100 pounds, witnessed by Alexander & Esq. Benjamin McCulloh & proved by the latter on Oct. 14 177

Buried in Fourth Creek Presbyterian Churchyard (Statesville, N.C.) are some Moores.

Rev. John Moore

Mrs. Sarah Fiducia (Hunt) Steeves, widow of Dr. B.L. Steeves, joined Colonial Dames &c, through several lines, among them being Rev. John Moore, born in Kent, England came to America on the ship, "Defiance", resided awhile in New York. The first record of him in Long Island was in 1641. In 1644 he was appointed Deputy to negotiate the terms of union with New England Colonies, & in the same year was appointed to receive appointments to collect subscriptions for the scholars of Harvard College. Licensed to preach before 1649, he was preaching this year at Southampton, Long Island. Records show that he was the first pastor of the Presbyterian Church at Newtown, L.I. in 1652. He died while serving on Sept. 17 1657. Soon after his arrival in America, he had married Margaret, the daughter of Edward Howell, of Wedon, Bucks Co. England, of the noted Howell family of England from which descend all Americans of that name, which is traced back 1000 years.

Rev. John Moore & wife Margaret had at least five children: John, Gershom, Joseph, Samuel & Elizabeth (of whom the last named married Capt. Content Titus, of Newton, Long Island.)

Captain Samuel Moore, son of Rev. John Moore, was born at Newton, L.I. in 1645 & died there in 1717. He had been granted land there on Dec. 4 1666, elected Freeholder & serving constantly for the next thirty years, holding many offices of trust & responsibility. He with others on Oct. 3 1662, bought from the Indian chiefs (Womalupa, Wonoce & Powatahuma) Plunders Nexk, Jamaica, L.I. He married Mary the daughter of Thomas Reed (who built the church & home of Rev. John Moore in 1655) & had: Samuel, Joseph, Benjamin, Nathaniel, Margaret, Mary, Elizabeth & Sarah--their descendants are numerous. For proofs of the Moore statements refer to "Annals of Newton (Elmhurst) Long Island & records of Southampton L.I.;" for Moore & Howell statements refer to Pioneers of Old Hopewell, by Edge.

Benjamin Moore, son of Captain Samuel Moore & wife Margaret, married Ann Sacket (the daughter of Captain Joseph Sacket, born Feb. 23 1656 died 1719 possibly at Southampton, L.I., who lived in Connecticut & New York, was Lieutenant of Newton Militia Foot Co. Feb. 9 1690. Captain in 1712 & Patentee in Southampton in 1686, by his wife Elizabeth Betts--for Sacket proof refer to "Annals Newton (Elmhurst) L.I." by Riker, "Thompsons Long Island and Howells History of Southampton" also "Documental History of New York" Vol. II.

Elizabeth Betts was the daughter of Richard Betts, (born at Hemil Hemstead Huts, England, in 1613, came to America, living at Ipswich Mass, 1648-1713, dying Nov. 18 1713 aged 100 years at Newton, L.I., buried upon his estate, at English Hills, L.I.--no one so eminent as he, a Magistrate, in the Revolution against the Dutch in 1663, Member of High Court of Assize, which was the supreme power in the province, for many years, Delegate to Committee of Public Safety June 1 1689, High Sheriff of Yorkshire L.I. from 1678 to 1681, Patentee of Newton L.I., Deputy to Promulgate the Dukes laws, Commissioner, Captain, Judge &c) & wife whose name is unknown. For proof

The first record of the Howell family is Howel Dda, meaning "Howel the Good" who flourished A.D. 900-950. It is a Welsh tradition that "Howel Dda" loved peace, feared God & governed conscientiously. (See the Genealogy of Reading, Howell & other families published by Prof. J.G. Leach L.L.D. in 1898, & "Pioneers of Old Hopewell" by Ralph Edge). The Howells of Westbury, Marsh Gibbon, County Bucks, England, descended from Howel, Prince of Caerleon-upon-Uske, in Monmouthshire, England, whose coat-of-arms they bore.

William Howell of Wedon, Waygate, was descended of the above prince. He died about Nov. 1557, leaving children by his wife Anne ----, who are: John, Henry, Jacob, Isabell, Jane, Cecil, Agnes, Anne, Joane & Alice. He left legacies to wife, children, to the poor in six neighboring parishes & to the church at Hardwick, directing that his body be buried in the chancel before the high altar in this church. His son,

Henry Howell lived on Manor of Westbury (which his father had bought in 1536,) which his son Edward bought after he died July 7 1625 & sold, signing Gent. to the deed on June 8 1639 of Greevelthorpe, County York, England

Edward Howell married first Francis (who died before he left England) & he then married ---- the daughter of Edward Bryan of Connecticut, America. Coming to America about 1639, he located at Lynn, Mass. where he held 500 acres but removed to Southampton, L.I. in 1640 & was one of the founders, a Member of the Governor's Council of Conn. 1647-1653, dying in 1655. His daughter, Margaret, born at Marsh Gibbon, England, & baptized there Nov. 24 1622 (supposedly the date of her birth), became the wife of Rev. John Moore--see top of this page--while her brother, John (two years younger) died in 1696 at Southampton L.I., where he was buried with Howell engraved upon his tombstone. (Refer to Howells of Southampton & Colonial Records of Connecticut).

This line runs thus: Prince Howell of Caerleon-upon-Uske of Monmouthshire, England, whose son, William Howell had wife Anne of Wedon, Waygate, England; whose son Henry & wife --- were of Manor of Westbury, whose son Edward, "Gent" & wife Francis were of Greevelthorpe, England, came to America, whose daughter, Margaret, married Rev. John Moore.

Col. Thomas Hunt of England was a colonel in Cromwell's army, born about 1588. His son, Ralph Hunt was a Lieutenant & Long Island colonist (refer to records of Mercer Co. N. Jersey) & had Samuel (who died in 1720) & Mary (who married Theopolis Phillips, by whom she had a Philip Phillips who married the widow, Elizabeth, of Ralph Hunt who died in 1733, son of his mother's brother Samuel, by whom he had a daughter, Esther Phillips who married Major John Hunt, the son of John the son of Samuel who died in 1720).

Page 221: "Some of the other Cunninghams of South Carolina, particularly of York District, served with the Americans during the Revolution. Among the latter seems undoubtedly to have been Humphrey Cunningham, whose daughter Rhoda became the wife of James Alexander, one of the first white settlers in what is now Western North Carolina and in the present County of Buncombe, which county he as a member of its county court helped to organize in 1792, and who was a pensioner of the United States for Revolutionary services when later such ensions were allowed. A tablet "In memory of Revolutionary Soldiers who Enlisted from Centre Congregation 1775-1781" at Centre Church in North Carolina names thirty-four of those American soldiers and among them William Davidson, Lieut., and Paul Cunningham and John Cunningham.

"This Rhoda Cuningham who married James Alexander was the daughter of Humphrey Cunningham and his wife Rhoda Cunningham, born Rhoda Summerville or Somerville, born in Ireland, whose mother was a Ware or Wear before marriage and, by a second husband, George Davidson, became the mother of General William Davidson killed at Cowan's Ford of Catawba River. Thus Mrs. Humphrey Cunningham was half-sister to General William Davidson while her daughter Rhoda, niece of General Davidson, married James Alexander, son of Rachel Alexander, first cousin of General Davidson."

Page 207: "A Mr. Somerville, of the north of Ireland, married a Miss Ware, of the same vicinity, and when they had a family of several children, started on a ship to settle in the British provinces of North America. He took with him his wife and all his children, except a twin girl named Rhoda whom they left in Ireland with an old maid aunt to be reared. The captain of the ship, when they were near the North American coast, left his five hundred passengers on an island, presumably of the West Indies, with provisions for a few days, promising to return in that time and take them on to the continent. He sailed away with their property and never came back. Soon their supplies were consumed and all but fifty of them died of starvation and exposure. Of the Somervilles only Mrs. Somerville survived. She with the other forty-nine survivors was rescued by some Indians. At length she reached Pennsylvania, and there, after some time, she married George Davidson, an immigrant from the north of Ireland. Then her daughter, Rhoda Somerville, who had been left in Ireland, came to Pennsylvania. After her arrival or before leaving Ireland she married Humphrey Cunningham, another migrant from the north of Ireland, and they settled in Lancaster County, Pennsylvania, where some of their children were born. At 1770 they removed to York District, South Carolina, and settled on Allison's Creek. A daughter named Rhoda Cunningham (who had been born in Lancaster County Pennsylvania, October 15, 1763), on Allison's Creek, March 19, 1782, married James Alexander. After the birth of several children James Alexander and wife, Rhoda (Cunningham) Alexander, with their children and some relations of both, removed in the early part of 1785 to Bee Tree Creek of Swannanoa River, now in Buncombe County, North Carolina; and there, at that time, formed the first white settlement in what is North Carolina west of the Blue Ridge. There James Alexander died June 28, 1844, and Rhoda (Cunningham) Alexander died January 29, 1848. Both are buried at Piney Grove Church in that neighborhood. They left sons and daughters and their descendants are very numerous in that country and elsewhere" (over)

Page 199: Other children of Humphrey Cunningham & wife Rhoda (Somerville) were: "Humphrey, James, ohn (who was drowned in East Tennessee), Rhoda (born in Pennsylvania, October 15, 1763, in Lancaster County, married James Alexander on Allison's Creek, York District, South Carolina, March 19, 1782) and Sarah (born December 12, 1765, and married James Patten, August 3, 1784, in York District, South Carolina)". A letter from a Mr. Hannah of Prairie Grove, Ark. to Mr. Ed Couch, Anthony, Kansas, to Rev. Erwin Patton Anderson, D.D. of Middle Tenn. was kindly sent to Mr. Sondley giving details of the Bee Tree Settlement. Dr. Anderson is descended of Rhoda (Somerville) Cunningham through her daughter, Sarah (Cunningham) Patton

N.C., June 28 1844, was buried at the old Robert Patton burying ground about two miles off, but removed when Rhoda (Cunningham) Alexander who died Jan. 29 1848 was buried in same grave at Piney Grove Church about three quarters of a mile from the Robert Patton burying ground. Their children were: "John C., born March 22, 1783, and married to Jane Patton on December 31, 1808; Rhoda, born November, 1785, and married to William McDaniel (Rhoda McDaniel dying September, 1881); William Davidson, born January 28, 1788, and died in youth; George C., born September 10, 1790, and married to Elizabeth Foster, June 23, 1818, she being a younger sister of Nancy (Foster) Alexander, wife of James Mitchel Alexander; George C. Alexander dying October 3, 1860 and his wife Elizabeth (Foster) Alexander dying January 4, 1864; James Mitchel, born May 22, 1793, and married to Nancy Foster, September 8, 1814; Robert S., born September 2, 1795, and married to Jane Wilson, May 25, 1820; Rachel, born December 30, 1797, and married to Moses White, December 2, 1824; William Davidson (the second child so named), born December 10, 1800, and married to Leah Burgin, April 21, 1825; Humphrey Newton, born June 11, 1803, and married to Mary Foster, December 26, 1826; and Elizabeth, born April 10, 1805, and married to Joseph A. McEntire, January 19, 1832."

Of the above children "James Mitchel Alexander, son of James Alexander and Rhoda (Cunningham) Alexander, was born at the Alexander home on Bee Tree Creek in Buncombe County, May 22, 1793, in the "SWANNANOVA SETTLEMENT" and when Buncombe was just a little over a year old. Most probably James Mitchel Alexander was named for the Presbyterian preacher, James Mitchel, who preached most of his time in the Shenandoah Valley, Virginia, from 1781 to 1841, and was celebrated as a preacher among the Scotch-Irish throughout Virginia, Kentucky, and Western North Carolina"

"In the times of pioneer settlements of American "backwoods" it was important for every young man to learn a trade. When a youth James Mitchel Alexander learned to be a saddle-maker and maker of harness but never followed the trade long. On September 8, 1814, he married Nancy Foster, oldest child of Captain Thomas Foster and his wife Orra (Sams) Foster who lived where the town of Biltmore later was. Soon afterwards, on July 6, 1816, he bought from Zebulon Beard a parcel of land containing 28 acres and 134 poles for two hundred dollars. This land was in the town of Asheville and is now south of Patton Avenue and west of the northern section of Church Street but extends at the southern end of the tract eastward to South Main Street now Biltmore Avenue". Here he built and kept a tavern--he gave a part of his land to the first Methodist Church--now Central Methodist Church on Church Street. About twenty five years later, he built an elegant mansion on Royal Mountain which he named Montrealla where he died June 11 1858 and is buried at Alexander's Chapel. His widow, Nancy (Foster) Alexander is buried by his side, having died Jan-14 1862. Their children were: "Harriet Elizabeth, born December 28, 1816; died March 22, 1897; Alfred M., born January 11, 1819; died October 24, 1890; Mary Eliza, born October 4, 1821; died September 11, 1861; Orra A., born November 22, 1824; died December 25, 1859. Samuel and his family moved to Illinois. John and James were patriots in the Rev. War; they moved to Georgia. John married Ann Davis."
