A letter from Luella D. Cuelee (Mrs. Shelby Cuelee) of Hotel Chase, St. Louis, on Oct. 6 1923, wanting information of Adam Mitchell who in 1768, gave "one acre of land for use of a Presbyterian Meeting house", the deed signed by Adam Mitchell & witnessed by Thomas Donnell & John Mitchell. From a fly-leaf on an old book called the "Houston Book" she found the following: "Adam Mitchell father of us all lived in N.C. He was badly damaged by a battle on his place in time of Rev. War His father's name was Adam Mitchell of whom I know nothing about. Adam Jr's children: John Mitchell, Samuel Mitchell, James Mitchell, Hezekiah Balch Mitchell, and Wm Mitchell. Adam Mitchell left N.C. directly after the War and settled in Blount Co. Tenn." This was written by L.B. Mitchell Feb. 8 1894. We are interested in Hezekiah Balch Mitchell, who went to Miss. Md, Mary Davidson Houston.

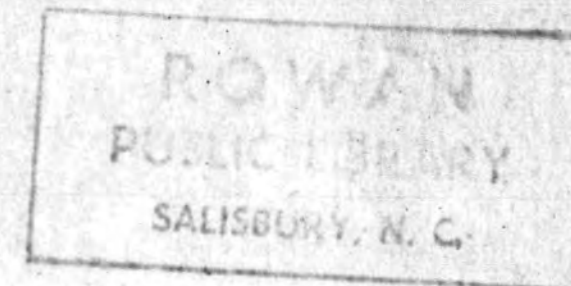
