



The wife of Daniel Travis Alexander was Susan Ward. Daniel Travis Alexander had two brothers: Bertram and Seab Seaborn Alexander. ~~Seaborn~~ Seaborn Alexander was a Mexican war veteran, Company M, 1st Reg., Tennessee Infantry, (but that is later than the date above given).

If you can look this up, see if these people were landowners, and if there is any trace of them there and where they came from to Rowan County, it would be most helpful to this lady who wants the information.

* History of Mecklenburg Co. N.C. (Dr. J.B. Alexander) page 98: "Gov. Nathaniel Alexander was one of five sons of the famous Moses Alexander. Gov. Alexander had a brother, William Alexander, who married Elizabeth Henderson." Gov. Nathaniel Alexander was a physician by profession & a native of Mecklenburg County. No evidence that he practiced his profession--see next excerpt. Marshall Delancey Haywood, "Masonic Revolutionary Patriots" in N.C. Booklet of July 1912 says "There were Governors Alexander Martin, Nathaniel Alexander, and Montfort Stokes, officers of the Grand Lodge, all of whom had served in the war--Martin as a Colonel of Continentals, Alexander as a Surgeon, and Stokes as a seaman" &c

History of Mecklenburg Co. N.C. (by D.A. Tompkins in 1904) page 65: Governor Nathaniel Alexander born in Mecklenburg Co. N.C. died at Charlotte, N.C. on Nov. 8 1808, married Margaret Polk Brevard (a daughter of Dr. Ephraim Brevard, & a granddaughter of Thomas Polk) Encyclopedia Britannica Appendix: Dr. Ephraim Brevard born about 1750 died in Charlotte N.C. about 1783 from effects of suffering imprisonment after capture by British while serving in the Continental army. He was a graduate of Princeton, was secretary of the Mecklenburg Convention & drew up the Declaration of Independence of May 31 1775. Six of his brothers also served in the Continental Army.

Book 9 page 315: Nov. 7 1783, Esq. Adlai Osborn--no wife signs--lets Esq. Spruce Macay (both of Rowan Co. N.C.) have lot #27 in the west square (144 sq. poles), for 10 pounds, witnessed & proved by John McNairy in Nov. 1783.

Book 9 page 316: Dec. 7 1783, Esq. Adlai Osborn--no wife signs--lets Esq. Spruce Macay (both of Rowan Co. N.C.) have lot #19 in the west square (144 sq. poles), for 300 pounds, witnessed & proved by John McNairy in Nov. 1783.

Book 14 page 795 or 895 (numbered twice): Aug. 28 1796, Esq. Spruce Macay--no wife signs--lets Esq. Archibald Henderson (both of Rowan Co. N.C.) have lot #19 in the west square of Salisbury (144 sq. poles) also lot #27 of same size in same square, for 600 pounds, witnessed & proved by Robert Troy in May 1797. (Esq. Adlai Osborn sold these to said Macay on Nov. 7 & Dec. 7 of 1783).

Book 23 page 484: May 15 1815, Maxwell Chambers--no wife signs--lets Archibald Henderson (both of Salisbury, N.C.) have lot #28 (144 sq. poles) in the west square of the town, for \$100.00, witnessed by Henry Allimong & John Fulton & proved by the latter in Aug. 1815. (Hugh Foster let Adlai Osborn have this, he let James Hackett have it, he & wifeetsy let Joseph Chambers have it).

Book 15 page 305: Nov. 10 1797, Richard Graham ^{farmer} (Rosana also) let James Alexander ^{farmer} all of Rowan Co. N.C.--have 72 $\frac{1}{2}$ acres on the bank of Wetheroes Creek next John Lock, Richard Graham & a spring, for 75 pounds, witnessed by Benjamin Plasten? & Samuel Reeves & proved by the latter in Nov. 1797. (This was granted to said Graham).

The will of Samuel Reeves (Book D page 101) made while 'weak of body' on Feb. 14 1801. Wife Mary (a negro named George during widowhood). Sons: Thomas (has had his share) & James (gets \$50.00 in my hands which was willed him by his grandfather, James Waston). Daughter Mary Alexander. Exrs: wife & son Thomas & Charles Mills. Witnesses: William Daunport, Elias Barber & Samuel Foster.

May 7 1801: The will of Samuel Reeves is proved by Elias Barber. Letters issued to Thomas Reaves & Charles Mills.

Book 31 page 41: May 24 1832, Isaac Knight & Samuel Reeves mortgage the following tract to William Murphy--all of Rowan--for \$600.00, witnessed & proved by N. Sutton in Aug. 1832.

Book 31 page 44: May 21 1832, Edward Cress & wife Margaret of Cabarrus Co. N.C. let Isaac Knight of Rowan Co. N.C., have 23 acres on the north fork of Crane Creek on the Salisbury road next Tobias Furr & Jacob Utzman, for \$250.00, witnessed by John B. Loss & acknowledged in May 1832. (This is part of 72 acres which Francis Marshall let Jeremiah & Moses Brown have).

Book 35 page 312: June 5 1841, John Hartman & Jacob Fulwider of Rowan Co. N.C.--no wives sign--let Josiah Huie of Autauga Co. Ala., have the house & lot in south square of Salisbury, where Silas Huie now lives, which Isaac Knight willed to John Kinder, for \$200.00, witnessed by Silas Huie & L.A. Bringle & proven by the latter in Aug. 1841.

The will of Isaac Knight (Book H page 659) made while sick on Sept. 17 1834 & proved in Feb. 1835. Son James. Sister Rachel Thomas (\$800.00). Others: John Kinder of Salisbury (a house & lot in town) & Samuel Reeve (238 acres where I live). Exrs: Richard H. Alexander & Samuel Reeve. Witnesses: R.H. Alexander & Aaron Cruse.

Book 6 page 143: On Aug. 24 1764, John Doake & wife Mary let John Alexander--all of Rowan Co. N.C.--have 320 acres on Great Alamance, for 5 shillings--the release price being 35 pounds on next day--witnessed by Crs. Nation & Jeremiah Reynolds & proved in April 1765. (This is a part of a grant from Earl Granville on Aug. 1 1760).

Book 7 page 184: On Jan. 19 1769, John Alexander (or Elexander) & wife Sarah (both make their marks) let James Alexander--all of Rowan Co. N.C.--have 320 acres on the head of Great Alamance, for 20 pounds, witnessed by James Matthews Jr. & Sr., & acknowledged on March 25 1769, before M. Howard as J.P. at Hillsborough, N.C. It begins on the northwest corner at a red oak saplin, goes south 85 chains to a persimmon, east 37 $\frac{1}{2}$ chains & 15 links to a post, north 85 chains to a post, then west to the beginning.

Feb. 15 1769: The King vs John Alexander, Recognizance. George Alexander & Thomas Stilwell go on his bail for 500 pounds: The prosecutor, William Means, is bound on 100 pounds with Will Willson & Henry Little as security

Book 5 page 424: On Nov. 7 1763, John Lewis & wife Priscilla, let George Alexander (all of Rowan Co. N.C.) have 300 acre plantation in Rowan & Orange counties on the north fork of Pole Cat Creek & both sides of the county-line, for 5 shillings--the release price being 100 pistoles on the next day, witnessed by Samuel Clark & Christopher Nation & proved in Jan. 1764. (Earl Granville's agents let John Lewis have this by indenture on Aug. 2 1760--see office of Orange County in book E page 387).

Book 5 page 534: On May 29 1755, Esq. James Carter & Hugh Forster (trustees of Salisbury) let Esq. Nathaniel Alexander of Anson Co.N.C., have lot #19 in west square of the town (144 sq. poles) for 20 shillings, witnessed by William Shepperd & David Jones & proved on May 28 1756.

Book 8 page 179: Sarah Alexander of Mecklenburg Co. & C. let Adlai Osborn of Rowan Co. & C. have lot 19 in the west square of Salisbury, & C. (144 sq. poles) for 12 pounds & 10 shillings witnessed David Reese & James Kerr & proved in Aug. 1774. (James Carter & Hugh Forster, as Trustees of the Town let Nathaniel Alexander have this on May

29 1755, whose son & heir, George Alexander, let the said Sarah have it June 16, 1773.)

Aug. 5th 1774: Deed from Sarah Alexander to Adlai Osborn for a lot in the west square of Salisbury. June 26, 1773, is proved by James Kerr.

May 5 1778: Deed from Nathaniel Alexander to James Kerr for lot #11 in the north square of Salisbury Jan. 14 1778 proved by Ad. Osborn.

Book 8 page 472: Jan. 14 1778, Nathaniel Alexander of Mecklenburg Co.N.C.--no wife signs--lets James Kerr of Rowan Co.N.C., have 144 sq. poles or lot #11 in the west square of the town of Salisbury, for 50 pounds, witnessed by & proved by Adlai Osborn in May 1778. (The trustees of the town let Moses Alexander have this on May 20 1755 & the said Nathaniel Alexander is his heir-by-law).

Book 6 page 112: May 29, 1755, The Trustees of Salisbury (as above), let the blacksmith, Moses Alexander of Anson Co., & C. have lot #11 in west square of the town (144 sq. poles), for 10 shillings & C.

Page 93 of 'A Collection of the Private Acts of ^{the} General Assembly of the State of North Carolina' & c. (printed in 1794 by Francois Xavier Martin): Nathaniel Alexander's mill was on Rockey River on the trading road from Salisbury to Charlotte.

Page 90 of same authority: As the Mecklenburg courthouse is so far from the northeast end of said county, the Second Regiment of Mecklenburg is to muster at the house of Martin Phifer where they formerly mustered--the captains of this regiment are: James Varr, James White, Matthias Lever, John Sterns, William Houston & William Alexander.

James P. Deaton

The Charlotte Observer of June 30, 1940, Mrs. Yarbrough wrote an article about Mr. Harry P. Deaton, who for forty years was owner & editor of the Mooresville Enterprise, who was a direct descendant of one of the Signers of the Mecklenburg Declaration of Independence through his mother, Mary Grissian Alexander who married Pinkney Stuart Deaton & moved to Concord, N.C. where Harry P. was born Feb. 22 1872. Mary Grissian Alexander was the great-great-granddaughter of Matthew McClure who was a Signer of the Declaration of Independence & his great-grandmother, Melinda McClure married Charles Alexander (a well known member of the Alexander family which was among the first in Mecklenburg County to adopt strenuous measures for American Independence). James Deaton (grandfather of Harry P.), was born & reared on the Thomas Deaton place near Mooresville which had been granted by Gov. Granville to the great-great-grandfather of Harry P. who lived to be ninety-nine years old & reared a family of three daughters & eleven sons--nine of whom served in the Confederate Army.

Harry P. Deaton married April 8 1902, Miss Minna Blanch McNeely with whom he was very happy until her death the second of June 1940 leaving Catherine, (the elder, who married the editor & owner of the Dare County Times, Victor Meekins), & Mary Moore

Daughters of the American Revolution, Vol. CXII page 171: Mrs. Charles B. Wagoner, (Janie Alexander Patterson), born in Concord, N.C., joined as #111524 from Abraham Alexander, (1717-1786), born in Cecil Co., Maryland, died in Charlotte, N.C. was Chairman of the Mecklenburg Declaration of Independence in 1775 & was appointed one of the Original Trustees of Liberty Hall Academy in 1777. (See #64442), &

Ensign Thomas McClure, (1760-1832), born in Chester Co., Pa., died in Charlotte, N.C., was appointed Ensign in the Salisbury District in 1776--see #111523.

She is the daughter of John K. Patterson (born in 1852), married secondly in 1883, Esther Alexander (born in 1860); granddaughter of John K. Alexander (born in 1829), married in 1853, Jane D. Kestler (1834-1912); great-granddaughter of Marcus Alexander, married in 1811, Malinda McClure; great-great-granddaughter of Thomas McClure, married in Mary Moorehead (born in 1756), & of Charles Alexander, born in 1748, married in Philander Wilson (1752-1829); great-great-great-granddaughter of Abraham Alexander, married in Dorcas ---- (1734-1800).

Sondley's My Ancestry page 112: "While the Revolutionary War was in progress James Alexander, on March 19, 1782, on Allison's Creek in York District of South Carolina, married Rhoda Cunningham, a native of Pennsylvania in territory once thought to belong to Maryland, born October 15, 1763, daughter of Humphrey Cunningham, a Scotch-Irish immigrant. For about two years soon after the marriage James Alexander and his wife resided in York District, South Carolina. A Miss Ware or Wear married in Ireland a Mr. Summerville and, between 1740 and 1750, they sailed for America. On the way they stopped at an island where Mr. Summerville and all the children, except Rhoda left in Ireland, died. Mrs. Summerville survived, reached America, and later married George Davidson and became the mother of General William Davidson killed at Cowan's Ford of Catawba River. Rhoda Summerville, half sister of General William Davidson, came to America. Either before or after her arrival she married Humphrey Cunningham. For a while they lived in Lancaster County, Pennsylvania, from which they removed to York District, South Carolina. The names of their children were Humphrey, James, John (who was drowned in East Tennessee), Rhoda (who married James Alexander), Sarah (who married James Patton, August 3, 1784 in York

District, South Carolina), born December 12, 1765"--see letter of ---- Hannah to Ed Couch, Anthony, Kansas, (which was sent Mr. Sondley from Prairie Grove, Arkansas, Sept, 1921."****Page 114: the records of the Swannanoa Settlement show that William & James Davidson were granted 640 acres where Kenilworth & Biltmore with the southeastern part part of Ashville is, and were joined by their kinsmen the Alexanders & the 1st cabin of James Alexander here was built near the line of Major William Davidson, but later he built another further up Bee Tree Creek--this farm of the Alexanders remains in the family now having passed to the next/youngest son.

Under Act of Congress of 1832, James Alexander was granted a pension for Revolutionary services from 1834 until his death June 28 1844 (buried in the Robert Patton graveyard) which passed on to his widow, Rhoda (by Act of Congress in 1836) until her death Jan.29 1848 (after she died she was buried at Piney Grove Presbyterian Church about 3/4 of a mile from the Robert Patton graveyard and her husbands remains were buried with hers). Their children were: John C. born March 22 1783 married Dec.31 1808 to Jane Patton;

Rhoda, born Nov. 1785 died Sept. 1881 married William McDaniel;

William Davidson born Jan.28 1788 died in youth;

George C. born Sept.10 1790 died Oct. 3 1880 married June 23 1818 Elizabeth Foster;

James Mitchel born May 22 1793 married Nancy Foster (sister of above Elizabeth) Sept.8 1814;

Robert S. born Sept.2 1795 married Jane Wilson May 25 1820;

Rachel born Dec.30 1797 married Dec.2 1824, Moses White;

William Davidson (second child of the name) born Dec.10 1800 married April 21 1825 to Leah Burgin;

Humphrey Newton born June 11 1803, married Dec.26 1826 to Mary Foster; &

Elizabeth born April 10 1826 married Jan.19 1832 to Joseph A. McEntire.

All of these children had families save William Davidson & Rhoda McDaniel.

* On June 26 1934, The Concord Daily Tribune, of Concord, Cabarrus Co. N.C. (a town about twenty miles from Salisbury), published an article written by Janie A. Patterson Waggoner (I think married), called The Four Historic Names On The Phifer Memorial, which monument was erected to honor the Martin Phifer family which consisted Martin (aged 16) & his youngest brother, John, who left Berne, Switzerland, in 1737, settled in Virginia then removed to North Carolina in 1755, when the latter settled in Rowan while Martin settled just across the county line in Anson (at that time) later Cabarrus. (There is a discrepancy here as the writer later says Martin's eldest son, John, was born March 22, 1747, "in Anson County, now Cabarrus" so perhaps their removal to N.C. may have been earlier than 1755.) "According to the inscription of the memorial, John Phifer, eldest son of Martin and Margaret Phifer, was born in Anson County, now Cabarrus, March 22, 1747, and died at 'Red Hill' in 1776. The slab over his grave was so faded by time and mutilated by the British soldiers that the exact date of his death could not be deciphered by the writer." (Red Hill is the name of the Martin Phifer home & remains in the family). John was probably the most illustrious of old Martin's sons, but it is in connection with the third son, Martin Jr., that I, (M.G. McCubbins) have copied the above leading what follows in connection with the Alexander family:

"The following is taken from the 'Genealogy and History of the Phifer Family'; His father being one of the executors of his son John, sent Martin to take care of the children and estate of John. To the house of John he moved with his family and many years kept a public house. Far and near his table was known, he being a great hunter, kept it well supplied with deer and other game, with which the forest abounded. After the death of his father he moved back to 'Cold Water' and built a house on the hill, 'It is there at the 'Red Hill; according to the family tradition, that General George Washington, then the first president of the United States, spent the night with Major Martin Phifer, Jr., May 29, 1791, on his famous inspection tour of the Southland. Elizabeth Locke Phifer, his wife, according to the Phifer history, 'made great preparation for the great man's coming and was sorely disappointed to find her distinguished guest so simple in his diet'. We should also preserve the first visit by Washington in Cabarrus on the same day to the home of General Robert and Sarah Alexander Smith at their home, 'Smithville', now the Harry home, seven miles southwest of Major Phifer's where the President and Major William Jackson, his companion-secretary, dined at noon. Mrs. Smith's first husband was Lieutenant Colonel Moses Alexander. She was before marriage Miss Sarah Taylor Alexander. Through her father she came of a very ancient family, a lenial descendant of the first Earl of Caledon, James Alexander, (1710-1802). Col. Moses and Sarah T. Alexander were the parents of Nathaniel

Alexander, M.D., Governor of North Carolina, and six other children. Their home was on the site of the present Harry home, but only the old kitchen is standing today."

"In Washington's diary kept as a record of his southern tour, which through this section followed the Great Stage road from Charlette to Salisbury and the northern states, President Washington left the following record:

"Sunday, May 29th, 1791'--Left Charlotte about seven o'clock, dined at Col. Smith's twelve miles off, and lodged at Major Fifer's, seven miles farther.

"Monday, 30th--At four o'clock I was out from Major Fifer's; and in about ten miles at the line which divides Mecklenburg from Rowan county; I*****

The above excerpts may be just what you would like to start you upon another line of thought but to give strength will add dates of birth & death of parents of the mentioned sons. Martin Phifer Sr. born Oct. 18, 1720, died Jan. 18, 1791 aged 71 years (the article says he was descended of the Pfeiffers, of Phieffersburg, Germany, & married in 1745, Margaret, the daughter of Caleb Blackwelder, a native of Holland,) Margaret Phifer, born Oct. 29, 1722, died Jan. 18, 1803, aged 81 years.



Hezekiah Alexander of Mecklenburg Co.N.C.

History of Mecklenburg Co.N.C. (by Dr. J.B.Alexander) page 408: "HEZEKIAH ALEXANDER. This member of the numerous Alexander family was a brother of John McKnitt Alexander, and was born in Cecil county, in the northern part of Maryland, in January, 1722. He migrated with his family to the Mecklenburg county in 1754, and was soon assigned a prominent place among the early settlers. He located four or five miles east of Charlotte and in 1764 erected a stone residence on which the date is cut, and is a good house to this day. He was for many years a magistrate and member of the County Court. Foote relates of him that he was "the clearest-headed magistrate in the county", a high compliment. In May, 1775, he served in the Mecklenburg Convention, and in the ensuing September he was chosen a member of the Salisbury District Committee of Safety. In April, 1776, he was appointed paymaster of Col. Thomas Polk's regiment of the Continentals, and the next month he was chosen one of the two members to represent the Salisbury District in the State Council of Safety, on pay of twenty shillings proclamation money for each day's traveling and attendance. He died June 16, 1801."



Heraldic blazoning of the coat of arms of the Alexander family:

Shield—Parted per pale (vertically) argent (silver) and sable (black) a chevron counterchanged (with colors opposite) in base a crescent counterchanged.

Crest—An arm holding balances proper (natural color).

Motto—Per Mare Per Terras. (Latin: "On the Land and on the Sea.")

Black, in heraldic symbolism, denotes death, sin, a dour disposition, mourning and anger, while silver connotes virginity, purity, gentleness and eloquence. The chevron is called an "honorable ordinary," meaning one of the honorable charges most ordinarily used. It is a charge denoting nobility and knighthood. The crescent was the badge of the Mohammedans from whom the Crusaders sought to wrest the Holy City. It was adopted by many Crusaders as their badge. The scales denote justice and refer to the one-time heredity office of the family, "Judges of the West Highlands." The motto is that of the Clan Randall, to which the Alexander family belonged and which they many times headed.

The name, Alexander, is found either as given name or surname in almost every land. It comes originally from the Greek and means "friend of man." Its Celtic form was Alister.
