



That the said party of the first part for and in consideration of the sum of Four Hundred and Forty Five Dollars, the receipt of which is hereby acknowledged, hath sold and conveyed, and do hereby sell and convey to the said party of the second part, all that Tract or Parcel of Land, lying in the County of Cabarras and State of North Carolina bounded as follows: Known as the High House Lands) Beginning on A Maple Standing on the bank of Long Creek by five Maple pointers thence North Eighty Seven & a half East Ninety Four Chains Crossing Two Big Roads to A White Oak Two White Oaks and Black Gum Pointers thence North Twenty three East Thirty Six Chains and Fifty Links to A Stake in the Rowan County Line by Two Post Oaks and Two Pines Thence with Said Rowan County line Twenty Two Chains and Fifty Links to a White Oak in the Old Allen Line by Five White Oaks, the Same Course in all One Hundred & thirty One Chains to three Elms Standing on the west Bank of Long Creek thence Down Said Creek as it Meanders to the Place of Beginning Containing three Hundred & Fifty Six Acres be the Same more or Less To have and to hold the same, with the appurtenances thereunto belonging to them the said party of the second part theirs Heirs and Assigns for ever. And the said party of the first part, for the consideration aforesaid, doth hereby covenant and agree to Warrant and Defend the premises aforesaid, to the said party of the second part, theirs Executors, Administrators and Assigns, against the claim and entry of all persons whatsoever, and do further covenant that he is Seized of the Premises in Fee Simple, and hath power to make and convey such an Estate by this Indenture, and hath done the same by these Presents. Book 33 page 321: Aug. 19, 1837, David McMakin of Cabarrus Co., N.C., as the attorney of William Cox & wife Rachel of Tennessee, let Samuel Riblin of Rowan Co., N.C., have the said Rachel Cox's seventh interest in the estate of her deceased father, Peter Riblin, which is 122 acres on the waters of Dutch Second Creek on the mill-branch of Jacob Holtshouser, beginning at a Spanish oak on the line of Jacob Pewlas & going with it south 100 poles to a dead hickory on the line of --- Beaver, west with the said line 228 poles to a persimmon on the line of Henry Beaver at a black haw bush, north with the said Beaver's line 40 poles to a hickory grub, (now a stake), in the field on the corner of Peter Peeler & the line of Henry Beaver, north 62 degrees east 86 poles with the line of Peeler to a forked white oak on the corner of Peter Peeler, north 51 degrees east 36 poles to a stake by a post oak on the corner of --- Bullen & the beginning corner of --- Peeler, then east 124 poles to the beginning, for \$250.00





Valentine Mauney (of Lincoln, Rowan & Stanley Counties)

History of N.C. (Lewis Publishing Co.), Vol. IV. page 188: James Lee Crowell, born Sept. 26, 1863, near New London, Stanley Co., N.C., (a son of Thomas J. Crowell, son of David Crowell--both born at the same place--son of David Crowell of Halifax Co. N.C., who served as a revolutionary soldier in Halifax County. A number of years before the outbreak of the revolution, John & Edward Crowell emigrated from Woolbridge, New Jersey, to Halifax Co., N.C. & from one of these is descended David, the grandfather of James Lee Crowell, the Concord layer. See Wheeler's History for further information.) Thomas J. Crowell was a farmer & miner, owning 1000 acres--he owned the Crowell Mine, his wife was Margaret Garmon)

James Lee Crowell married Miss Minnie Lee Mauney (a daughter of Valentine Mauney, who was born in Lincoln Co., N.C. of that well known family, who spent many years as a miner in Gold Hill, Rowan Co., N.C., being a member of Barnhardt & Mauney, which mined \$200,000.00 of gold from Jan. 1843 to July 1851, &c.) by whom he had eleven children: Nannie L. (wife of T.C. Newman), Lieutenant J. Lee, Jr., Katherine (wife of P.B. Raeford, Jr.), Valda Mauney, Mary Davis, Ruth, Minnie Lois, Theresa, Eleanor, Sarah & David Crowell.

"This Indenture made and entered into On the Thirtieth day of August in the year of our Lord Eighteen hundred and forty Seven between WM C, Randolph of the County of Rowan and State of North Carolina of the first part and Charles G. Hesse of the County and State aforesaid of the second part witnesseth That the Said WM C, Randolph for and in Consideration of the Sum of Thirty Dollars the receipt whereof is hereby fully acknowledged has sold, bargained and Conveyed and doth hereby grant Sell, bargain and convey unto the said Charles G, Hess a certain lot of land situated on Gold-hill County and State aforesaid, for him, his heirs and assigns to hold Said lot for ever in fee Simple, excepting all minerals, which may be found here-after on Said lot, these to go to Said WM C, Randolph. The boundaries of Said lot as follows, begining on the north corner of G.P(?), Week's lot laying in the Heilig line, running thence hundred feet northwest 47 degrees & thirty Seven & $\frac{1}{2}$ minute to a stake, thence forty feet southwest 137 degrees 37 $\frac{1}{2}$ minute to a stake, thence one hundred feet Southeast paralell with the opposite line to a stake, thence forty feet in G.F,(?) Weeks line to the beginning Corner. The said WM C. Randolph to have the privilege to tunnel under Said lot in search of minerals. McMackin.

The McMackins may have come from Penn. to the edge of Rowan & Cabarrus Cos. in search of gold. These are ancestors of the Mauney's. Buried at Gold Hill Methodist church, to which they gave land as Mrs. Sarah Furr Heilig (widow of George?) was afraid to let the church have any in Gold Hill for fear a mine might be on it. This family is also connected with the Blachs (or Balchs) of Rockey River. The accent is on Mac the 2d syllable, instead of the 1st, as the Davie Co. set pronounce their names. Buried in this Methodist graveyard on the line between Cabarrus & Rowan counties: David McMackin, born Dec. 23 1787 died Dec. 26 1858 aged 71 yrs. & 3 days; his wife Susanna, died Aug. 25 1857 aged 69 yrs. 6 mos & 9 days. Their daughter, Rachel (wife of Ephraim Mauney) born Dec. 3 1824 died of a congestive chill on Jan. 19 1858, aged 33 yrs. 1 mo. & 16 days. Mr. Adolphus Mauney (a descendant of Rachel) says David McMackin's father, James McMackin, was of Pennsylvania, a splendid machinist, whom the Cornish miners sent for to show them how to use the machinery at Gold Hill mines. Ephraim Mauney, born Dec. 15 1812 died May 24 1899; his wife, Eliza Jane (the daughter of J. & R. Davis) died Jan. 1 1880 aged 50 years. 5 mos. & 19 days.

Book 31 page 447: Oct. 28 1830, Isaac Rillin, John Linn & wife Catherine, Henry Jarger & wife Elizabeth, William Cox & wife Rachel—all formerly of Rowan Co.N.C.—let Samuel Rillin of Rowan Co.N.C., have their sevens of 115 acres on Dutch Second Creek next Jacob Powlans, the estate of George M.Geileigh & Henry Peaver, for \$150.00, acknowledged in Aug. 1831 but as Catherine Linn was unable to get to court, she acknowledged at Mocksville N.C. before Thomas McNeely & James F.Martin. (This had belonged to the deceased Peter Ritelin of whom they were heirs).

Book 37 page 256: Dec. 29 1794, John Rogers & wife Silvey of Mecklenburg Co.N.C. let James McMackin of Cabarrus Co.N.C., have 100 acres on Long Creek next George Hoffner, for 40 pounds, witnessed by William Rodgers & Michael McMackin but proved in Nov. 1844 by Jacob Barnhart & David McMackin, as both witnesses are dead.

Book 37 page 255: Feb. 26 1798, James McMackin of Cabarrus Co.N.C.—no wife signs—lets George Michael Heilig of Rowan Co.N.C., have the above for 50 pounds, witnessed by Martin Rintelman & John Rintelman & proved by the latter in Nov. 1844.

Book 98 page 195: Dec. 11 1873, R.J.Holmes & D.C.Reid (as commissioners, on a petition of 1883, showing that J.I.Reid had died leaving heirs, Julius A., William R., James L. & Mary W.Reid who want the land divided, & as R.J.Holmes owned 2/3 jointly with D.C.Reid who has 1/3, so it was sold in Gold Hill April 5 1873), let E.Mauney have 2 tracts (one of 213 acres on both sides Riles Creek & other of 83 acres on Riles Creek next John Canup, Tobias Miller & ---Trexler)—in all 296 acres, for \$267.15, witnessed & proved by Luke Blackmer on Dec. 15 1885.

Book 118 page 142: Aug. 8 1905, Mrs. F.C.Mauney, F.H.Mauney, Mary V.Walton, N.B.McCannless & wife G.F.C., A.C.Mauney & T.L.Heilig (unmarried) let J.R.Faggart & wife Sallie J. (all of Rowan Co.N.C.) have 213 acres "Known as the Kirk land in Morgan Township" on Ryals Creek & a branch next F.H.Mauney, for \$1065.00, witnessed by R.L.Mauney & acknowledged on Aug. 21 1905.

Book 118 page 196: Sept. 28 1908, J.R.Faggart & wife Sallie J. let George H.Peeler—all of Rowan Co.N.C.—have 213 acres "Known as the Kirk land in Morgan Township on Ryals Creek, but excepting 20 acres sold W.C.Waggoner) for \$625.00, acknowledged on the same day. (For the back title see deed from F.H.Mauney in book 118 page 142, also book 68 page 195-6).

Book 11 page 685: Oct. 25 1786, The State grants (#1087 at 50 shillings the 100 acres) to James Madkin 200 acres on the waters of Royals Creek, beginning on the corner of James Lambert & the County-line at a hickory saplin, going east 55 chains to a white oak, north 36 chains & 40? links to a black oak saplin, west 55 chains to a stake on the line of said Lambert, then with his line to the beginning.

North Carolina History (Lewis Publishing Company), Vol. IV page 135; Napoleon B.
McCanless, of Salisbury, N.C., born at Gold Hill, N.C. (died
), was the son of Joseph McCanless, born in 1818 in Iredell Co.N.C., until
about 1845, he removed to Gold Hill & mined until sometime in the Civil War when
he served in the Confederate service until the close of the war he became the
miller as the owner of the mine had recovered it, but later in life he removed to
Winston-Salem, N.C., where he died aged 3 score & 10--he was the son of William
McCanless of Scotland who settled in Iredell Co.N.C. The wife of Joseph McCanless
was Catherine Wasson, who died at Gold Hill, (the daughter of William Wasson), by
whom he had five children; William Lafayette, James C., David A., Laura & Napoleon

The last named tried to enlist in Wheeler's Cavalry but failed, clerked in Sal-
isbury awhile, went to New York in the firm of McCanless & Burrell, of which his
brother, William L. McCanless was the head, & after the death of this brother, trav-
elled while, later returning to Gold Hill where he worked for Amos Howe in the mine,
&c. &c. On April 26 1872, he married Georgia Frances Mauney (daughter of Ephraim &
Rachel (McLackin) Mauney of Gold Hill, by whom he had nine children: Carrie, Mary,
Lena, William A., Kate, John, Walter, Charles & Napoleon Jr.

N.C. History (Lewis Publishing Company) Vol. V page 61: Hon. William Andrew Mauney born in 1841 on the old Mauney homestead in Cleveland Co. N.C., about $\frac{4}{5}$ miles southeast of Cherryville, entered the war in April 1861--see his record--moved to Kings Mountain in 1873, married 3 times: first to Susan Ramseur by whom had Ida (wife of C.E. Neisler), Laura (wife of W.A. Ridenhauer) & Hunter (married Jessie Munday); married second Carrie Hope by whom no living children; married third Candace Miller (by whom had Bonnie & Virginia).

The parents of Hon. Wm.A. were David Mauney by Fannie Carpenter--both of what is now in Gaston Co. N.C. David was born in 1814 & died in 1900, son of Peter Mauney by wife Barbara Heavener. Peter was the son of Christian Mauney who received a tract of 350 acres on Beaver Creek on Sept. 8 1770 & by act of N.C. Assembly, a part of his land was purchased for the county-seat of Tryon County--this county ceased to exist in 1779 so the county-seat became the seat of the new county Lincoln until a new one was established in 1783 at Lincolnton. (Tryon was divided into Lincoln, Gaston, Catawba, Cleveland & others). On the Christian Mauney place the Tryon Declaration of Freedom was proclaimed in 1775 & Lord Cornwallis camped here on his march through Lincoln County.

Christian with his brothers, Jacob & Valentine Mauney, of German lineage, came from Pennsylvania to North Carolina in colonial days. Valentine got a grant on Nov. 3 1762 on Indian Creek in what is now Gaston County & Jacob got a grant on April 19 1763.
