Page 298: Rodman Corse Pell of Florissant, Colo., joined the Illinois society as #12 (general society #747), as 6th in descent from Deputy-Governor William Robinson; 7th in descent from Colonel Thomas Willett & Zoeth Howland; Major John Pell & 8th in descent from Governor Walter Clarke.

Page 97: Howland Pell of New York joined the N. Y. society as #15, (general society #15 also), as 6th in descent from Ensign Joseph Lawrence & 7th in descent from Capt. William Lawrence, Col. Thomas Willett, Col. Richard Townley, Zoeth Howland & Major John Pell.

Page 154: Rodman Wister of Philadelphia, joined the Pennsylvania society as #119, (general society #1323) as 4th in descent from Owen Jones, William Logan & Thomas Langhorn Biles; 5th in descent from James Logan, Hugh Evans, William Biles Jr., & Joseph Kirkbride Jr.; 6th in descent from William Biles Sr., Joseph Kirkbride Sr., Robert Owen, Dr. Edward Jones, Thomas Langhorne; 7th in descent from Governor Walter Clarke, Dr. Thomas Wynne, Richard Borden, Albert Albertson Stoothoff; 8th in descent from Thomas Cornell & Jeremiah Clarke.

Society of Colonial Wars (1897-1898), page 537: John Rodman, (1679-1756), was a Member of the King's Council 1738-1756 & a Member of the Court to settle the controversy between the Mohegan Indians & the Colony of Connecticut in 1749. Page 537: William Rodman, (1720-1794), was a Member of the Assembly of Pennsylvania 1764-1775 & a Commissioner to negotiate with Indians at Fort Pitt in 1768. (Only Charles H. Jones, page 143 & Richmond Leigh Jones, page 144, joined on his services).

Page 149: John Rodman Paul of Philadelphia, joined the Pennsylvania society as #29, (general society #150) as 5th in descent from John Rodman.

Same page: Lawrence Taylor Paul of Villa Nova, joined the Pennsylvania society as #92, (general society #687), as 6th in descent from John Rodman.

Page 447: Thomas Cornell, (---- 1656), of Westchester Co., N.Y., was an Ensign of the Portsmouth, R.I. Militia 1642-1644 & served under Gov. Kieft against the Indians. (Those joining on his services were Abraham B. Valentine, page 122, Charles H. Jones page 143, Rodman Wister page 154, Leonard B. Almy page 217, James T. Smith page 314 & William E. Almy page 338.)



Thomas Redman (Dropping Off Branch of Rockey Creek)

Book 9 page 576: Oct. 10 1783, The State grants (#228 at 50 shillings the 100 acres) to Thomas Johnston 200 acres on Dropping Off Branch of Rockey Creek in the cove of the mountains next Thomas Redman on the spur.

Book 9 page 589: Oct. 10 1783, The State grants (#277 at 50 shillings the 100 acres) to Thomas Redman 130 acres "On the Dropping off Branch of Rocky Creek Joining the lines of Lazarus Whitehead and Thomas Johnston Beginning at a Post oak on the Spur of the Mountain Whiteheads corner" & going south 192 poles to a black oak, west 208 poles, crossing the creek, to a post oak, north 120 poles to a black oak on the spur of the mountain, north with the line of Johnston 43 degrees east 100 poles to a pine, then to the beginning.

Book 9 page 542; July 29 1784, Lazarus Whitehead--no wife signs--lets William Johnston (both of Rowan Co.N.C.) have 100 acres on Dropping Off Creek waters of Rockey Creek on the south end of Charles Jolly, Lazarus Whitehead, Job Coles & his old survey, for 20 Or 90 pounds & 10 shillings, witnessed by Wm. Sharpe, Reuben Fletcher & John Roberts & proved by William Sharpe in Aug. 1784. (This is a subdivided tract of 410 acres granted by The State to Lazarus Whitehead on Oct. 10 1783).

Book 10 page 142; Oct. 10 1783, The State grants (#439 at 50 shillings the 100 acres) to Lazarus Whitehead 410 acres on Droping Off Creek waters of Rockey Creek next the side of the mountain next Job Coles, Thomas Redman, crossing the creek & by a small branch.



Jane Redman

Biographical & C. History, (Lewis Pub. Co.), Vol. IV, page 72: Dr. William C. Greene of Wilkesboro N.C. (now retired), born Dec 3, 1842 in Alexander Co. N.C. was the son of John B. Greene (who died when nearly 80 years old), & wife, Jane Redman, (born in Yadkin Co. N.C., died aged 91 years, the daughter Rosa Redman by Jucretia Williams) who had five children: Jucretia Adeline, William C., Martha Jane, Emma & Arthur Judson.


Dr. Wm C's grandfather Greene was of Massachusetts, bought a farm eight miles east of Rutherfordton, N.C. which he cultivated with slaves until his death & here, in Rutherford Co. was born John B., farmed & freed the 22 slaves remaining after the war, became a partner of his brother, Cromwell, in merchandising, etc. Dr. Wm C. Greene was an officer in this war on the Confederate side, & for about 60 years has practised as a dentist & physician. In July 1865, Dr. Greene married Laura (born May 21 1841, the daughter of Joseph Gray of Davie Co. who later moved to Yadkin Co & finally bought the Gov. Stokes farm in Wilkes Co. N.C. married Mary Kelley - who died about fifty five years of age leaving 1 son & 5 daughters: William, Elizabeth, Juliet, Mary Ida, Laura & Josephine.

Dr. Greene & wife had two children, both now dead, Herbert, who ~~married~~ gave Willburn & left four (Gray, Louise, Mary & Ida), & Ida, who married Robert Stafford & had Ida.

Iredell Co.N.C. book S page 139: Jan. 6 1835, Agnes, Robert G. & Letty Martin let William Chenault--all of Rowan Co.N.C.--have 351 acres next Samuel Williams, the field of --- Sharpe & the creek, for \$500.00, witnessed by Humphrey Roberts & Thomas M.Gaysbell & proved by the latter in Aug. 1836.

Iredell Co.N.C. book O page 478: Nov. 12 1827, the heirs-at-law of deceased Samuel Williams, (who are Edward, Samuel, Theophilus, Alexander & Hiram Williams, John, Lucretia, Hosea & Jean Redman) let Argelus Hardin--all of Iredell Co.N.C.--have their eight shares in 100 acres on Droping Creek of Hunting Creek next James Dishman & ---Redman; also their interests in what the widow, Sarah Hardin, got, for \$20.00 each, witnessed

Iredell Co.N.C. book 2 page 145: The will of Argelois Hardin made Aug. 20 1830, if he never returns from the west, wants Uncle Samuel Williams to have \$50.00, to collect notes &c. & divide proceeds between my sisters Adlai & Miranda (Adlai to have the land on the east side of the branch & Samuel to have on the west side after death of my mother)

Reuben GEORGE of Stokes Co.N.C.

Stokes Co.N.C., book 3 page 412: Dec. 4 1798, Gray Bynum--no wife signs--lets Reuben George (both of Stokes Co.N.C.), have 250 acres on both sides of Neatmans Creek, beginning on the north line of his mill tract, on the west side of Peavine Branch, for 260 pounds current money

Book 3 page 16:--- -- 1797, Micajah Coffey--no wife signs--lets Reuben George (both of Stokes Co.N.C.), have 249 $\frac{3}{4}$ acres on the waters of Mill Creek & Panther Creeks, on the south side of Mill Creek, for 100 pounds,

Professor George says the coldest day he ever felt was
when his aunt, Docia George (the youngest child, who married William Gray Hampton of Yadkin County aristocratic family, son of Henry? Gray Hampton the sheriff, lived at Jonesville N.C.) lost her husband & died at High Point N.C. was buried

Reuben George of Virginia

N.C. History (Lewis Publishing Company) Vol. V page 65: Thomas Millard George, educator & editor of the leading paper of Mount Airy, was born Jan. 15 1852 in New Hope Township, Iredell Co.N.C., married in Dec. 1883, Mary Critz (also a teacher, born in Davie Co.N.C., daughter of Heman & Elizabeth (Frost) Critz) by whom had: Lillian, William Fiske, Wesley Critz & Mabel Elizabeth.

The parents of Thomas Millard George were Wesley Hensley George, born June 1810, in Stokes Co.N.C., (who had a natural gift as a mathematician & "developed exceptional skill as a surveyor",) & Arena Redman (she was born in Iredell Co.N.C., daughter of John Redman by wife Jane Williams; granddaughter of Thomas Redman of Irish ancestry who was born in Virginia, among the pioneer settlers of Iredell County, where he & wife Mary reared a large family--a farmer as was his son, John. It is thought that the father of John's wife, Samuel Williams, was born in Davidson Co.N.C. of Welsh ancestry but moved to Iredell where he too farmed). Mrs. Wesley George died at the age of seventy four--her first husband was William Chenault by whom there were three children (Abner, William & Mary), by her second husband there were seven children: John Franklin, Martha, Reuben Harrison, Julia, Thomas Millard, Isadore & Dacia. Her second husband was a whig, elected twice to Legislature & served in the Constitutional Convention of 1868. He bought a farm in New Hope Township & taught school but in 1872 bought a farm in the western part of Yadkin County where he died in 1880.

Isaac George was born in Virginia, became a pioneer settler of Stokes Co.N.C. but moved to Iredell County, quite late in his life, about 1840, he removed to Indiana with some of his family, accompanied by his wife, a son & two daughters, bought land near Knightstown where he died nearly eighty years of age--his wife, a Miss Hensley who was born in Virginia, & by whom he had reared five children (Enoch, Wesley H., Elizabeth, Mary & Reuben) then went with a son to Litchfield, Ill. where she died.

The great-grandfather was Reuben George, was born in & spent most of his life in Virginia (the remote ancestors were Welsh settlers of Maryland) was with the Virginia troops in the Revolutionary War. Two of his sons went to Ohio & two to North Carolina--one being the Isaac just mentioned.

Born Jan. 1, 1812; married William Chenault in 1834. William Chenault was born in 1806 and died in 1839. From this union were three children: Abner, Redman Born June 5, 1835; attended the old field schools in neighborhood, the well known Academy of Hill and Burk, at Taylorsville, Ebenezer Academy, founded by Rev. James Hall, at Bethany, Iredell, Co., while there boarded in the Col. Allison home. Later went to Missouri and graduated from William Jewell College, married Ella Estes taught school for short time; engaged in agricultural, stock-raising, and Mercantile pursuits. He became wealthy owning at one time some 1400 acres of Missouri river bottoms and other valuable holdings. He died at Richmond Mo., Dec. 11, 1907.

William Washington, graduated from the Baltimore college of Medicine about 1860, married Bettie Sherrill, of Catawba, located at Catawba for the practice of medicine; soon thereafter was made Captain of a Company of Confederate soldiers. He died of congestive chills, at Petersburg some time of the period of the civil war.


Mary Jane, born Nov. 18, 1838; married Offie G. Williams ad lived her entire life in Iredell county; died about 1910.
