Sons: Joseph (part of the plantation), James (land on north side of South River) John & Johnza (150 acres on west of my plantation). Daughters: Jinsey Robinson Orten, Rachel & Eliza Beth. Witnesses: John Orten & Thomas Summers (test). A codicil on April 10 1807 mentions his daughter Eliza Beth Wilson.

May 2 1808; Administration on the estate of Jennet Orten is granted James Orten & Joseph Campbell who qualified & gave bond of 200 pounds with Henry Hughey & Francis Neely. " is appointed guardian of Jane, the orphan of Joseph Orten, & gave bond of 500 pounds with James Orten & Francis Neely.

Book 12 page 504: Nov. 16 1790, The State grants (#1967 at 50 shillings the 100 acres) to Joseph Orten 480 acres on both sides South Yadkin next his other land, Thomas Bean & John Morrow.

Book 12 page 665; Nov. 16 1790, The State grants (#1981 at 50 shillings the 100 acre to John Morrow 380 acres on the north side of South River next Joseph Orten, Thomas Bean & William McGuffin.

Book 23 page 710; May 30 1815, Adlie Campbell of Indiana Territory (as the executor of Joseph Campbell), through his attorney, John Fulton, lets John Harris of Rowan Co. N.C., have 319 1/2 acres next Robert Johnston, John Kellie, John Harris & said Campbell, for \$197.00, witnessed by Daniel Clary, & D. Woodson & acknowledged by John Fulton in Feb. 1816. (This is done in accordance with the will and an agreement with said Harris & said deceased but Rebecca Campbell is to remain in possession while she lives. This was granted by The State to said deceased).

The will of John Campbell (book I page 43) made Feb. 15 1838 & probated in Aug. 1838. Brother Adlai Campbell (\$6000.00 if he is still living, if not then to his children) & the remainder goes to the children of brother Joseph Campbell. Sisters: Rebekah Orten (\$6,000.00 if she still lives if not then to her children), Rachel Orten, Hannah Hall & Margaret Leach each of whom gets \$1,500.00 each. The same amount goes to each of Nathan, Robert V., Adlai & Aaron V. Cowan. Exrs: Maxwell Chambers of Salisbury N.C., & Adlai Campbell of Indiana & he wants them to locate those living by advertising in the papers of western North Carolina &c.

Aug. 20 1838; The will of John Campbell is proven by Robert N. Fleming (a witness who says it was found among his valuable papers). Maxwell Chambers qualified &c. May 6 1839; Adlai Campbell (one of the executors of John Campbell) renounced his right to execute.


