Page 159 of the History of the Allison Family. Fifth branch of N.C. Allisons: "760. Andrew Allison¹ had a son, 761. Theophilus Allison² who was born in 1747; settled in Iredell county, N.C. There is a tradition that he was born in Scotland, that he first settled in Pennsylvania, lived for a time in Georgia, and then made North Carolina his home. He married Sarah Simonton, and died Oct. 5, 1815. CHILDREN.

762. Thomas Jefferson Allison³ (765), b. Oct. 25, 1801; d. Jan. 28, 1839; res. in North Carolina.

763. Robert Allison,³ b. in Georgia; is deceased. His son, I. 764. John A. Allison, res. Granite Hill, N.C.

765. Thomas Jefferson Allison³ (762) (Theophilus,² Andrew¹). He was born in North Carolina, Oct. 25, 1801; resided at Troutman's Iredell county N.C. He was prominent in his locality, was a member of the Associate Reformed Presbyterian church, and was an elder in one of the oldest churches in that section of North Carolina. He married Jane, daughter of William and Ann (Allison) Neill, of Lincoln county, N.C. Her grandfather was Andrew Neill, of Rowan county, N.C. Mrs. Allison was born Oct. 17, 1803; died June 9, 1860. He died Jan. 28, 1839. CHILDREN.

766. Theophilus Washington Allison,⁴ b. Nov. 6, 1827; res. Salisbury, N.C.

767. William Lafayette Allison,⁴ b. June 8, 1826, m., July 25, 1861, Asenath Cavin, and is still living; res. Troutman's, N.C. Children: I. John Washington Allison,⁵ b. June 3, 1868; m. Laura Cornelia Sherrill, Dec. 22, 1889. She was b. March 12, 1865. II. Thomas Young Allison,⁵ b. Feb. 3, 1867. III. William Elmore Allison,⁵ b. Jan. 12, 1868; res. Leesburg, Fla. IV. 768. Andrew Neill Allison,⁴ b. May 11, 1829; m., Aug. 21, 1861, Jane Elizabeth White; res. Iredell Co., N.C.

769. Richard Allison⁴; is deceased.

770. Thomas Jefferson Allison⁴; is deceased.

771. Julia Ann Allison,⁴ b. May 31, 1833; d. of consumption, June 5, 1861. She and her sister were devoted Christians, and noted for their kindness and philanthropic principles.

772. Sarah Kesiah Allison,⁴ b. Oct. 4, 1838; d. Oct. 16, 1858.

773. Andrew Neill Allison⁴ (768) (Thomas Jefferson,³ Theophilus², Andrew¹). He was born May 11, 1829, married, Aug. 21, 1861, his cousin, Elizabeth White. His parents were wealthy, and his early life passed in ease and luxury. He attended the public school, but the educational facilities in the south were very limited, and received so little approbation that his education was quite limited. The war freed the slaves belonging to the family, so that when it closed he was compelled to work on the farm, but work did not go as hard with him as with many, and he became a successful and prominent farmer. He still lives on the Allison homestead. He is prominent in county politics; an elder in the Associate Reformed Presbyterian church; a man of good judgement and spotless character; residence, Troutman's, Iredell county, N.C. CHILDREN.

Sons: William (the plantation where he lives in Lincoln Co. also where I now live but he must pay my daughter, Sarah Falls \$200.00) & Gilbreth (200 acres on the east end of my big meadow while he lives then it is to be sold & proceeds divided among his children excepting Jehn, wh who gets the big meadow & Andrew who gets the Gilleland tract). Granddaughter Resanah Allison. Exrs: sons William & Gilbreth. Witnesses: Andrew Ramsey & Robert Cook.

717. Rebecca Allison, 4 m. Thomas Jones. They are deceased.
718. Elizabeth Allison, 4 m. John Chambers. They are deceased. Joseph Chambers, Booneville, Mo., is a grandson. Frank Chambers, 7 county clerk, Booneville, Mo., is a great grandson. William H. Allison, 6 of Clinton, Henry Co., Mo., is a grandson.
719. Matilda Allison, 4 m. Thomas L. Johnson, and both are dead.
720. William Allison, 4 d., unmarried, of yellow fever at New Orleans, La.
721. Hugh Allison 3 (707) (William, 2, ---Allison 1). He was born near Jacksboro, Wilkes county, North Carolina, Feb. 11, 1771; resided at Ft. Boonesborough, Madison county, Ky., after 1797, and lived in Cooper county, Mo., after March, 1821, where he died April 25, 1846. He married, Nov. 5, 1788, Rebecca Sanders Hartt. Hugh Allison was a fair business man. Was elected coroner of Cooper county, Mo., August, 1824, and again in 1828, serving eight years in all. As a military man he served three years in Colonel Whitley's regiment of volunteers in 1812-'13-'14, and was in Harrison's army, was at the battle of Lundy's Lane. After his discharge he was commissioned a captain in the Kentucky militia. He always declared that he would gladly have fought three years longer rather than to have let Great Britain have one foot of ground in America. He was a fiery patriot and was ever ready to serve his country. He was a believer in a sound national currency that was worth one hundred cents on a dollar anywhere on earth. In 1840, by appointment, he met and spent a short time with Gen. W.H. Harrison, the Whig candidate for president, at Vincennes, Indiana. On July 4, 1840, he was present at the grand Whig rally at Rochefort, Mo., it being one of the largest political gatherings ever held in the state. There are said to have been 17 steamboats loaded with people who came to attend" *** "CHILDREN.
- 721a. Rebecca Allison, 4 b. about 1791; m. James Pearce, and after the close of the war of 1812-'15, they settled in Illinois, and some of this family lived in Alhambra, Madison county, Ill.
722. Jesse Allison, 4 b, Sept. 29, 1791; m. Mary Snodgrass, in 1809; served in the U.S. army in 1812-'13-'14. Went to Illinois in 1821, Co. Madison; rem. to Cooper Co., Mo., in 1840, and later to Arrow Rock, Saline Co., in fall of 1859, and d. there about March 1, 1860. James Allison, Yuba Dam, Yuba Co., Cal., and Dr. John L. Allison, Poplar Bluff, Butler Co., Mo., are of that branch of the family.
723. Lucinda Allison, 4 is deceased; she was b. Feb. 6, 1793.
724. Thomas Allison, 4 b. in North Carolina, Sept. 4, 1795, Res. Wilkes Co., N.C., Madison Co., Ky., and in St. Charles Co., Cooper Co., Pettis Co., and Lawrence Co., Mo. He enlisted in the militia against the rebels in 1863, being over 66 years of age, and was killed near Mount Vernon, in Lawrence Co., Mo., about May, 1863. He m. Roxanna Snyder in 1816. He m. second, Nancy Orr, in 1856. Children: Nathaniel T. Allison, 5 Greene P. Allison 5, Martin S. Allison Hugh Allison 5, Elizabeth Allison 5, Rebecca Allison 5, Lucinda Allison 5, John L. Allison 5 (was a soldier in the state militia during the war), Thomas F. Allison 5, Frances Allison, 5, Mary Allison 5, Louisa Allison, 5 Henry C. Allison 5, Roxanna Allison 5, who m. Frank Payne; Hughesville, Mo. Mrs. Absalom McVey was of this family; res. Sedalia, Mo. --- Allison 5, his dau.; m. James Dapsley; res. Diamond Grove, Newton Co., Mo. Monroe Allison 6, grandson of Thomas Allison 4, lives in Silverton, Colorado.
725. Nathaniel Thompson Allison, 4 (735) b. Ft. Boonesborough, Madison Co., Ky., April 29, 1798; m. Ruth Goodrick, and d. March 18, 1877.
726. John L. Allison, 4 b. in North Carolina, Aug. 22, 1801. He lived in Wilkes Co., N.C., Madison Co., Ky., St. Charles Co. and Cooper Co., Mo. Farmer. He d. about 1844. Children: I. Shelton R. Allison, 5 went to Richmond, Ft. Bend Co., Texas, about 1859. II. Lucinda Allison 5 removed to Richmond, Ft. Bend Co. Texas; about 1859.
727. Thomas Allison 4 (714) (Ephraim, 3 William, 2 ---Allison 1). He was born in North Carolina Oct. 24, 1800, and emigrated with his parents to Missouri when fifteen years of age. He married Lydia Jones; resided in Henry county, Mo., and died in Saline county, in Feb., 1865. CHILDREN.
728. Josephine Allison, 5 m. William Claycomb, and lives at Herndon, Saline Co., Mo.
729. Selinda Allison, 5 m. William Adkisson, and died at Warrensburg, Mo., in 1885.

(There is much more to this family but it is out of my region).

The History of the Alison or Allison Family in Europe and America from 1135 to 1893, by Leonard Allison Morrison, A.M. (published in 1893 by Damrell & Upham, of Boston, Mass.), chapter VII., page 144, tells of five brothers by name Allison, "born in Pennsylvania (one account says in Ireland), lived on the Yellowstone River in that state, and between 1760 and 1770, and before the War of the Revolution, they moved to North Carolina, while their brother, James Allison, remained in Pennsylvania. They were of that strong Scotch stock which went from Scotland to Ireland, and later to Pennsylvania, New Hampshire, and the southern states, and who have been such magnificent builders of states and commonwealths. They settled in Iredell and Mecklenburgh counties, where the name to-day is very common. The names of these emigrants to North Carolina were:

579. William Allison¹ (586), who resides at Bethany Church, N.C.

580. John Allison¹, married, first, a sister of Colonel Richard Allison, of Iredell county, N.C. The relationship between them is not known. There was no issue by this marriage. He married a second time.

581. Polly Anderson², his daughter, married her cousin.

582. James Allison², son of Robert Allison¹. Mr. Allison lived at Poplar Tent, Mecklenburgh county, N.C.

583. George Allison¹, settled in Mecklenburgh or Iredell county, N.C.

584. Thomas Allison¹, born 1743, was never married. He was a school teacher of renown, and was widely known as "Master Allison". He died in Nov., 1811, aged 68 years. A sister of these five Allisons married a Mr. Todd, settled in Mecklenburgh, N.C., and their descendants live in that county today.

585. Robert Allison¹ (588), born in 1750; married Sarah Graham; resided on Clark's Creek, Cabarrus county, N.C.; died in 1804, aged 54 years." See notice in account of the Allisons of Pennsylvania, in letter of Rev. James Allison, which precedes No. 460. (Page 126: "Rev. James Allison, of Pittsburgh, Penn., in a personal letter, Dec. 17, 1890, says: "Part of the Allison family, to which I belong, went to Mecklenburg county North Carolina, nearly one hundred and fifty years ago. Many of the descendants are still there (see sketch of Allisons of North Carolina, No. 579). Another part went to Virginia, and thence passed on into Indiana (see Allisons of Indiana, No. 463). One family of the part that went to North Carolina returned to Cecil county, Maryland, and afterwards removed to Washington county, Pennsylvania. One of its number (Hon. James Allison, No. 485), afterward going to Beaver county, Pennsylvania, served in the Eighteenth congress and was reelected to the Nineteenth, but declined on account of ill-health. The late Hon. John Allison, register of the United States Treasury, was his son (see sketches of Hon. James Allison, and of his son, Hon. John Allison, No. 486). The father of Hon. William B. Allison, United States Senator from Iowa, removed from the Cumberland valley, Pennsylvania, to Bellafonta, Pennsylvania, and then to the Western Reserve, Ohio, where William B. Allison was born (see sketch of Hon. William B. Allison, No. 489). One of my grandfather's brothers went from the Cumberland valley to Erie, Pennsylvania, where his descendants still live (James Allison and his descendants of Lake Pleasant, Erie County, Pennsylvania, may be this family. See notice of them, No. 490). Another went to Butler; and my grandfather himself removed to the south side of the Monongahela river, near this city, in 1810, and afterward to a place ten miles north of this city, where he resided until his death."

"460. James Allison⁴ (James³, George², --- Allison¹). 1 Rev. James Allison was born in Pittsburgh, Penn., September 27, 1823; married, August 6, 1851, Mary Jane, daughter of Robert Anderson, who was born in Lancaster county, Penn., and who lived in Washington, Washington county, and in Sewickly, Alleghany county, Penn. Mrs. Allison was born and died in the latter place. He married, second, November 6, 1855, Caroline, daughter of Hon. John M. Snowden. She was born in Pittsburgh, Penn. Mr. Allison graduated at Jefferson College, Penn., in the class of 1845, taking the first honor. He studied theology in the Western Theological Seminary, Alleghany, Penn. In 1848 he took charge of the Presbyterian church at Sewickley, Penn., fourteen miles from Pittsburgh, where he continued to be pastor until 1864" &c. A footnote says this Rev. James Allison is the son of James & Elizabeth (Brickett) Allison, grandson of George & Susan (McRoberts) Allison, son of the emigrant --- Allison of the north of Ireland.

An account of the Allisons furnished by the Indiana family (a branch of the Pennsylvania family) gives:

463. George Allison¹ settled in Iredell Co., N.C.

464. William Allison¹ settled in Charlotte, N.C.

465. John Allison¹ settled in North Carolina.

466. Thomas Allison¹ settled in North Carolina; was a teacher.

467. Robert Allison¹ settled in North Carolina; see sketch of North Caro-

lina Allisons.

468. James Allison¹ (469) m. Miss Young; res. Donegal, Penn., near where Harrisburg now stands. Had three sons & possibly other children. (More to this but it will hardly concern me so will not copy it).

"588. Robert Allison¹ (585), one of the five brothers who went south from Pennsylvania, between 1760 and 1770, probably, was born in 1750, and settled near Charlotte, N.C., and married Sarah Graham.¹ Mrs. Allison was a sister of Joseph Graham, the father of Hon. William A. Graham, once governor of North Carolina, and candidate for vice-president of the United States on the ticket with General Winfield Scott, in 1852. Mrs. Allison was the aunt of Miss Graham, sister of Hon. William A. Graham, who married Rev. Hall Morrison, D.D., and one of their daughters married General D.H. Hill, and another married General Thomas J. Jackson, known as "Stonewall" Jackson. In 1790, Mr. Allison removed to Poplar Tent on Clark's creek, in what is now Cabarrus county, and was a ruling elder in the church there. He died in 1804, aged 54 years. Mrs. Allison was delicate in appearance, had great energy, and was a fine manager and a strong Presbyterian. CHILDREN. 589. William Allison (599), born Oct. 7 1780; m. Peggy Young; res. Continuing the children of Robert & Sarah Graham Allison: "592. Thomas Allison², (605), born March 5 1785; m. Sarah Young, a sister of his brother William's wife; res. Poplar Tent, Cabarrus Co. N.C. 593. Anne Allison², m. Sandy McKinley, of Rocky River, N.C., and d. young. Child; Fanny McKinley³, who m. Rev. Cyrus K. Caldwell. 594. John Graham Allison², m. Almira, dau. of John Johnston. They died without children. 595. Sarah Allison², m. W.C. Johnston, son of John Johnston. Their son, 596. Robert Allison Johnston³, m. a Miss Reeves."

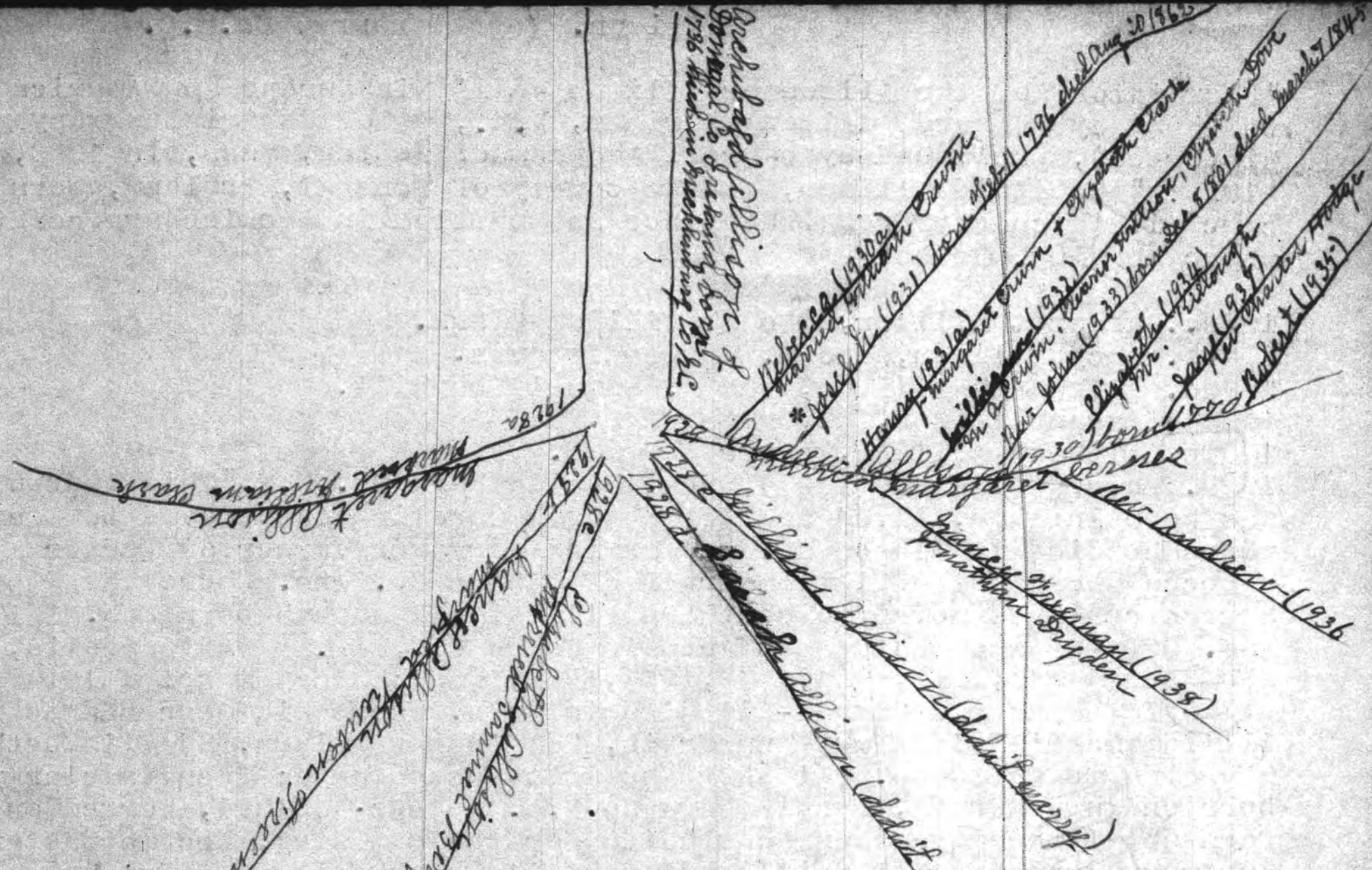

"JARVIS H. ALLISON. Jarvis H. Allison was born at the home place on Jonathan's Creek, June 19, 1887. After receiving his education in the public schools of the county, he became a teacher in the county system for a number of years. For a time, he was principal of the Sannock elementary school in the Waynesville district. He retired from the teaching profession to go into the dairy business. His dairy farm near Waynesville is in the grade A class and is one of the best in Haywood County.

"Going into politics in 1930, he was elected to membership on the board of county commissioners, one of the big pieces of work during his term on the

The Allison Family of Jonathan's Creek, Haywood Co.N.C.

The Annals of Haywood Co.N.C., [W. Allison in 1955] page 393: "Joshua Allison, the first of the name to come to what is now Haywood County, was born and reared in the Piedmont section of North Carolina. His parents had settled there some time prior to the Revolutionary War. About the year 1800, he came to the Jonathan's Creek valley and purchased a tract of land, on which he built a home, where he lived until his death. He was one of those early farmers that helped to give prestige to that valley as a fine agricultural community.

"He married Annie Williams and reared the following children: Jason, who made his home in South Carolina; Asop, who went to Alabama but later moved to Texas; Hesikiah, who became a citizen of Alabama when that State was new and undeveloped. Only two of the children of Joshua Allison remained in Haywood County, as follows: Daniel, who was born March 3, 1814, married Lucinda Henry, who was born March 6, 1814; and Nancy, who married Wilson Barton.

"Daniel was born on his father's farm. He reared the following children: Joshua H. Allison was born in 1845; Marjoram S. Allison, who was born in 1846; Meek H. Allison, who was born in 1848; Asa, who was killed in the War Between the States; David, who when a young man went to the Great West and was never heard from; Nancy Ann, who married Arch Justice; and Paralee, who married H.F. Caldwell. Three of these men were soldiers in the Civil War.

"Daniel Allison was also a soldier in the great war of 1861 to 1865. One day near the close of the war, he and three of his sons, who had been either discharged from service, or had come home on a furlough, Joshua, Marjoram, and Meek, were following the road up the creek to join in the pursuit of the marauders, George W. Kirk and his band, when they met a squad of Kirk's men in the road near the Boyd farm. The marauders opened fire upon them. Daniel was struck in the breast with a bullet but managed to escape death and capture; Joshua slid off his horse in the noise and rolled under the bank of the creek, was taken prisoner, but managed to escape from his captors near the White Sulphur Springs; Marjoram and Meek were captured and taken to Cam

hickory. north 25 chains to a black oak, west 48 chains to a black Jack oak, south
51 chains to a white oak, west 22 chains, south 30 chains to the beginning, for
10 shillings sterling, with the yearly rent of 20 shillings, 3 pence, half penny,
(which is at the rate of 3 shillings sterling the 100 acres), witnessed by Richard
Vigers & William Churton & proved by the latter in Oct. court of 1758.
Feb 15 1770: Deed from Andrew Allison to Thomas Allison for 507 acres Feb. 15 1770
is proved by John Frohock.

Book 7 page 183: Feb. 15 ----, Esq. Andrew Allison--no wife signs--binds himself
with 50 pounds, to let Thomas Allison (both of Rowan Co. N.C.), to have the above
tract, witnessed by John Frohock & Griffith Rutherford & acknowledged the receipt
of the money in Feb. court of 1770.

Book 8 page 264: Aug. 22 1774, Thomas Allison, a Gentleman of Rowan Co. N.C., & wife
Martha, let the merchant, Hugh Montgomery, of Salisbury, N.C., have 507 acres on
both sides of Poplar Branch waters of Grants Creek, a branch of Grants Creek which
is a branch of the Yadkin River, (beginning the same land which Andrew Allison warranted
to the said Thomas Allison on Feb. 15 1770,) for 250 pounds proclamation money, wit-
nessed by Theophilus Allison & Alexander Brown & proved by the latter in Feb. court
of 1775. It begins at a white oak on the line of Francis Lock, goes east with his
line 55 chains to a hickory, south 20 chains to a hickory, east 18 chains to a white
oak, north 76 chains to a hickory, west 3 chains to a hickory, north 25 chains to a
white oak, west 48 chains to a black ack oak, south 51 chains to a white oak, west
22 chains, then south 30 chains to the beginning.
