Atlanta Journal "Answer to Query # 857g., A.H.McH., Sept. 7, 1930. My father's name was Matthew Martin, grandson of Matthew Martin, Jr., who married Susannah Harrelson, of Marion County, S.C. He was son of Matthew Martin, Sr., but I do not know his wife's name. He served in the Revolution in Gen. Francis Marion's army. He was granted land in South Carolina, and settled near Mullins, S.C. His land is bordered by Maiden-down Swamp. There was also a Matthew Martin in Massachusetts. I wonder if your Matthew Martin Jr., is not my Matthew Martin, Sr.? I shall be glad to correspond.---MRS. HENRY BERRY, Marion, S.C. (Note.---I have the Massachusetts Martin Genealogy--my own ancestors. It may be seen in my office. In the appendix is a list of all the Martins who applied for pensions for the Revolutionary War, the war of 1812 and the Mexican War. A little of their family history is given in each case.---Editor.)



The Charlotte Observer of Sunday, Oct. 31 1924, contains an article by Dr. Archibald Henderson with caption, "JACKSON'S HISTORY-MAKING PILGRIMAGE ACROSS NORTH CAROLINA MOUNTAINS", in which his own family was brought in, as usual, "The name of Alexander Martin, famous in our history, has a certain association with the name of Andrew Jackson. Martin, born in Lebanon, Hunterdon county, New Jersey, about 1738, and graduated from the College of New Jersey, September 29, 1756, emigrated to North Carolina about 1760. In the little hamlet of Salisbury, he at once established himself as a merchant; and the following advertisement appeared in the Pennsylvania Gazette of December 10, 1761, 'Notice is hereby given to Alexander Martin, merchant, in Salisbury, N.C., that his father, Hugh Martin, of Hunterdon County, New Jersey, died 9th March last, and left him and his brother James executors of his will; wherefore, said Alexander Martin, if not inconvenient to his business, is desired to return home, to settle his late father's affairs, but if his coming should be attended with disadvantages to him, he is requested not to come by his mother, Jane Martin.' Dr. A. Henderson adds more about the different affairs of Alexander Martin, (some too well known to copy,) who moved to Guilford Co. N.C. in 1772, influenced possibly by Thomas Henderson (brother of Judge Richard, president of the Transylvania Land Co.) who had married Jane, (the sister of Alexander Martin). Reuben Searcy, Clerk & Sheriff of Granville, Co., N.C., married Susan Henderson (a sister of Richard, Thomas & Pleasant Henderson) & had a son, Thomas Searcy, born Jan. 28, 1767, who married Ann Martin (daughter of Col. James Martin) by whom had Susan who married Nathaniel Henderson (daughter of Thomas & Jane Martin Henderson). There were other connections by marriage, at any rate, Thomas Searcy & his brother-in-law Thomas Henderson ran a store in what is now Martinsville--he died at Chapel Hill probably, while Thomas Searcy died at "Mill Grove" Aug. 1 1831, in N.C. The Searcy brothers, Reuben, Bartlett & Richard, went west with Richard Henderson, having got 1,400 acres each in Kentucky in 1779. Richard Searcy was captured by Indians at Boonsborough, the Transylvania fort, in 1777, & his brother, Bartlett, was killed by them in an engagement.




